

A Bill for an Act

ENTITLED

THE EAST AFRICAN COMMUNITY APPROPRIATION ACT, 2024

An Act of the Community to appropriate a sum of United States Dollars one hundred and twelve million, nine hundred and eighty-four thousand, four hundred and forty-two, out of the budget of the Community to meet expenditure for the organs and institutions of the Community for the financial year ending 30th June, 2025.

ENACTED by the East African Community and assented to by the Heads of State.

1. This Act may be cited as the East African Community Appropriation Act, 2024 and shall be deemed to have come into force on the 1st day of July, 2024.

Short title and Commencement.

2. Appropriation of the sum of United States Dollars one hundred and twelve million, nine hundred and eighty-four thousand, four hundred and forty-two is allowed out of the budget of the Community to meet expenditure for the organs and institutions of the Community, as specified in the Schedule, for the financial year ending 30th June, 2025.
