- 1. The Senate assembled at thirty Minutes past Two O'clock.
- 2. The proceedings were opened with Prayer said by the Speaker.

# 3. QUORUM OF THE SENATE

The Speaker, having counted the Honourable Senators present at the commencement of the sitting and confirming that there was no Quorum, directed that the Bell be rung for ten minutes, pursuant to Standing Order 40;

And there being a Quorum before the expiry of the ten minutes;

The Speaker invited the Clerk to call the Orders of the Day.

#### 5. **STATEMENTS**

### a) Statement pursuant to Standing Order 52 (1)

The Senator for Nandi County (Sen. Samson Cherarkey, MP) made a statement regarding the performance of Kenyan athletes, highlighting the

remarkable achievement of Ms. Ruth Chepng'etich in the World record at Chicago Marathon on Sunday, 13th October, 2024.

Thereupon, the Senator stated that Ms. Ms. Ruth Chepng'etich became the first woman to break the 2:10 barrier in marathon running and set the new Women's Marathon Record at 2:09:56, a gap of almost two minutes over the previous record of 2:11:53 set by Ethiopia's Tigst Assefa at the 2023 Berlin Marathon, marking her third consecutive win at the Chicago Marathon.

The Senator also stated that, during this year's Chicago Marathon, the organizers observed a moment of silence to honour the late Kevin Kiptum, the Men's athlete Marathon World Record holder with Ms. Ruth Chepng'etich also honouring the late Kevin Kiptum by dedicating her win and record to the late.

The Senator also congratulated Mr. John Korir for an outstanding performance in the Men's Marathon, where he achieved a personal best of 2:02:04, the second-fastest time ever recorded in Chicago. He also congratulated Mr. Amos Kipruto, who was third at 2:04:50. The Senator also recognized other Kenyan athletes who finished strongly, including Mr. Vincent Kipngetich and Mr. Daniel Ebenyo.

The Senator condemned the harassment by some media outlets of Ms. Ruth Chepng'etich after breaking the world record. He called upon the Ministry of Sports, Athletics Kenya (AK) and the National Olympics of Kenya (NOCK) to defend the integrity of the athletics from baseless media accusations. Further, the Senator urged the Anti-Doping Agency to take necessary measures against coaches who tarnish Kenyan athletes' careers by encouraging doping and also called upon the athletes themselves to remain clean and report suspicious individuals or activities.
