- 3. **Presiding -** the Rt. Honourable Speaker

4. COMMUNICATION FROM THE CHAIR

The Rt. Honourable Speaker issued the following Communication to the House-

Appointment of Members to a Mediation Committee on the Division of Revenue (Amendment) Bill, 2024

"Honourable Members,

As you are aware, on Wednesday, 16th October 2024, the House rejected the Motion on consideration of the Senate amendments to the Division of Revenue (Amendment) Bill (National Assembly Bill No. 38 of 2024). This decision essentially committed the Bill to a Mediation Committee in accordance with the provisions of Article 112 of the Constitution and Standing Order 149.

Honourable Members, Article 113 of the Constitution requires that whenever a Bill is referred to a mediation committee, the Speakers of the Houses of Parliament shall appoint an equal number of Members from both Houses to attempt to develop a version of the Bill for consideration by the Houses of Parliament.

In this regard, **Honourable Members**, having consulted with the Leader of the Majority Party and the Leader of the Minority Party, I have appointed the following Members to represent the National Assembly in the Mediation Committee on the Division of Revenue (Amendment) Bill, 2024–

- (1) The Hon. Ndindi Nyoro, CBS, MP;
- (2) The Hon. Mary Emaase, MP;
- (3) The Hon. (Dr.) John Chikati, MP;
- (4) The Hon. David Ochieng, CBS, MP;
- (5) The Hon. David Kiplagat, MP;
- (6) The Hon. (Dr.) Otiende Amollo, SC, MP;
- (7) The Hon. Fatuma Jehow, MP;
- (8) The Hon. (Dr.) Makali Mulu, MP; and
- (9) The Hon. (Dr.) Ojiambo Oundo, MP.

Honourable Members, the aforementioned Members will await the appointment of Senators to the Mediation Committee for the Committee to be fully constituted for purposes of

commencing the mediation process. Once I receive a Message from the Senate to that effect, I will convey the same to the House.

Thereafter, the Mediation Committee will embark on an attempt to develop a version of the Bill for consideration by the Houses of Parliament in accordance with Article 113 of the Constitution.

The House is accordingly guided. I thank you!"

5. MESSAGES

The Speaker issued the following Messages—

a) Decision of the Senate on the proposed removal from office, by impeachment, of His Excellency Rigathi Cachagua, EGH, Deputy President of the Republic of Kenya

"Honourable Members, Pursuant to the provisions of Standing Order 41(4) of the National Assembly Standing Orders relating to *Messages from the Senate*, I wish to report to the House that today, Friday, 18th October 2024, I received a Message from the Senate regarding its decision on the proposed removal from office, by impeachment, of His Excellency Rigathi Gachagua, EGH, as Deputy President of the Republic of Kenya.

Honourable Members, the Message conveys that—

"The Senate investigated the matter in accordance with Article 150(1)(b) and (2) of the Constitution, as read with Article 145 and Standing Order 79 of the Senate Standing Orders, and after according the Deputy President an opportunity to be heard, on Thursday, 17th October, 2024, **upheld** the following impeachment charges against the Deputy President:

- (1) **Ground 1**: Gross violation of Articles 10 (2)(a), (b) and (c); 27 (4), 73 (1)(a) and (2)(b); 75 (1)(c), and 129 (2) of the Constitution and Article 147 (1), as read together with Article 131 (2)(c) and (d) of the Constitution;
- (2) **Ground 4**: Gross violation of Article 160 (1) of the Constitution on the Institutional and Decisional Independence of Judges;
- (3) **Ground 5**: Gross violation of Articles 3 (1) and 148 (5)(a) of the Constitution on the fidelity to the Oath of Office and Allegiance;
- (4) **Ground 6**: Serious reasons to believe that H. E. the Deputy President has committed crimes under sections 13 (1)(a) and 62 of the National Cohesion and Integration Act; and
- (5) **Ground 9:** Gross misconduct that is incompatible with the high calling and dignified status of the Office of the Deputy President and a member of the Cabinet and the National Security Council. H. E. the Deputy President has publicly attacked and undermined the work of the National Security Intelligence Service and its officers.

Honourable Members, you will recall that on Tuesday, 8th October 2024, **282 Members**, being more than two thirds of the Members of the National Assembly, voted in support of the Special Motion for the proposed removal from office, by impeachment, of H.E. Rigathi Gachagua, EGH, the Deputy President of the Republic of Kenya on <u>eleven grounds</u>.

The upholding, by the Senate, of **five impeachment charges** out of those set out in the Special Motion therefore concludes the consideration of the process as provided in Article 145 of the Constitution.

The House is accordingly informed. I thank you!"

b) Nomination of Prof. Kithure Kindiki, EGH, to fill the vacancy in the Office of the Deputy President of the Republic of Kenya

"Honourable Members, Pursuant to the provisions of Standing Order 42(1), I wish to report to the House that today morning, I have received a Message from His Excellency the

President regarding the nomination of **PROF. KITHURE KINDIKI, EGH,** to fill the vacancy which has occurred in the Office of the Deputy President of the Republic of Kenya following the impeachment of the previous office holder.

Honourable Members, as you are aware, Article 149(1) of the Constitution provides as follows, and I quote –

"149(1). Within fourteen days after a vacancy in the office of the Deputy President arises, the President shall nominate a person to fill the vacancy, and the National Assembly **shall vote** on the nomination within sixty days after receiving it."

Honourable Members, as you are aware, for a person to hold the Office of Deputy President, the person must meet the requirements specified in Article 148 as read together with Article 137 of the Constitution.

In the Message, His Excellency the President indicates that, as a prerequisite to the nomination, he sought and received confirmation from the Independent Electoral and Boundaries Commission (IEBC) that the candidate is qualified to vie for election as a Member of Parliament in accordance with Article 137(1) of the Constitution.

Further, His Excellency the President confirms that he has sought and received clearances from the following institutions with respect to the candidate—

- (a) the Kenya Revenue Authority (KRA);
- (b) the Ethics and Anti-Corruption Commission (EACC);
- (c) the Directorate of Criminal Investigations (DCI);
- (d) the Higher Education Loans Board (HELB); and
- (e) the Commission for University Education (CUE).

Honourable Members, in testament to the foregoing, His Excellency the President has annexed the following documents in relation to his nominee —

- (a) Certified true copy of his **Certificate of Birth**;
- (b) Certified true copy of his **National Identity Card**;
- (c) Certified copies of his **University Degrees and other Academic Certificates**;
- (d) Certification of foreign university degrees by the **Commission for University Education (CUE)**;
- (e) Passport-size Photograph;
- (f) Curriculum Vitae and Testimonials;
- (g) Confirmation of Compliance with Article 137 of the Constitution from the Independent Electoral and Boundaries Commission (IEBC);
- (h) Confirmation of Citizen Status by the **National Registration Bureau** (Office of the Registrar of Persons);
- (i) Confirmation of Membership Status in a Political Party from the **Office of the Registrar of Political Parties (ORPP)**;
- i) Policy Party Membership Confirmation from the **United Democratic Alliance (UDA)**;
- (k) Chapter Six of the Constitution Statutory Clearances (Leadership and Integrity) from:
 - (i) Tax Compliance Certificate Kenya Revenue Authority (KRA);
 - (ii) Ethics and Anti-Corruption Commission (EACC);
 - (iii) Certificate of Good Conduct- Directorate of Criminal Investigations (DCI);
 - (iv) Compliance Higher Education Loans Board (HELB); and
 - (v) Credit Report and Certificate of Clearance Credit Reference Bureau (CRB).

In view of the foregoing, **Honourable Members**, and having perused the attached documents, I am satisfied that the candidate meets the requirements under Article 148 as

read together with Article 137 of the Constitution to fill the vacancy in the Office of the Deputy President. Consequently, the nomination is properly before the House for purposes of the decision required under Article 149(1) of the Constitution.

Honourable Members, Article 149(1) of the Constitution states that upon receipt of a nomination of a person to fill a vacancy in the Office of the Deputy President of the Republic of Kenya, the House is required to vote on the nomination.

Considering that the House is scheduled to proceed on recess at the rise of the House this afternoon, I will convene a meeting of the House Business Committee immediately hereafter to deliberate on the next steps to be taken by the House. Thereafter, I will guide the House on the decision of the House Business Committee. The House is accordingly guided. I thank you!"

13. RE-ORGANISATION OF BUSINESS

Pursuant to the provisions of Standing Order 40, the Speaker interrupted the debate to issue a Communication on Voting on the Nomination of Prof. Kithure Kindiki, EGH, to fill the Vacancy in the Office of the Deputy President of the Republic of Kenya.

14. COMMUNICATION FROM THE CHAIR

The Speaker issued the following Communication from the Chair—

On the nomination of Prof. Kithure Kindiki, EGH to fill the Vacancy in the Office of the Deputy President of the Republic of Kenya

"Honourable Members, You will recall that earlier, at the commencement of this sitting, I notified the House of the receipt of a Message from H.E The President nominating Prof. Kithure Kindiki, EGH to fill the vacancy in the Office of the Deputy President pursuant to Article 149 of the Constitution. You may further recall, upon notification of the House, several Members rose in their places and raised a number of issues for my guidance. The Members who spoke included Hon. Robert Pukose, MP; Hon. Omboka Milemba, MP; Hon. Emmanuel Wangwe, MP; Hon. Samuel Chepkonga, MP; and Hon. Jane Kagiri, MP.

In this regard, I convened a meeting of the House Business Committee for the purposes of deliberating on the next steps to be taken by the House on this matter and guiding the House on the issues raised by the Members.

Honourable Members, I have distilled the issues raised by the Members as follows—

- (1) Whether Article 149(1) of the Constitution envisages an approval process in the manner contemplated by the Public Appointments (Parliamentary Approval) Act, Cap. 7F;
- (2) Whether the House shall conduct public participation in voting on the nomination under Article 149(1) of the Constitution;
- (3) Whether the Members shall be required to debate on the nomination under Article 149(1) of the Constitution;
- (4) The timelines envisaged under Article 149(1) of the Constitution; and
- (5) The threshold for voting on the nomination under Article 149(1) of the Constitution.

Honourable Members, now permit me to examine each of the issues. With regard to the **First Issue,** on whether Article 149(1) of the Constitution envisages an approval process in the manner contemplated by the Public Appointments (Parliamentary Approval) Act, it is noteworthy that Article 149(1) of the Constitution provides as follows—

149 (1) Within fourteen days after a vacancy in the office of Deputy President arises, the President shall nominate a person to fill the vacancy, and the National Assembly shall vote on the nomination within sixty days after receiving it.

From a reading of Article 149(1) of the Constitution, it is expressly provided that the National Assembly shall "vote on the nomination within sixty days after receiving it". The drafters of the Constitution distinguished the language used in Article 149(1) of the Constitution by expressly providing that the House is required to vote and not approve the nomination.

Indeed, this is to be distinguished from the provisions of Article 132(4) of the Constitution which provides that the President shall nominate and, with the **approval of the National Assembly**, appoint, and may dismiss the Cabinet Secretaries, in accordance with Article 152; the Attorney-General, in accordance with Article 156; the Secretary to the Cabinet in accordance with Article 154; Principal Secretaries in accordance with Article 155; and high commissioners, ambassadors and diplomatic and consular representatives.

Honourable Members, in this regard, for all the State officers that I have just highlighted, the House is required to approve their nomination by the President. However, in respect to the Deputy President, Article 149(1) of the Constitution expressly provides that the House is required to vote on the nomination. It is noteworthy that the Public Appointments (Parliamentary Approval) Act applies where an appointment under the Constitution or any other law requires an approval by the House. Consequently, noting Article 149(1) of the Constitution requires the House to take a vote on the nomination, the approval process envisaged under the Public Appointments (Parliamentary Approval) Act does not apply. The House will therefore adopt the precedent it has set on this matter. This settles the First Issue.

Honourable Members, the Second Issue was whether the House shall conduct public participation in voting on the nomination under Article 149(1) of the Constitution. As stated earlier, Article 149(1) of the Constitution requires the House to take a vote on the nomination of Prof. Kithure Kindiki, EGH to fill the vacancy in the Office of the Deputy President which is essentially an election.

Honourable Members, you will recall the practice of the House whenever it is confronted with an obligation to vote on a matter as relates to an election. The instances include, election of the Speaker and Deputy Speaker under Article 106 of the Constitution; the Members of the East Africa Legislative Assembly and the Pan-African Parliament, for which the House is required to vote on nominations of Members to hold such positions. The practice of the House in these instances is that the House has always proceeded directly to vote without public participation. To this end, to the extent that Article 149(1) of the Constitution contemplates the House to vote, upon receiving the nomination, the requirement for public participation is not applicable in this case. This settles the Second Issue.

Honourable Members, on the **Third Issue**, relating to whether Members shall be allowed to debate on the nomination, it is noteworthy that having determined the vote contemplated under Article 149(1) of the Constitution is an election, no debate arises on a matter of

election. Indeed, you will recall that in the case of the election of a Speaker of this House and the Members of the East Africa Legislative Assembly, no debate arises. This settles the Third Issue.

Honourable Members, moving on to the **Fourth Issue,** on the timelines envisaged under Article 149(1) of the Constitution, you will observe that Article 149(1) of the Constitution defines the period within which the President is required to nominate a person to fill the vacancy in the Office of the President, which is **within fourteen days** after a vacancy in the office of Deputy President arises. The National Assembly is then required to vote on the nomination **within sixty days** after receiving it.

Honourable Members, from the foregoing, Article 149(1) of the Constitution defines the maximum period within which the President and the National Assembly are required to act. To this end, the President can nominate a person to fill the vacancy from the first day the vacancy arises up to the fourteenth day. On its part, the National Assembly is required to vote on any day from the first day it receives a nomination up-to the sixtieth day after receipt of the nomination. Consequently, the nomination of Prof. Kithure Kindiki, EGH and the vote the House is required to take today on the nomination, is within the constitutional timeline provided for in Article 149(1) of the Constitution. This settles the Fourth Issue.

Honourable Members, the Fifth and Final Issue, that was raised for guidance was on the threshold for voting under Article 149(1) of the Constitution. It is noteworthy that Article 149(1) of the Constitution has not defined or provided for the threshold for voting for the nomination of a person to fill the vacancy in the Office of the Deputy President. Article 122(1) of the Constitution provides that "except as otherwise provided in the Constitution, any question proposed for decision in either House of Parliament shall be determined by a majority of the members in that House, present and voting". Consequently, the threshold for voting on the nomination of Prof. Kithure Kindiki, EGH is a majority of the Members in this House, present and voting as provided for in Article 122(1) of the Constitution. This settles the Final Issue.

Honourable Members, in summary therefore, I wish to guide the House as follows—

- (1) THAT Article 149(1) of the Constitution requires the House to take a vote on the nomination of Prof. Kithure Kindiki, EGH to fill the vacancy in the Office of the Deputy President.
- (2) In this regard, the House will be guided by its previous precedent whenever it is called upon to take a vote on a matter as relates to the election of the Speaker, Deputy Speaker and Members of the East Africa Legislative Assembly and the Pan-African Parliament.
- (3) THAT no debate arises on a matter that the House is required to take a vote.
- (4) THAT the nomination of Prof. Kithure Kindiki, EGH and the vote the House is required to take on the nomination, is within the constitutional timeline provided for in Article 149(1) of the Constitution.
- (5) THAT the House Business Committee has resolved that the vote contemplated under Article 149(1) of the Constitution be taken today, during this sitting of the House.
- (6) THAT the threshold for voting on the nomination of Prof. Kithure Kindiki, EGH is a majority of the Members in the House, present and voting as provided for in Article 122(1) of the Constitution.

The House is thus accordingly guided and may now proceed to take the vote. I thank you!"

15. VOTING ON THE NOMINATION OF PROF. KITHURE KINDIKI, EGH TO FILL THE VACANCY IN THE OFFICE OF THE DEPUTY PRESIDENT OF THE REPUBLIC OF KENYA (Pursuant to Article 149(1) of the Constitution)
