4. QUORUM AT COMMENCEMENT OF THE HOUSE

There being no Quorum present to commence business, the Rt. Honourable Speaker ordered that the Quorum Bell be rung for Ten minutes;

Honourable Members, you will recall that, on 18th October 2024, the House rejected part of the Senate amendments to the Food and Feed Safety Control Coordination Bill, 2024 thereby committing the Bill to a Mediation Committee in accordance with

the provisions of Article 112(2)(b) of the Constitution. On the part of the National Assembly, I appointed the following Members to the Mediation Committee, having consulted with the Leader of the Majority Party and the Leader of the Minority Party—

Honourable Members, following the appointment of Senators, the Mediation Committee is now fully constituted as contemplated under Article 113 of the Constitution. I therefore call upon the Committee to expeditiously consider the matter and submit a version of the Bill for consideration by the Houses of Parliament bearing in mind the timelines provided for under Article 113(4) of the Constitution. I thank you!"

b) The 2024 State of the Nation Address to Parliament by H.E. The President of the Republic of Kenya

"Honourable Members,

Standing Order 42(1) relating to Messages from the President provides that "the Speaker shall read to the House any message from the President delivered to the Speaker for communication to the House." In this regard, I wish to inform the House that I received a Message from His Excellency the President conveying that he intends to deliver the 2024 State of the Nation Address to Parliament pursuant to Article 132(1) of the Constitution, **on Thursday**, 21st November 2024.

- (4) There shall be a Chief Curator for Science Museum who shall be employed by the Board through a competitive process on such terms and conditions as the Board may, with the advice of the Salaries and Remuneration Commission determine.
- (5) The Chief Curator shall be responsible to the Board for the day-to-day running of the affairs of the Science Museum.
 - (6) The Board may employ such other staff as may be necessary for the performance of the functions of the Science Museum.
