QUALITY AND STANDARDS OF CEMENT IN THE KENYAN MARKET

Sen. Cherarkey: Thank you, Mr. Speaker, Sir. I rise pursuant to Standing Order 53(1) to seek a statement from the Standing Committee on Trade, Industrialization and Tourism regarding the quality and standards of cement in the Kenyan market.

In the statement, the Committee should-

(1) Report the compliance of cement produced in Kenya with Kenyan Bureau (KEBS) Standards, KSEAS 18-1, outlining the adherence levels of all cement manufacturers to these standards.

(2) Present a report on the findings of the recent market surveillance operation conducted by Kenyan Bureau of Standards on the quality of cement in Kenya, specifically addressing the reasons behind the non-implementation of quality assurance recommendations, particularly regarding the cement in the 32.5 megapascal (MPA) category, which accounts to approximately 85 per cent of the total cement production in the country.

(3) Detail the actions taken against unscrupulous cement manufacturers and smugglers who have compromised cement quality, leading to the collapse of buildings and loss of lives, including details of any enforcement measures, despite having clear

data on quality breaches where buildings have been collapsing in various towns and centres across the country.

(4) Clarify where the Weights and Measures Department and the Kenya Anti-Counterfeit Authority failed in their responsibilities in monitoring compliance and ensuring consumer protection under the Consumer Protection Authority, thereby contributing to the poor quality of concrete and cement used in construction and compromising the safety of buildings.

I thank you, Mr. Speaker, Sir.

STATE OF THE NATION ADDRESS

Hon. Senators, Article 132(1)(b) mandates the President to address a Special Sitting of Parliament once every year.

Article 132(1)(c) also requires the President once every year to do the following-

(1) Report in an address to the nation on all measures taken and progress achieved in the realization of the national values referred to Article 10.

(2) Publish in the Gazette the details of the measures and progress under (1).

(3) Submit a report for debate to the National Assembly on the progress made in fulfilling the international obligations of the Republic.

Further, Article 247 of the Constitution requires the National Security Council to report annually to Parliament on the state of security of Kenya.

Ordinarily, this report is submitted to Parliament during the address of the President by the President, referred to under Article 132(1)(b) and tabled in the Houses of Parliament.

Vide the letter reference number EOP/CAB.26/4AVol. 4(178), dated 9th September, 2024, the Chief of Staff and Head of Public Service inform the Speakers of the Houses of Parliament of the intention of His Excellency the President to deliver an address to Parliament in accordance with Article 132(1)(b) and (c) of the Constitution.

The Chief of Staff and Head of Public Service further requested the Speakers' concurrence to schedule the State of the National address on Thursday, 7th November, 2024 or Thursday 14th November, 2024 at 2.30 p.m.

Hon. Senators, following consultations between the Speakers of the Houses of Parliament and the Executive Office of the President, it was agreed that the State of the Nation address will be held on Thursday, 21st November, 2024.

I, therefore, take this opportunity to welcome all hon. Senators to this very important event that will take place in the National Assembly Chamber, from 2.30 p.m.

A team of officers has been appointed by the Clerks to coordinate the event. Further details on the Special Sitting will be communicated in due course.

Sen. Tabitha Mutinda: Thank you, Mr. Speaker, Sir. I would like to contribute to the statement by Sen. Cherarkey in regards to the standard of the cement quality in this country. This is a key issue since housing is one of the basic needs. The cement factor plays a key role.

If the agencies that are allowed and mandated to ensure quality standards are adhered, specifically KeBS, indicate that we have unscrupulous business people bringing in substandard cement into the country, then they jeopardise the standards that have been set by the National Construction Authority (NCA) as far as the standard of housing in this country is concerned.

Mr. Speaker, Sir, one of the manifestos for the Kenya Kwanza Government is the housing project. Therefore, noting that there are issues with the standard of the cement in the country is a concerning issue. So, it is high time that a committee is mandated to embark and give this House feedback as to why we have substandard cement. At the same time, in the market, the cost of cement is very high.

Right, now cement is retailing at Kshs850. The cost has gone very high. If the cost is high and still we are being informed that the same cement is not up to the standards, then it worries us as a country as to the kind of structures that we will have in future.

We have seen buildings in Nairobi City County collapsing. Is this the cause? The KeBS should ensure the set standards are adhered to.

Thank you, Mr. Speaker, Sir.

The Speaker (Hon. Kingi): Sen. Okoiti Omtatah.

Sen. Okiya Omtatah: Thank you, Mr. Speaker. Sir. I rise to contribute to the statement by Sen. Cherarkey, the great from Nandi County.

The quality of cement is important and should not be compromised because cement is shelter. It is everything we have in terms of building homes that are lasting and urbanization, especially in Kenya, where the next frontier is urbanization as a way of combating poverty. We need good quality cement at affordable prices.

Mr. Speaker, Sir, this statement comes at a very opportune time for us. I hope that the committee that will look into it will dig in and ferret out whoever is behind cement that does not meet the standards that have been set by the KeBS. These standards are regularly revised and they are up to date. The least any businessman can do to this country is to ensure adherence to the KeBS standards.

We have seen buildings collapsing in this country as my fellow Senator who has contributed before me has stated. That is mostly not because of poor design, but poor materials. There might be a problem with workmanship, but materials are key.

We must make sure that we have the right material. In this country, when constructions are going on, some contractors have to import cement from their homeland. I always wondered why the Chinese come with their own cement to do certain projects in this country. Is it that the cement made in Kenya is substandard or are our standards not to international levels?

Mr. Speaker, Sir, if there are standards that need to be set to achieve higher quality cement that can do specialised jobs like underwater construction and so on, then we need to have those standards set. We do not have to import cement when we have enough raw material to manufacture whatever cement we require.

Another important thing is that if the standards are upheld to make sure that the cement in Kenya; be it imported or locally made, meets the international standards. This is the only way we will be in a position to get ourselves into the regional and even international market as net exporters of cement. This is an area of growth and job creation. Therefore, this country needs to focus on this area if we aim to be a manufacturing country.

It is with cement that skyscrapers are constructed. When I walk around Kenyatta International Convention Centre (KICC), I do not see a crack. However, when you look at some modern buildings, they already have cracks. You wonder whether it is the quality of cement. More so, the Bunge Tower is already cracked. Was it the quality of cement? Did they bring in some substandard cement or what was it?

We need to get this thing answered well and in a timely manner. Going forward, when you go to a shop in any part of this country to buy cement, we want to buy cement that is certified and suitable for modern construction.

If you look at the Raila Odinga, or is it Mbagathi Highway, although I still do not know which is the correct name for it, I will consult Sen. Cherarkey *baadaye---* You will find that road was done using cement. For those of us who use it, that road has remained

steady for a long time. It was supposed to be a pilot project. We do not know whether the issue was shelved or not. Therefore, we may need to move away from bitumen and embrace more cement in our roads. This is so that we build proper roads.

I am also aware of the fact that heavy trucks that are known for damaging our roads are not using Mbagathi Road. Nonetheless, it is a road that has withstood time. Subsequently, the quality of cement is a very important point for me and for this Republic.

Mr. Speaker, Sir, I support that statement. As I contribute, I pray that the committee to which it has been committed, does thorough work, beginning with establishing whether our standards are up to scratch. There will be no point of holding it to a standard that is not up to scratch. Let us hold our standards to the best in the world. Let them pass muster, check and see whether the cement we have is up to those standards.

With those few remarks, I support the statement.

INEFFICIENCIES, MISMANAGEMENT AND CORRUPTION AT LONGISA COUNTY REFERRAL HOSPITAL IN BOMET COUNTY

Sen. Wakili Sigei: Thank you, Mr. Speaker, Sir. I thank you for graciously allowing me to read this statement that I had earlier on been left out.

I rise to seek for a statement on the critical inefficiencies, mismanagement and corruption at Longisa County Referral Hospital in Bomet County and the Bomet County Health System.

Mr. Speaker, Sir, this statement is pursuant to Standing Order No.53 (1).

The level of inefficiency and management resulted in the tragic avoidable death at the County Referral Hospital on Sunday, the 10th of November, 2024, of one baby Diana Chepngeno, a three-year-old girl from Koitabai Village in Bomet County who had suffered severe venom-induced injuries from a bee sting.

It is claimed that the hospital staff demanded Kshs5,000 from the family; an illegal fee disguised as a prerequisite for accessing crucial hospital services before they could provide the urgent medical care that was needed. This is not an isolated incident and is a blatant display of the rot of corruption that has plagued the county's service delivery system.

It should be noted that during a recent appearance before the Senate County Public Investments and Special Funds Committee (CPISFC), the Governor of Bomet boasted of Longisa Hospital's capacity, asserting that it operates effectively as a Level 5 facility. The governor's confident statements sharply contrast with the harsh reality faced

by patients and raise questions about the true state of health care services at the said hospital and the county at large.

In the statement, the Committee should-

(1) Explain the circumstances that led to the tragic death of baby Diana Chepngeno at Longisa County Referral Hospital.

(2) State the disciplinary actions taken by the Kenya Medical Practitioners and Dentists Council (KMPDC) against those found culpable for negligence and gross misconduct that resulted in the tragic death of baby Chepngeno, outlining other steps taken to ensure that such incidences are not witnessed again in the future.

(3) Assess the adequacy and effectiveness of the Bomet County Emergency Response Protocols, indicating the availability and cost of the ambulance services for health emergencies.

(4) Outline steps taken to address identified systemic challenges within Bomet County's health care system, assessing the training, preparedness and professionalism of health care staff, particularly during medical emergencies.

(5) Lastly, evaluate the utilisation of resources allocated to the health sector in Bomet County.

Objects of the Act

3. The objects of this Act are to-

(a) provide a framework for standards for professional practice and their enforcement;

(b) facilitate the delivery of quality fire and rescue professional services;

(c) promote the delivery of quality professional training and education for fire and rescue service professionals;

(d) protect the public from unethical professional practice in fire and rescue services; and, (e) promote realization of the right to the highest attainable standard of health for every person in relation to prevention, response and mitigation of unintentional injuries resulting from fire, accidents, emergencies, disasters and calamities.

(g) one person nominated by the umbrella body of emergency responders in Kenya;

(h) one person representing private sector organizations in Kenya; and

(i) the registrar who shall be an ex-officio member and who shall have no vote.

(2) The persons nominated under subsection (1) (e), (f), (g) and (h) above shall be appointed by the Cabinet Secretary by notice in the Gazette.

(d) has at least ten years' experience in the field of fire and rescue;

(e) has at least five years' experience in leadership in the public or private sector; and,

(f) has knowledge and experience in policy formulation; (g) meets the requirements of Chapter Six of the Constitution.

17. (1) A person shall not practice as a fire and rescue service professional, manage a fire and rescue services consulting firm or provide fire and rescue consultancy and advisory services unless they are registered in accordance with this Act.

(2) In this section, practice as a fire and rescue service professional includes

- (a) providing fire and rescue professional services such as fire prevention, operating fire equipment for purposes of extinguishing fire where such a process requires a rescue professional, fire investigation, fire risk assessment, audit and inspection or rescue operation;

(b) carrying out or holding oneself as a fire and rescue service professional; or

(c) certifying or authorizing any process where a fire and rescue service professional is required under any law or administrative procedure to certify or authorize.

THE HOUSES OF PARLIAMENT (BICAMERAL RELATIONS) BILL (NATIONAL ASSEMBLY BILLS NO. 44 OF 2023)

The Temporary Chairperson (Sen. Wakili Sigei): Hon. Senators, we are proposing to consider the Houses of Parliament (Bicameral Relations) Bill (National Assembly Bills No. 44 of 2023).

I call upon the Senate Majority Leader to move the proposed amendments.

Clause 3

The Senate Majority Leader (Sen. Cheruiyot): Mr. Temporary Chairperson, Sir, I beg to move-

THAT the Bill be amended by deleting Clause 3 and substituting therefor with the following new clause –

3. The object of this Act is to provide –

(d) a framework for determining the nature of a Bill; and

(e) for the procedure for determining whether a Bill concerns counties.

(Question of the amendment proposed)

The Temporary Chairperson (Sen. Wakili Sigei): Division will be at the end. I call upon the Senate Majority Leader to move the proposed amendments.

Clause 4

The Senate Majority Leader (Sen. Cheruiyot): Mr. Temporary Chairperson, Sir, I beg to move-

THAT the Bill be amended-

(a) a Bill concerning counties; and

(b) a special or an ordinary Bill.

(2) The Speaker to whom the request is sent under subsection (1) shall respond to the request within a period of seven days from the date of receipt of the request.

(3) Where the Speakers fail to agree on the nature of a Bill, each Speaker shall, within seven days from the date of receipt of the response under subsection (2), appoint three members from amongst members of the respective House to constitute an advisory team to assist the Speakers resolve the question under subsection (1).

(4) The advisory team shall, within fourteen days from the date of the first sitting, prepare and submit its advisory on the question under subsection (1) to the Speakers.

(5) The Speakers shall, within seven days from the date of receipt of the advisory under subsection (4), resolve the question under subsection (1).

(6) Where the Speakers, having taken into account the advisory of the advisory team, fail to agree on the question under subsection (1), the Bill shall not be introduced in either House of Parliament.

6A. (1) The Speakers shall, in making a determination under section 6(1) and (2), take into account the criteria set out under sections 7 and 7A.

(2) The advisory team shall, in assisting the Speakers under section 6(4), take into account the criteria set out under sections 7 and 7A.

(Question of the amendment proposed)

The Temporary Chairperson (Sen. Wakili Sigei): Division will be at the end. I call upon the Senate Majority Leader to move the proposed amendments.

Clause 7

The Senate Majority Leader (Sen. Cheruiyot): Mr. Temporary Chairperson, Sir, I beg to move-

7. (1) A Bill is a Bill containing provisions affecting the functions of a county government under Article 110(1)(a) of the Constitution if the Bill –

(a) directly or indirectly affects the operations of the county governments;

(b) will have a direct or indirect impact on the functions of county governments under Part 2 of the Fourth Schedule to the Constitution;

(c) would have an impact on the exercise by any person upon whom a function or power is conferred under the Bill on any institution or office of the county government, the finances of the county government or the property held by or vested in the county government;

(d) contains provisions which the county governments are required to implement or are binding on county governments;

(e) confers a function or power on a person that would affect the exercise of the functions and the powers of the county governments under the Fourth Schedule to the Constitution; (f) seeks to transfer a function or power between the National Government and the county governments under Article 187 of the Constitution;

(g) that affects the ability of the Senate to carry out its functions under Article 96 of the Constitution; or

(h) provides for any other matter that would directly or indirectly affect the functions and powers of the county governments.

(2) A Bill is a Bill affecting the finances of a county government under Article 110(1)(c) of the Constitution if –

(a) the Bill provides for –

(i) the equitable sharing of revenue under Article 202(1) of the Constitution;

(ii) the additional allocation of funds from the National Government's share of revenue to county governments under Article 202(2) of the Constitution;

(iii) the additional allocation of funds to county governments under Article 190(1) of the Constitution including proceeds of loans and grants from development partners;

(iv) a matter relating to the appropriation and administration of the Equalisation Fund under Article 204 of the Constitution;

(v) the sharing of revenue or any financial matter concerning county governments as contemplated in Article 205(1) of the Constitution;

(vi) the transfer of equitable share to the county governments pursuant to Article 219 of the Constitution;

(vii) the withdrawal of money from the Consolidated Fund under Article 206 of the Constitution that affects the finances of county governments;

(viii) the withdrawal of money from a County Revenue Fund;

(ix) the establishment of public funds by counties and the management of those funds;

(x) the establishment of a fund by Parliament for the benefit of a county government or a county government entity;

(xi) advances from the Contingencies Fund under Article 208 of the Constitution that affect the finances of county governments;

(xii) the imposition of a tax, duty or charge under Article 209(3)(c) of the Constitution;

(xiii) borrowing by the National Government under Article 211 of the Constitution;

(xiv) public debt under Article 214 of the Constitution that is to be charged on a public fund established for the benefit of county governments;

(xv) borrowing by counties including the terms and conditions under which the National Government may guarantee a loan under Article 212(a) of the Constitution;

(xvi) any matter concerning the Commission on Revenue Allocation under Articles 215 and 216 of the Constitution;

(xvii) the form, content and timing of budgets for National and county governments prepared pursuant to Article 220 of the Constitution;

(xviii) estimates for expenditure from the Equalisation Fund prepared pursuant to Article 221(2(a);

(xix) an appropriation under Article 223(4) of the Constitution that affects the finances of a county government;

(xx) the form and procedure for processing county budgets and appropriation Bills prepared pursuant to Article 224 of the Constitution;

(xxi) financial control measures and mechanisms under Article 225 of the Constitution;

(xxii) the keeping of financial records and auditing of accounts of county governments and the designation of accounting officers in the county governments under Article 226 of the Constitution;

(xxiii) the procurement of public goods and services under Article 227 of the Constitution;

(xxiv) the powers and functions of the Salaries and Remuneration Commission to set, review and advise on the remuneration and benefits of public officers in the county governments under Article 230(4) of the Constitution; or

(xxv) any other matter referred to in Chapter Twelve of the Constitution affecting the finances of county governments; or

(b) the Bill is –

(i) the annual Division of Revenue Bill under Article 218(1)(a) of the Constitution;

(ii) the annual County Allocation of Revenue Bill under Article 218(1)(b) of the Constitution; or

(iii) the annual Governments County Additional Allocations Bill under Article 202(2) of the Constitution.

7A. A Bill is a special Bill if the Bill –

(a) relates to, affects or concerns the election of members of a county assembly or a county executive including-

(i) the continuous registration of citizens as voters under Articles 82(1)(c) and 88(4)(a) of the Constitution;

(ii) the review of the names and boundaries of the constituencies and wards by the Independent Electoral and Commission Boundaries under Articles 82(1)(a) and 89 of the Constitution;

(iii) the monitoring of compliance with the legislation required by Article 82(1)(b) relating to nomination of candidates by parties under Article 88(4)(k) of the Constitution; (iv) the conduct of elections and referenda and the regulation and efficient supervision of elections and referenda, including the nomination of candidates for elections under 82(1)(d) of the Constitution;

(v) the registration as voters of citizens residing outside Kenya under Article 82(1)(e) of the Constitution;

(vi) the establishment of mechanisms for electoral disputes under Article 87(1) of the Constitution;

(vii) the functions of the Independent Electoral and Boundaries Commission under Article 88 of the Constitution directly or indirectly affecting the election of members of a county assembly;

(viii) the conduct and supervision of elections for the members of county assemblies under 177(1)(b) and (c) of the Constitution conducted by the Independent Electoral and Boundaries Commission under Article 90(2) of the Constitution;

(ix) the allocation of airtime to political parties under Article 92(a) of the Constitution;

(x) the regulation of freedom to broadcast for fair election campaigning under Article 92(b) of the Constitution;

(xi) the regulation of political parties under Article 92(c) of the Constitution;

(xii) the roles and functions of political parties under Article 92(d) of the Constitution;

(xiii) the registration and supervision of political parties under Article 92(e) of the Constitution;

(xiv) the establishment and management of a political party fund under Article 92(f) of the Constitution;

(xv) the accounts and audit of political parties under Article 92(g) of the Constitution;

(xvi) restrictions on the use of public resources to promote the interest of political parties under Article 92(h) of the Constitution; and

(xvii) any other matter affecting the management of political parties; or

(b) is a –

(i) County Allocation of Revenue Bill under Article 218(1)(b) of the Constitution; or(ii) County Governments Additional Allocations Bill under Article 202(2) of the Constitution.

PART IV - RESOLUTION UNDER ARTICLE 114 OF THE CONSTITUTION

7B. (1) Before a Bill is read a First Time in the House originating the Bill, the Speaker of that House shall seek the opinion of the Speaker of the other House on whether the Bill is a Money Bill.

(2) Sections 6 and 19 shall apply, with necessary modification, in the resolution of any question as to whether a Bill is a Money Bill.

7C. (1) A Bill is a money Bill within the definition of Article 114 of the Constitution if the Bill contains provisions dealing only with -

(a) the imposition, abolition, remission, alteration or regulation of any tax;

(b) the imposition of charges on a public fund or the variation or repeal of any of those charges;

(c) the appropriation, receipt, custody, investment or issue of public money;

(d) the raising or guaranteeing of any loan or its repayment; or

(e) matters incidental to any of the matters specified under paragraphs (a) to (d).

(2) A Bill is not a money Bill within the definition of Article 114 of the Constitution if the Bill contains provisions that -

(a) concern county governments as set out in section 7A;

(b) the imposition of taxes by a county government;

(c) provides for the appropriation of funds by Parliament but does not appropriate money;

(d) the imposition of charges on a public fund or the variation or repeal of such charges by a county government;

(e) the appropriation, receipt, custody, investment or issue of public money by a county government; or

(f) the raising or guaranteeing of any loan or its repayment by a county government.

7D. (1) A Bill that meets the criteria under section 7C (1) may be introduced only in the National Assembly in accordance with Article 109(5) of the Constitution.

Meetings of **1.** (1) The Board shall meet at least once in every three months to conduct the business of the Board.

(2) The Chairperson shall convene the ordinary meetings of the Board.

(3) Despite the provisions of subparagraph (1), the Chairperson shall, upon a written request by at least five members, convene a special meeting of the Board at any time where the chairperson considers it expedient for the transaction of the business.

(4) Unless three quarters of the total number of the members of the Board otherwise agree, at least fourteen days written notice of every meeting shall be given to every by the respective Secretary.

(5) The quorum for the conduct of the business of the

Board shall be five members.

(6) The chairperson shall preside at every meeting of the Board at which the Chairperson is present and in the Chairperson's absence, the members present shall elect one person from their number to preside over the meeting and that person shall have all the powers of the Chairperson.

(7) Unless a unanimous decision is reached, a decision on any matter before the Board shall be by a majority of the votes of the members present and voting and in the case of an equality of votes, the Chairperson or person presiding over the meeting shall have a casting vote.

(8) The proceedings of the Board shall not be invalidated by reason of a vacancy within its membership.

(9) Subject to provisions of this Schedule, the Board may determine its own procedure and for the attendance of other persons at its meetings thereof.
