- 1. The House assembled at thirty minutes past Two O'clock.
- 2. The Proceedings were opened with Prayer.
- **Presiding -** the Deputy Speaker. 3.

4. LACK OF QUORUM AT COMMENCEMENT

There being no Quorum present to commence business, the Deputy Speaker ordered that the Quorum Bell be rung for ten minutes;

And Quorum having been attained within ten minutes, business commenced.

5. **MESSAGES**

The Deputy Speaker issued the following Messages from the Senate -

(a) Approval of the Mediated Version of the Sugar Bill (National Assembly Bill No. 34 of 2022)

"Honourable Members, pursuant to the provisions of Standing Order 41, I wish to report to the House that I have received a Message from the Senate regarding the approval of the Mediated Version of the Sugar Bill (National Assembly Bill No. 34 of 2022).

The Message conveys that on 24th October 2024, the Senate considered the Report of the Mediation Committee on the Sugar Bill (National Assembly Bill No.34 of 2022) and approved the Mediated Version of the Bill, in the form developed by the Mediation Committee, pursuant to Article 113(2) of the Constitution and Standing Order 167(3) of the Senate Standing Orders.

Honourable Members, you may recall that the said Bill was committed to a mediation committee pursuant to Article 112(1)(b) of the Constitution following the National Assembly's rejection of part of the Senate amendments to the Bill on 1st August 2024.

Honourable Members, you will further recall that on 18th October, 2024, the National Assembly considered the Report of the Mediation Committee on the Sugar Bill (National Assembly Bill No. 34 of 2022), and similarly approved the Mediated Version of the said Bill in the form developed by the Mediation Committee.

Honourable Members, the approval of the Mediated Version of the Sugar Bill, 2022 by the two Houses of Parliament effectively concluded the bicameral consideration of the Bill in accordance with the provisions of Article 110 of the Constitution.

Subsequently, the Bill was presented for Assent, in accordance with the provisions of Article 110(5) of the Constitution. Indeed, His Excellency the President did assent to the said Bill on 1st November, 2024. I thank you!"

(b) Appointment of Senators to the Mediation Committee on the Division of Revenue (Amendment) Bill (National Assembly Bill No. 38 Of 2024)

"Honourable Members, pursuant to the provisions of Standing Order 41, I wish to report to the House that I have received a notification from the Senate regarding the nomination of Senators to the Mediation Committee on the Division of Revenue (Amendment) Bill (National Assembly Bill No. 38 of 2024).

Honourable Members, you will recall that, on Wednesday, 6th October 2024, this House **negatived** a Motion on consideration of the Senate amendments to the Division of Revenue (Amendment) Bill, 2024 thereby committing it to a mediation committee in accordance with the provisions of Article 112(2)(b) of the Constitution. Consequently, the names of the members to constitute the team from the National Assembly were communicated to the House on Friday, 18th October 2024, and forwarded to the Senate for further action.

In this regard, the Speaker of the Senate has appointed the following Senators to the Mediation Committee on the Bill: -
