- 1. The Senate assembled at thirty Minutes past Two O'clock.
- 2. The proceedings were opened with Prayer said by the Speaker.

3. QUORUM OF THE SENATE

The Speaker, having counted the Honourable Senators present at the commencement of the Sitting and confirming that there was no Quorum, directed that the Bell be rung for ten minutes, pursuant to Standing Order 40;

And there being a Quorum before the expiry of the ten minutes;

The Speaker invited the Clerk to call the Orders of the day.

4. COMMUNICATIONS FROM THE CHAIR

The Speaker conveyed the following Communications from the Chair -

(a) Resumption of Sittings of the Senate for Part V of the Senate Calendar, 2024

"Honourable Senators,

I take this opportunity to welcome Honourable Senators back from the short recess. In accordance with the Calendar of the Senate for the regular sittings, Part V begins today, Tuesday, 12th November, 2024 and will conclude at the rise of the Senate on Thursday, 5th December, 2024. Honourable Senators,

You will observe that this will be the last segment of the Senate Calendar (Regular Sessions of the Senate, 2024). It will be a short one before the Senate undertakes the December – January recess. The resumption of regular sittings in this last part brings with it a certain degree of urgency to conclude the legislative agenda of the Senate.

It is in this context that I therefore urge that we redouble our collective effort in a bid to conclude the business of the Senate by the close of the Session in December, 2024. I also urge the Office of the Senate Majority Leader, the Senate Minority Leader and Committee Chairpersons to do all that is necessary within the Standing Orders to expedite pending legislative business.

5. STATEMENT PURSUANT TO STANDING ORDER 56(1)(a)

Sen. Joe Nyutu, MP, on behalf of the Chairperson, Standing Committee on Health, made a Statement relating to the status of implementation of the resolution on the Motion on the Current State of the Nation.

In the Statement the Senator stated that, following the passage of the Motion on 24th July 2024, the Standing Committee on Health engaged relevant stakeholders in two key areas; namely, facilitating public participation in the re-enactment of the Social Health Insurance Act, the Digital Health Act, and the Primary Health Care Act, in line with a High Court ruling, in Petition No. E473 of 2023. Additionally, the committee was working with the Cabinet Secretary for Health and the Council of Governors to standardize the human resource policy for health workers across counties.

The Senator reported that the ruling by the High Court in Petition No. E473 of 2023, challenging the constitutionality of the three Acts of Parliament on claims that they lacked proper public participation. The High Court, in its ruling on 12th July 2024, found the Acts to be unconstitutional, ordering Parliament to undertake sufficient public participation and amend the unconstitutional provisions within 120 days. The court also suspended the Acts during this period, and where the Government failed to comply, the Acts would be declared null and void. The Cabinet Secretary for Health, dissatisfied with the ruling, appealed the decision, and the Court of Appeal granted a temporary stay on the judgment, allowing the Acts to remain in effect until the appeal was determined.

The Senator stated that, while awaiting the determination of the appeal, the Committee halted further actions on the re-enactment of the Acts. In addition, the Committee scheduled a retreat with the Ministry of Health, the Council of Governors, and medical practitioners' unions to address challenges in standardizing the health workforce policy. A report on this matter would be prepared for consideration by the Senate upon the conclusion of discussions by stakeholders.

13. MOTION - CONSOLIDATION OF BURSARY FUNDS FOR EQUITABLE ACCESS TO EDUCATION IN KENYA

Order read;

Motion made and Question proposed;

THAT AWARE THAT, Pursuant to Article 53 of the Constitution, every child in Kenya is entitled to free and compulsory basic education, and the Basic Education Act provides that, basic education should be guided by principles such as equitable access to all youth and equal access to education or institutions;

FURTHER AWARE THAT, many students in secondary schools and higher education institutions come from financially disadvantaged backgrounds, making it difficult for them to afford school fees and access education opportunities;

NOTING THAT, over the years, various interventions have been made, including the issuance of bursaries through the National Government Constituency Development Fund (NCDF), National Government Affirmative Action Fund (NGAAF), the Ministry of Education and county governments through various county bursary funds;

CONCERNED THAT, despite these efforts, schools' fees remain unaffordable for many parents and the allocation of bursaries has been plagued by nepotism, favoritism, and political manipulation, lack of transparency and accountability;

FURTHER CONCERNED THAT public learning institutions are primarily funded by the Government through the Ministry of Education, and in the financial year 2024/25, approximately Kshs. 656 billion was allocated to the education sector,

making it difficult to ascertain the specific funds granted to each student and that the lack of transparency in the disbursement of bursaries from various agencies makes it difficult to determine the total amount allocated in a financial year, thus hindering efforts to ensure equitable access to education for financially disadvantaged students;

NOW, THEREFORE, the Senate urges the Ministry of Education, to:

- 1) audit the funds allocated to bursaries by both the National Government and county governments;
- 2) consolidate the funds distributed by various government entities and agencies, with the aim of directing these funds directly to schools as supplementary capitation to facilitate the achievement of free secondary education; and
- 3) calculate the cost of education per learner and make this information public for primary, secondary, and tertiary institutions, including a detailed breakdown of the annual financial requirements for each student across the country.
