5. MESSAGES FROM THE NATIONAL ASSEMBLY

The Speaker conveyed the following Messages from the National Assembly: -

(a) Approval of the appointment of a Member to the Parliamentary Service Commission

"Honourable Senators,

I wish to report to the Senate that I have, pursuant to Standing Order 46 (3), received the following Message from the National Assembly regarding the approval of the appointment of a Member to the Parliamentary Service Commission.

The Message, dated Tuesday, 26th November, 2024, was received in the Office of the Clerk of the Senate on the same day.

Pursuant to Standing Order 46 (4), I now report the Message -

"PURSUANT to the provisions of Standing Order 41(1) of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly –

WHEREAS, Article 127(2)(c) of the Constitution provides for the appointment, by Parliament, of four Members of Parliament nominated equally from both Houses by the party or coalition of parties forming the national government, of whom at least two shall be women;

AND WHEREAS, following the resignation of Sen. John Kinyua, MP from the Parliamentary Service Commission, Sen. Wahome Wamatinga, MP was nominated to fill the vacancy occasioned by the said resignation;

FURTHER WHEREAS, in accordance with the provisions of Article 127(2)(c) of the Constitution, by a Resolution passed on Tuesday, 26th November 2024, the National Assembly approved the appointment of Sen. Wahome Wamatinga, MP to the Parliamentary Service Commission;

NOW THEREFORE, pursuant to the provisions of the Standing Order 41(1) of the National Assembly Standing Orders, I hereby convey the decision of the National Assembly to the Senate."

Honourable Senators,

Having concluded the bicameral approval of the appointment of Sen. Wahome Wamatinga for the Position of Member, Parliamentary Service Commission, the Senator, this afternoon, took his oath of office, pursuant to Section 46 of the Parliamentary Service Act.

(b) Approval of the Mediated Version of the Division of Revenue (Amendment) Bill (National Assembly Bills No. 38 of 2024)

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 46 (3), I received the following Message from the Speaker of the National Assembly regarding the approval, by the National Assembly, of the Mediated Version of the Division of Revenue (Amendment) Bill (National Assembly Bills No. 38 of 2024).

The Message, dated Friday, 29th November, 2024, was received in the Office of the Clerk of the Senate on Monday, 2nd December, 2024.

Pursuant to Standing Order 46 (4), I now report the Message -

"PURSUANT to the provisions of Standing Order 41 (1) and 150 (4(b) of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly –

WHEREAS, on Wednesday, 16th October 2024, the National Assembly considered and rejected the Senate amendments to the Division of Revenue (Amendment) Bill (National Assembly Bills No. 38 of 2024) thereby committing the Bill to a mediation committee, in accordance with the provisions of Article 112 (2)(b) of the Constitution;

AND WHEREAS, on Friday, 18th October, 2024 and Tuesday, 5th November, 2024, the National Assembly and the Senate, respectively, appointed Members to a Mediation Committee to develop a mediated version of the said Bill;

AND WHEREAS, on Wednesday, 27th November 2024, the National Assembly considered the Mediated Version of the Division of Revenue (Amendment) Bill (National Assembly Bills No. 38 of 2024) and passed it without amendments and in the form developed by the Mediation Committee;

NOW THEREFORE, in accordance with the provisions of Article 113 (3) of the Constitution and Standing Order 150 (4)(b) of the National Assembly Standing Orders, I hereby convey the said decision of the National Assembly to the Senate."

Honourable Senators,

As you are aware, the Senate, on Thursday, 28th November, 2024, also approved the Mediated Version of the Division of Revenue (Amendment) Bill (National Assembly Bills No. 38 of 2024).

Accordingly, the Bill, having been passed by both Houses, will be referred to His Excellency the President for assent, pursuant to Article 113 (3) of the Constitution.

I thank you."

(c) Passage of the Coffee Bill (Senate Bills No. 10 of 2023)

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 46 (3), I received the following Message from the Speaker of the National Assembly regarding the passage, by the National Assembly, of the Coffee Bill (Senate Bills No. 10 of 2023).

The Message, dated Friday, 29th November, 2024, was received in the Office of the Clerk of the Senate on Tuesday, 3rd December, 2024.

Pursuant to Standing Order 46 (4), I now report the Message –

"PURSUANT to the provisions of Standing Order 41 (1) and 144 of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly –

WHEREAS, the Coffee Bill (Senate Bill No. 10 of 2023), which was published as a Bill concerning county government to provide for, inter alia, the regulation of the coffee industry in the country, was passed by the Senate on Thursday, 21st March 2024 and thereafter referred to the National Assembly for consideration pursuant to the provisions of Article 110(4) of the Constitution;

AND WHEREAS, the National Assembly considered the said Bill and passed it with amendments on Wednesday, 27th November 2024, in the form attached herewith;

NOW THEREFORE, in accordance with the provisions of Article 112(1)(b) of the Constitution and Standing Orders 41(1) and 144 of the National Assembly Standing Orders, I hereby convey the said decision of the National Assembly to the Senate."

Honourable Senators,

Article 112 (1) (b) of the Constitution provides that if one House passes an ordinary Bill concerning counties and the second House passes the Bill in an amended form, it shall be referred back to the originating House for reconsideration.

Honourable Senators,

In this regard, I direct the Standing Committee on Agriculture, Livestock and Fisheries to deliberate on the National Assembly amendments and report to the Senate. Further, pursuant to Standing Order 165 (1) of the Senate Standing Orders, I direct that the National Assembly amendments to the Coffee Bill (Senate Bill No. 10 of 2023) be circulated to all Senators. At an

appointed time, the Senate Business Committee will schedule the consideration of the amendments.

The House is accordingly guided.

7. **STATEMENTS**

a) Statement pursuant to Standing Order 52(1)

The Senator for Meru County (Sen. Kathuri Murungi, MGH, MP) made a Statement regarding the persistent challenges facing the miraa sector in the Somalia market and other related issues. He emphasized that Somalia's suspension of flights from Kenya had harmed the livelihoods of thousands of farmers who rely on Miraa as their primary income source.

Thereupon, Sen. Kathuri stated that, in addition to the above, the sector was plagued by cartel-like activities that exploited farmers, leading to drastic price reductions and further economic hardships and that challenges facing the Miraa sector were exacerbated by mismanagement, cartel exploitation and lack of transparency.

The Senator called upon the government to address the diplomatic tensions with Somalia, propose ways of dismantling the cartels exploiting Miraa farmers and ensure greater transparency in the allocation of funds related to Miraa exports. Additionally, the Senator urged the government to diversify export markets, consider diplomatic solutions that would lead to reopening of the Somalia market, provide updates on any efforts to reopen other closed markets and put strategies in place to protect the future of the sector.

b) Statements pursuant to Standing Order 53 (1)

- iii) The Senator for Nandi County (Sen. Samson Cherarkey, MP), on behalf of the Senator for Kajiado County (Sen. Seki Lenku Ole Kanar, MP), sought a Statement from the Standing Committee on Land, Environment and Natural Resources regarding the re-issuance of land title deeds belonging to Mbirikani Group Ranch that were stolen from Kimana Police Station in Kajiado County.
- iv) The Senator for Nandi County (Sen. Samson Cherarkey, MP), on behalf of the Senator for Senator for Kajiado County (Sen. Seki Lenku Ole Kanar, MP), sought a Statement from the Standing Committee on National Security, Defence and Foreign Relations concerning alleged theft of a safe box containing land title deeds and other critical official documents belonging to Mbirikani Group Ranch from Kimana Police Station.
- v) Nominated Senator (Sen. Crystal Asige, MP) sought a Statement from the Standing Committee on Education regarding the plight of Ms. Rachel Nasimiyu Barasa on claims of indirect discrimination due to her disability.
- vi) The Senator for Kisii County (Sen. Richard Onyonka, MP) sought a Statement from the Standing Committee on Land, Environment and Natural Resources regarding continued logging and degradation of forests in Kenya.
- vii) The Senator for Kisii County (Sen. Richard Onyonka, MP) sought a Statement from the Standing Committee on National Security, Defence and Foreign Relations on the plight of missing Kenyan citizens in Saudi Arabia and other foreign countries.
- viii) The Senator for Lamu County (Sen. Joseph Githuku, MP) sought a Statement from the Standing Committee on Health regarding the supply of pharmaceutical and non-pharmaceutical products to hospitals in Lamu County.
