A. Introduction

- 1. This Paper presents the status of legislative business before Committees.
- 2. The timelines applicable to the disposal of legislative business before Committees are as presented at the last meeting. In summary
 - a) Legislative Proposals within fourteen (14) days of committal.
 - b) **Bills** within thirty (30) days of First Reading and committal.
 - c) **Petitions** within sixty days (60) of committal.
 - d) **Statements** no timelines provided. However, Committees are expected to consider the Statements expeditiously.
 - e) **Statutory Instruments** within twenty-eight (28) sitting days of Tabling of the Instruments and committal.
 - f) **Inquiries** determined by the respective Committee, but ordinarily within one Session.
 - g) **Resolutions** within the timelines provided for in the resolution.
- 3. A summary status of legislative business before Committees as at Friday, 11th April, 2025 is indicated in **Annexes I and II**.

B. Legislative Proposals

- 4. Seventy (70) legislative proposals have been referred to Committees for prepublication scrutiny and comments, pursuant to standing order 130 (3) (a) of the Senate Standing Orders. Of this number, Committees have concluded the consideration of sixty- nine (69) legislative proposals thereon and submitted their comments to the Rt. Hon. Speaker of the Senate.
- 5. The remaining (1) Legislative Proposal has exceeded the fourteen (14) day timeline provided for in the Standing Orders as follows-

- 14. One thousand one hundred and eighty-seven (1187) Statements have been referred to Committees for consideration, comprising seven (17) Statements made under Standing Order 52(1), and one thousand and one hundred and seventy (1170) Statements sought under Standing Order 53(1).
- 15. Of this number, Committees have concluded consideration of six hundred and fifteen (615) Statements, leaving five hundred and seventy-two (572) Statements pending before Committees. This represents a completion rate of **51.8%**.
