## 4. STATEMENTS PURSUANT TO STANDING ORDER 45 (2) (b)

i) The Vice-Chairperson of the Standing Committee on National Security and Foreign Relations issued a statement regarding international boundary disputes between Kenya and her neighbours. The Vice-Chairperson informed the Senate that there existed no boundary dispute between Kenya and the Democratic Republic of Ethiopia, but that inspection of the entire international boundary between the two countries was yet to be carried out due to logistical and other bureaucratic challenges. The joint inspection and reestablishment of boundary pillars between the two countries commenced in 2014, and was expected to be completed in approximately five years.

The Vice-Chairperson further informed the Senate that there existed no dispute on the land boundary between Kenya and Somalia, but that the boundary beacons between the two countries were dilapidated and require immediate re-establishment. Further, the Transitional Government of the Republic of Somalia had instituted a legal dispute in the International Court of Justice (ICJ) where it claimed part of the maritime territory over which Kenya presently exercises sovereignty. The Kenya Government had constituted a team of lawyers, headed by the Attorney General, to defend Kenya's position at the ICJ.

The Senate was further informed that there was notable disagreement along the Kenya-Uganda boundary along Lake Victoria over a one acre rock outcrop (Migingo Island) and that a joint survey had been undertaken by the two countries in respect of the boundary at Lake Victoria, and the Report thereon submitted to the respective Governments. Actual demarcation along the international boundary is pending, and the Kenya Government was pushing for completion of the same to resolve the dispute.

The Vice-Chairperson further informed the House that Kenya had a notable disagreement with the Republic of South Sudan over the common boundary from Kenya-Uganda-South Sudan Tri-Junction to Kibish Area, a place commonly referred to as 'llemi Triangle'. While Kenya continued to exercise sovereignty over the area, the Republic of South Sudan recently deposited maps with the African Union (AU) indicating the area to be in South Sudan. Efforts to delimit the boundary between the two countries had not progressed as the Republic of South Sudan requested to first address its boundary to the North with the Republic of Sudan in respect of the Abyei region. The Government was however engaging the Government of South towards kick-starting the process of delimiting the Sudan international boundary between the two countries.

The Senate was also informed that the Government had established the Kenya International Boundaries Office (KIBO) to deal with all matters related to international boundaries, and was expected to finalise demarcation of boundaries and to deposit Kenya's boundary instruments with the African Union and United Nations before the 2018 deadline.

#### (No. 056)

ii) The Vice-Chairperson of the Standing Committee on Roads and Transportation issued a statement regarding the status of the Mai-Mahiu – Narok Road. In the statement, the Vice-Chairperson informed the House that originally the road had isolated pockets of potholes, especially the section between Ntulele and Narok Town, and that the onset of the long rains in May 2015 had considerably worsened the situation and led to emergence of new potholes along the road.

The Vice-Chairperson further informed the House that the Ministry of Transport and Infrastructure through the Kenya National Highways Authority (KeNHA) had recently awarded a contract for maintenance of the road, and that the said works were expected to commence shortly.

The Senate was also informed of the House of the number and type of accidents that had occurred on the said road, and that measures were being put in place to address the identified safety challenges in order to mitigate and reduce the number of accidents.
