#### 4. STATEMENTS PURSUANT TO STANDING ORDER 45(2) (b)

a) The Senate Minority Leader (Sen. Moses Wetang'ula) sought a Statement from the Chairperson of the Standing Committee on Health regarding alleged misappropriation and loss of public funds at the Ministry of Health.

b) The Vice Chairperson of the Standing Committee on National Security and Foreign Relations issued a Statement regarding the volatile situation in South Sudan.

Thereupon , the Vice Chairperson informed the Senate that the regional Chiefs of Defence had been working out modalities for the deployment of protection forces with the hope that the United Nations Security Council would go a step further to provide sustainable funding, as well as the necessary force multipliers and enablers, to guarantee the success of their mandate.

The Vice-Chairperson also informed the Senate that the Government of Kenya had taken a lead role in resolving the conflict and had hosted the 56<sup>th</sup> Extra Ordinary Session of IGAD Foreign Ministers in Nairobi to discuss and offer solutions to the crisis in South Sudan.

The Vice Chairperson further informed the House that the Government had continued to be involved in a proactive diplomatic engagement to implore the leadership of South Sudan to honour the Comprehensive Peace Agreement with a view to restore peace and tranquility in the country.

c) The Chairperson of the Standing Committee on Labour and Social Welfare issued a Statement regarding street families and urchins in Kenya.

Thereupon, the Chairperson informed the Senate that the Street Families Rehabilitation Trust Fund (SFRTF) was established in 2003 and had embarked on the development of a national policy on the rehabilitation of street families, persons with disability and homeless urchins. The final draft was ready and awaiting input from key stakeholders.

The Chairperson also informed the Senate that the SFRTF intended to undertake major rescue and rehabilitation activities in the 2016/2017 Financial Year towards achieving its vision.

d) The Vice-Chairperson of the Standing Committee on Agriculture, Livestock and Fisheries issued a Statement regarding delay in payment for French beans delivered to M/S Value Pak Foods Limited by farmers in Kirinyaga County.

Thereupon, the Vice-Chairperson informed the Senate that M/S Value Pak Foods Limited, a private company which had contracted to buy French beans from the farmers at an agreed price of Ksh.50 per kilogramme, had faced financial problems after its main banker

collapsed. This had in turn affected the company's ability to honour its payment obligations to farmers.

The Vice-Chairperson also informed the Senate that the Government has set up an arbitration office at the Horticultural Crops Directorate of the Agricultural Food and Fisheries Authority to receive and arbitrate on conflicts between exporters and farmers or producers.

'emergency obstetric care' means the basic and comprehensive life-saving interventions performed to treat major birth complications,

"emergency treatment" means treatment immediately necessary to preserve life or prevent a permanent disability;

"family planning" means the conscious effort by a person to plan for and attain the person's desired number of children and to regulate the spacing and timing of the births of the children with the use of contraceptives or natural family planning;

"female genital mutilation" means female genital mutilation as defined in the Prohibition of Female Genital Mutilation Act;

"health care provider" means any person or institution that has been authorized to deliver health care services;

"health regulatory bodies" refer to an institution authorized by law to regulate the practice of medicine or health care provision;

"in vitro fertilization means" means the process by which an ovum is fertilised by a sperm outside the body;

"informed choice" means a voluntary decision by a patient to use or not to use a reproductive health care service, after receiving adequate information regarding the options, risks, advantages and disadvantages of that service;

"informed consent" means consent obtained freely, without threats or improper inducement, after appropriate disclosure to the patient of adequate and understandable information in a form and language understood by the patient;

"intra-partum services" means the correct diagnosis, followed by periodic examinations, screening and management of complications in the period from onset of labour to the completed delivery of the newborn and the completed delivery of the placenta;

"life skills education" means a structured programme of needs and outcomes based on participatory learning that aims to increase positive and adaptive behavior by assisting individuals to develop and practice psycho-social skills that minimize risk factors and maximize protective factors;

"maternal care" includes health care of a woman during pregnancy, childbirth and forty two days after childbirth;

"medical practitioner" means a person registered under the Medical Practitioners and Dentist Act, Cap 253;
