#### 6. <u>NOTICE OF MOT</u>ION - <u>ECONOMIC EMPOWERMENT FUND FOR PERSONS</u> <u>LIVING WITH DISABILITIES</u> (The Hon. Joyce Lay)

THAT, aware that Article 21(3) of the Constitution mandates State organs to address the needs of Persons With Disabilities (PWDs); noting that this vulnerable group continues to face numerous challenges in getting access to the *Uwezo* Fund, the Youth Enterprise Development Fund and the Women Enterprise Fund; deeply concerned that there is no clear mechanism to ensure that Persons With Disabilities get their share of the funds, this House resolves that 30% of each of these Funds be channeled through the Economic Empowerment Fund under the National Council for Persons with Disabilities.
