5. **STATEMENTS**

(a) Statements Pursuant To Standing Order 45(2) (b)

- i) Sen. Ali Bule sought a Statement regarding the ongoing severe drought affecting Tana River County and other arid and semi-arid areas in the country, including Kilifi, Kwale, Taita Taveta, Garissa, Wajir, Mandera, Isiolo, Marsabit, Kitui and Samburu Counties.
- ii) Sen. Moses Kajwang' on behalf of the Chairperson, Standing Committee on Agriculture, Livestock and Fisheries issued a statement on the fate of tea farmers who lost money in the collapse of Imperial Bank and Chase Bank.

The Senator informed the Senate the Board of Directors of KTDA had approved 15 banks, including Imperial Bank and Chase Bank, where the Agency would deposit money. The Senator further informed the Senate that as at 13th October, 2015, when Imperial Bank Limited was placed under receivership, KTDA had Kshs. 2.926 billion as deposits compared to its deposit of Kshs. 1.9228 billion held at when Chase Bank Limited as at 7th April, 2016, when the Bank was put under receivership.

The Senator also informed the Senate that by spreading cash sales with different banks, KTDA was mitigating the concentration risks through diversification of investments across several banks. The Senate was assured that farmers have been paid their bonus, by KTDA, using borrowings and reallocations of funds set aside for other projects as the Agency awaits the availability of its deposits in the collapsed banks.

iii) The Vice-Chairperson of the Standing Committee on National Security and Foreign Relations issued a Statement on the plight of Kenyan refugees from Uganda, who had been camping at the gate of Senate since 10th October, 2016.

In the Statement the Vice-Chairperson informed the Senate that the Government was aware of the group of Kenyans who had returned from Uganda where they had fled following the 2007/2008 Post-Election Violence and who camping along Parliament road. The Senate was informed that the Government had established a taskforce to facilitate repatriation of refugees to Kenya. The team and executed their mandate and found only 246 to be genuine returnees. The 246 had since been compensated in cash.

The Vice-Chairperson further informed the House that on further scrutiny of the list provided by the leader of the returnees, the government had noted a discrepancy between the list provided by the returnees and that held by the Government. Consequently, the United Nations High Commissioner for Refugees (UNHCR) was helping the Government to address the discrepancies and ensure unscrupulous persons did not take advantage of the process.
