Standing Order 141(2)(b) states that, "a Bill that has been published, read a first time or in respect of which the Second Reading has not been concluded at the end of two consecutive Sessions of Parliament shall lapse at the end of the Second Session and may be republished in the same or different form in accordance with Standing Order 114."

In this regard, Honourable Members, the following Bills have since lapsed-

- (ii) The Election Laws (Amendment)(No. 2) Bill, 2015;
- (iii) The Parliamentary Service Bill, 2015;
- (iv) The Constitution of Kenya (Amendment)(No. 3) Bill, 2015;
- (v) The Constitution of Kenya (Amendment)(No. 5) Bill, 2015;
- (vi) The Constitution of Kenya (Amendment) (No. 6) Bill, 2015;
- (vii) The Military Veterans Bill, 2013;
- (viii) The Kenya Uwezo Fund Bill, 2015; and
- (ix) The International Crimes (Repeal) Bill, 2015.

Honourable Members, it is imperative to note that in accordance with our Standing Orders, the aforementioned Bills may be re-published, whether by the Members who had earlier sponsored them or by any other Member or Committee for consideration by the House. Pursuant to the provisions of Standing Order 225(2)(b), the Speaker reported the following Petition to the House:-

#### Alleged detention of Mr. Silas KeragiaMaosa in the Republic of Rwanda

"Honourable Members, Pursuant to the provisions of Standing Order 225, I hereby convey a Petition from a Mr. Muriuki Wandeto on behalf of the family of Mr. Silas Keragia Maosa. The Petitioner alleges that a Kenyan citizen has been detained in the Republic of Rwanda based on accusations of embezzlement of resources belonging to a private entity, Gulf Energy Limited.

Honourable Members, the Petitioner states that Mr. Maosa while employed by Gulf Energy Rwanda, was arrested, tried, convicted and remains incarcerated in Kigali, Rwanda. The Petitioner further states the family of Mr. Maosa has been denied access to him.

Honourable Members, in this regard, the Petitioner prays that the National Assembly recommends that the Ministry of Foreign Affairs intervene with a view to having the family of Mr. Silas Maosa granted permission by the Rwandese authorities to access the detainee and also intervene to have him repatriated to Kenya.

This Petition therefore stands committed to the Departmental Committee on Defence and Foreign Relations for consideration. The Committee is required to consider the Petition and report its findings in accordance with the provision of Standing Order 227 (2).

The Member for Suba Constituency (Hon. John Mbadi, CBS, M.P.) made a personal Statement pursuant to Standing Order 84 regarding allegations leveled against him by the Leader of the Majority Party (Hon. Aden Duale, EGH, MP) on 23<sup>rd</sup> November 2016, that a company associated with him or his relatives allegedly benefited inappropriately from the National Youth Servicecontracts. He mentioned that Hon. Duale alleged that two (2) companies he claimed are associated with his wife namely; Omos Enterprises and Takawiri Enterprises Limited as having benefitted in the rip off.

He averred that the he knew of no company in the name of Omos Enterprises that was related to him or his relatives, adding that whereas Takawiri Enterprises Limited was registered by his wife, it remained active until August 2012 and it was inconceivable that it could have benefited from NYS related scandals which happened much later. Hon. Mbadi was categorical that Hon. Duale's allegations were based on false information.
