9. MOTION - ADOPTION OF THE REPORT OF THE STANDING COMMITTEE ON FINANCE, COMMERCE AND BUDGET ON THE CONSIDERATION OF THE SECOND GENERATION CRITERIA FOR RESOURCE ALLOCATION FOR 2015/16, 2016/17 AND 2017/18

Motion made and Question proposed;

THAT, this House adopts the Report of the Standing Committee on Finance, Commerce and Budget on the Consideration of the Second Generation Criteria for Resource Allocation for 2015/16, 2016/17 and

2017/18 laid on the Table of the House on Wednesday, 11th February, 2015.

Debate on the following amendment interrupted on Wednesday, 18th February, 2015, resumed;

THAT, this House adopts the Report of the Standing Committee on Finance, Commerce and Budget on the Consideration of the Second Generation Criteria for Resource Allocation for 2015/16, 2016/17 and 2017/18 laid on the Table of the House on Wednesday,11th February, 2015 subject to amending the recommendation by:-

- a) Renumbering the current recommendation as (1) and
- b) Adding recommendation (2) and (3) as follows:
- (2) That, one (1) percent of the resultant figure arising from recommendation (1) in each County in every financial year shall be reserved in the respective County Revenue Funds to be utilized within the county for monitoring and evaluation of devolution, entrenching of devolution, capacity building and any other purpose related to Article 96 of the Constitution.
- (3) The Senate shall make regulations for the management of the resources referred to in (2).
