I. Questions under the Departmental Committee on Education, Research and Technology

Questions to the Cabinet Secretary for Education, Science and Technology:

(i) Question No. 065/2015 by the Member for Sirisia Constituency (The Hon. John Waluke Koyi, M.P.):

Could the Cabinet Secretary inform the Committee the criteria used to appoint and promote academic staff at the University of Eldoret; address the allegations that ethnicity is a factor as seen by lecturers seeking support of local politicians for promotions which led to the recent violent protests by students and the local community leading to the closure of the institution; address the allegations that the chaos targeted persons from non-local ethnic communities leading to the ejection of Vice Chancellor from office; confirm whether due process was followed in the recent appointments; and table names of candidates interviewed and appointed as well as their positions and remuneration?

(ii) Question No. 107/2015 by the Member for Kesses Constituency (The Hon. James Kimaru Bett, M.P.):

Considering that a number of learning institutions in Garissa County including Garissa University, Garissa Medical Training Institute, Garissa Technical Training Institute failed to re-open following the April 2015 terrorist attack, could the Cabinet Secretary apprise Members on whether the situation on the ground provides guarantee for resumption of learning without endangering the lives of students and tutors; the rationale behind Garissa University inviting students to report back despite the current security concerns in the area; the measures in place to secure both the students and the institutions; and plans, if any, to transfer students from the said institutions particularly those from Kesses Constituency bearing in mind that most of them are still traumatized by the terrorist attack which claimed the lives of their colleagues?

(iii) Question No. 108/2015 by the Member for Ndhiwa Constituency (The Hon. Agostinho Neto, M.P.):

Could the Cabinet Secretary apprise the Committee on the number of times that Kenya Certificate of Secondary Education (KCSE) results for Obera Boys Secondary School and Magina Girls Secondary School in Ndhiwa Constituency have been withheld over the past five years; the reasons behind the withholding decisions; measures, if any, either disciplinary or otherwise that have been taken against those found culpable; and measures that have been taken to remedy and secure the rights of the boys and girls who have been constantly been affected by the situation?

(iv) Question No. 109/2015 by the Member for Eldama Ravine Constituency (The Hon. Moses K. Lessonet, M.P.):

Could the Cabinet Secretary apprise the Committee on the general deployment policy of the Teachers Service Commission, and in particular, explain to the Members the reasons behind the continued discrimination against schools in Eldama Ravine Constituency when it comes to deployment of teachers; further enlighten the Committee on why Schools in the Constituency have fewer TSC teachers compared to other parts of Baringo County which have smaller population sizes and some of whose schools have been in operation for less than four years as shown in the following analysis:

Could the Cabinet Secretary explain to Members the reasons behind the indefinite closure of public learning institutions in Garissa County including the Kenya Medical Training College (KMTC) and the North Eastern Provincial Technical College, and provide timelines within which the institutions shall be reopened?

Could the Cabinet Secretary inform the Committee whether an Environmental Impact Assessment (EIA) was undertaken and approved by the National Environmental Management Authority (NEMA) for the construction of the Standard Gauge Railway (SGR) from Mombasa to Nairobi, the mitigation measures to be undertaken in ensuring that the construction of the railway through Tsavo East and Tsavo West National Parks will not impact negatively on the environment; movement and survival of wildlife; and the mechanisms, both short and long-term that have been put in place to evaluate the success or failure of the proposed mitigation measures?

(ii) Question No. 072/2015 by the Member for Emuhaya Constituency (The Hon. (Dr.) Wilber Ottichilo, M.P.):

Could the Cabinet Secretary table before the Committee the current implementation status report of the Lake Victoria Environmental Management Programme funded by the World Bank, showing projects that have been implemented, their total costs, location, environmental impact, impact on human welfare, whether respective stakeholders and leaders were fully involved in their identification and implementation, and the projects planned for the near future?

(iii) Question No. 073/3015 by the Member for Emuhaya Constituency (The Hon. (Dr.) Wilber Ottichilo, M.P.):

Could the Cabinet Secretary inform the Committee on the programmes and activities that the Ministry has put in place to implement the National Climate Change Action Plan that was launched

in 2013, the number of programmes and activities being mainstreamed at the County level, the avenues being pursued by the Ministry in involving the key stakeholders in the formulation and development of national proposals and positions towards the preparation of Global Climate Change Agreement that will be negotiated and approved in Paris, France during the 21st Conference of Parties of the UN Framework on Climate Change Convention in November/ December 2015?

(iv) Question No. 114/2015 by the Member for Galole Constituency (The Hon. Hassan Dukicha, M.P.):

Considering that Article 132(1)(h) of the Constitution envisages equity and diversity in the representation of Kenya's communities in public appointments, could the Cabinet Secretary explain to Members whether the recruitment of Kenya Wildlife Services (KWS) rangers in Tana River in the recently concluded recruitment exercise was equitable; and further apprise Members on the actions the Ministry is undertaking to ensure equity in such appointments in Tana River.

(v) Question No. 115/2015 by the Member for Turkana North Constituency (The Hon. Christopher Nakuleu, M.P.):

Could the Cabinet Secretary apprise Members on measures being pursued by the Ministry towards sustainable water security for arid and semi-arid regions of the country, and in particular, confirm the timeline by which the water pans and boreholes that were allocated to Turkana North Constituency in the 2013/2014 Budget will be completed considering that the procurement process had already been initiated through regional authorities of Kerio Valley Development Authority and Rift Valley Water Service Board (RVWSB); explain what occasioned the two-year delay in the completion of these projects; and inform the Committee on the alternative ways of timely execution and completion of essential projects within the shortest time possible in the face of the current lengthy and bureaucratic procurement procedures?

(vi) Question No. 116/2015 by the Member for Embakasi North Constituency (The Hon. James Mwangi Gakuya, M.P.):

Could the Cabinet Secretary provide an update of the status of Nairobi River and the new park between Kijabe and Kipande Roads; information on the ownership of the land on which the park is situated, the status of the rehabilitation project including the satisfaction of the relevant Ministry with the work done; and further apprise Members on whether procurement procedures were followed in the acquisition of project materials including tree seedlings; and highlight the plans, if any, being pursued by the Ministry in permanently employing the people working as casual labourers under the project?

Could the Cabinet Secretary inform the Committee what steps the Government is taking to ensure that the economic interests of Kenyan investors in South Sudan affected by the non-convertibility of the South Sudan currency are restored and in particular explain the measures theKenyan and South Sudanese Governments are taking to help convert the cash already accumulated by Jetlinkin Juba and subsequently enable the airline, which had already grounded its fleet, to resume operations?

(ii) Question No. 040/2015 by the Member for Westlands Constituency (The Hon. Timothy Wanyonyi, M.P):

Could the Cabinet Secretary inform the Committee the current status of unclaimed financial assets in the country, and in particular, apprise Members on why the Unclaimed Financial Assets Authority has allegedly neglected its supreme mandate of ensuring that all asset holders make all reasonable efforts to locate and notify owners of their assets as provided for in the Unclaimed Financial Assets Act 2011 thereby causing untold suffering to families of owners of unclaimed assets who continue to wallow in poverty oblivious of the assets due to them; whether or not the Authority has published a list in a medium accessible to most people including the families of owners of unclaimed financial assets to enable them trace them; actions taken so far by both the Authority and the Ministry at informing families/ beneficiaries of unclaimed financial assets whose owners are either deceased or cannot be traced; measures in place to compel and ensure that all asset holders of unclaimed financial assets inform the Authority of the said assets, and punitive action being meted against non-compliance by asset holders?
