<u>Guidance on Proposed Amendments to the Supplementary Appropriation (No. 2) Bill,</u> 2016

"Honourable Members,

You may recall that during today's Morning Sitting, the House approved the Report of the Budget and Appropriations Committee on the Second Supplementary Estimates for the Financial Year 2015/2016 including amendments proposed by the Leader of the Majority Party, Hon. Aden Duale. The said amendments increased the development expenditure budget to a net amount of Kshs.27,441,547,334 taking into account the proposed reduction of Kshs. 7,519,683,629.

However **Hon. Members**, during the passage, the overall Motion did not capture the changes in the schedules. It is for this reason therefore that the Chairperson of the Budget and Appropriations Committee, Hon. Mutava Musyimi, MP, will be moving amendments to the Bill. This will ensure that the House corrects the overall total increase in both the recurrent and development expenditure as reflected in the Schedules approved this morning.
