The main event, namely, the 46<sup>th</sup> CPA (Africa Region) Conferenceis scheduled to take place from the 9<sup>th</sup> – 15<sup>th</sup> August, 2015.

It will be preceded by the 6<sup>th</sup> Commonwealth Women Parliamentarians (CWP) Conferencewhich willtake place from the 6<sup>th</sup> – 9<sup>th</sup> August, 2015. Both conferences will be held at the Safari Park Hotel, Nairobi.

My office has nominated or is in the process of nominating Senators to participate in the two conferences as delegates and observers. I am certain some Senators have received correspondence to that effect.

The CWP conference is expected to attract more than one hundred (100) participants from the Commonwealth Countries in Africa, Government Officials and civil society organizations. Her Excellency the First Lady of the Republic of Kenya has been invited and has graciously accepted to officially open the conference on Friday, 7<sup>th</sup> August, 2015.

All Senators and especially women Senators are invited and encouraged to attend. In the following week, that is, Tuesday, 11<sup>th</sup> August, 2015, H.E. the President of the Republic of Kenya will officially open the second and main conference where over four hundred (400) participants from Africa and beyond are expected to attend.

#### 7. STATEMENTS

#### (a) <u>Statements Pursuant To Standing Order 45 (2) (b)</u>

- i) Nominated Senator (Sen. Liza Chelule), sought a statement from the Chairperson of the Standing Committee on Labour and Social Welfare on access to finances by the youth, women and persons with disability to execute tenders won through the 30% access to Government procurement.
- ii) The Vice-Chairperson of the Standing Committee on Agriculture, Livestock and Fisheries issued a Statement on the seizure by Thailand customs officials of ivory hidden in tea leaves as had been requested by the Senator for Bomet County (Sen. (Prof) Wilfred Lesan).

#### THURSDAY, JULY 30, 2015

The Vice-Chairperson informed the Senate that Kenya did not export any tea to the Kingdom of Thailand or Laos in the days preceding 28<sup>th</sup> April 2015. However, the Vice-Chairperson informed the Senate that Customs officials at Thailand had seized 511 elephant tusks weighing 3.1 tons on 27<sup>th</sup> April 2015 inside a container that had been shipped from Mombasa on 6<sup>th</sup> April 2015.

The Senate was further informed that the alleged container was exported by Almasi Chai (K) Ltd and declared to contain 220 bags of various teas destined for UAE and that the tea was stored by Siginon Global warehouse before export by an entity known as Potential Quality Supplies who are not registered to deal in tea, and in contravention of the Crops Act, 2013.

The Vice-Chairperson also informed the Senate that the circumstances under which the tea consignment was found in Thailand on 28<sup>th</sup> April, 2015, yet it was destined for UAE are currently under Police investigations and assured the Senate that the Ministry of Agriculture, Livestock and Fisheries in consultation with stakeholders had put in place several measures to streamline tea trade, including not allowing tea auction by proxies of the registered buyers and installing CCTV cameras in all tea warehouses and that, to deter traders from dealing in contraband under the guise of tea, the Ministry had revoked the license of Almasi Chai Ltd and suspended the license for Signon Group until they are exonerated by the ongoing investigations.
