## 7. STATEMENTS PURSUANT TO STANDING 44(2)(b)

Pursuant to Standing Order 44(2)(b), the following Statements were issued -

(i) by the Leader of the Majority Party regarding the status of commercial motorcycles, commonly known as "boda bodas" in response to a request by the Member for Ugenya (Hon. David Ouma);

The Leader of the Majority Party informed the House that there are 672,620 registered motor cycles in the country, out of which 450,000 are engaged in public transport business. All *boda boda* riders are expected to undergo training in licensed driving institutions and acquire riding licences. Regarding plans being taken to ensure that travel using *boda boda* means is safe, the Chairperson informed the House that the Government will continue enforcing existing laws with a view to ensuring safety and order in the transport. The Government would also continue apprehending and prosecuting those found to be violating the laws in place.

(ii) by the Chairperson, Departmental Committee on Transport, Public Works and Housing regarding the status of tarmac roads in the country, in response to a request by the Member for Keiyo (Dr. James Murgor);

The Chairperson informed the House that the Ministry of Transport and Infrastructure had approved roads to be tarmacked in the last three financial years. Iten-Burgar Road project was awarded to M/s Kiu Construction Company Limited on 15<sup>th</sup> September, 2011 at a cost of Kshs. 656,510,497; and

(iii) by the Chairperson, Departmental Committee on Transport, Public Works and Housing regarding the status of tarmac roads in Bureti Constituency, in response to a request by the Member for Bureti (Hon. Leonard Sang);

The Chairperson informed the House that the Sotik-Cheplanget-Cheborgei-Roret-Sigowet road project was awarded to M/s Spencon Kenya Limited at a contract sum of Kshs. 3,149,152,168. The Litein-Cheborgei-Kiburgat road has been designed and the works are expected to complete in 24 months.

Statement to the Chairperson, Departmental Committee on Health regarding non-deployment of nursing interns to hospitals in the country by the Member for Kiambu (Hon. Jude Njomo) was dropped in the absence of the Member.

#### 9. PERSONAL STATEMENT PURSUANT TO STANDING ORDER

The Member for Dagoretti North (Hon. Simba Arati) made a Personal Statement regarding an article appearing in the Sunday Nation of 27<sup>th</sup> July, 2014 where it was reported that he had been accused of misusing a gun.

The Member informed the House that the article was false, sensational and only intended to mislead the public. The case of misuse of the gun is however under investigation at the Muthangari Police Station involving a Mr. Shah not the Member for Dagoretti North.

The Member also informed the House of the circumstances that led to the incident and that the matter is under investigation. The story is thus a misrepresentation of the facts on the ground. Further, the Member believes in the due process of the law and that Mr. Shah has on previous occasions published falsehoods concerning the incident.
