III. I. <u>Questions under the Departmental Committee on Administration and National</u> <u>Security</u>

<u>Questions to the Cabinet Secretary for Interior and Coordination of National</u> <u>Government:</u>

(i) Question No. 078/2015 by the Member for Emuhaya Constituency (The Hon. (Dr.) Wilber Ottichilo, M.P.):

Could the Cabinet Secretary explain the mechanism that has been put in place to ensure that full-time state officers are not engaged in other gainful employment; and that retired state officers do not hold more than two concurrent remunerative positions as chairpersons, directors or employees of state organs as required by Article 77 of the Constitution?

(ii) Question No. 080/2015 by the Member for Trans Nzoia County (The Hon. Janet Nangabo, M.P.):

Could the Cabinet explain to the Committee reasons behind the ongoing dismissals of police officers without explanations or tribunals being set that has led to some among them committing suicide due to frustrations; reasons behind failure to set tribunals to give officers opportunity to defend themselves; measures being pursued to curb this abuse of power by their seniors who appear to sack them at will; and the date set to have all wrongfully dismissed officers reinstated?

(iii) Question No. 082/2015 by the Member for Sirisia Constituency (The Hon. John Waluke, M.P.):

Could the Cabinet Secretary inform the Committee the circumstances that have led to recent jail-breaks through which dozens of hardcore criminals have escaped custody with no reports of their recapture; the facts that most of the daring escapes have been committed outside the precincts of correctional facilities; circumstances by which a robber sentenced to life imprisonment escaped from Kenyatta National Hospital and whether or not he has been recaptured; address the allegation that some prison officers are in collusion with the escapees since they are always being caught off-guard even during prisoners' transportation; the number of escapees rearrested within the last one year; and the long-term measures being pursued to tackle this disturbing and dangerous menace once and for all?

(iv) Question No. 083/2015 by the Member for Kajiado North Constituency (The Hon. Joseph Manje, MP):

Could the Cabinet Secretary apprise Members on the circumstances in which buildings belonging to Museto Women Group in Ngong Town were demolished on November 11, 2014 yet there was a court case scheduled for the same day at 0900hrs at Milimani Commercial Courts; the reason behind use of excessive force by police officers from Kasarani, Lavington, Langata, Dagoretti, Kamukunji, KICC, Muiki and Ngong Police Stations; the reasons behind police officers lobbing teargas canisters at the Area Member of Parliament (Hon. Joseph Manje) which led to serious injuries necessitating admissions at Karen Hospital, Nairobi Hospital and Apollo Hospital in India for treatment; the reasons behind police officers allowing hired youths from Kibra to loot property belonging to the Group; and the rationale behind the fact that the Museto Women Group's case which was registered in Machakos in 2002 has never been concluded?

(v) Question No. 079/2015 by the Member for Emuhaya Constituency (The Hon. (Dr.) Wilber Ottichilo, M.P.):

Could the Cabinet Secretary apprise the Committee on the current status of the San Marco Space Application Centre in Malindi as regards its legal status, status of management and staff, its assets and equipment, the ongoing activities, usage of satellite data generated, income generation, corporate social responsibility, and its future goals; and explain the reasons why the country has not incorporated the use of satellite technology in its security operations and monitoring as well as disaster risk reduction monitoring and management?

(vi) Question No. 081/2015 by the Member for Emuhaya Constituency (The Hon. (Dr.) Wilber Ottichilo, M.P.):

Could the Cabinet Secretary apprise the Committee on the achievements of the Kenya Space Science Secretariat, the costs it has incurred since its establishment, and when the Kenya National Space Agency (KENSA) will be established?

(i) Question No. 152/2015 by the Member for Nakuru County (The Hon. Mary Mbugua, HSC, M.P.):

Considering the rising number of accidents on the Salgaa-Nakuru-Eldoret Highway that have either killed or maimed scores of people due to among other factors, poor or total lack of road signs particularly in the Salgaa area that has become a blackspot, could the Cabinet Secretary apprise Members on plans, if any, that the Government is pursuing in clearly marking this and other roads, erecting traffic signs, replacing vandalized road signs, and repainting faded signs; and further enlighten the Committee on the feasibility of constructing a dual carriage for the Salgaa Road section and other accident-prone roads in the country?

(ii) Question No. 153/2015 by the Member for Eldama Ravine Constituency (The Hon. Moses K. Lessonet, M.P.):

Could the Cabinet Secretary apprise the Committee on reasons why the section of Road C55 Ravine to Nyoru continues to be damaged by overloaded trucks without any visible interventions from the Ministry; explain reasons why the Kenya National Highways Authority (KeNHA) has not installed signages along this section to enable police implement truck control measures; provide names the public officers guilty of negligence in implementing load control measures; highlight the disciplinary measures taken against these officers; and give the estimated cost of damage on this particular section of the road?

(iii) Question No. 154/2015 by the Member for Embakasi South Constituency (The Hon. Irshadali M. Sumra, M.P.):

Could the Cabinet Secretary apprise the Committee on plans, if any, to reduce the cash bail fines imposed on traffic offenders, mainly bodaboda operators, taxis and matatus, from the current Ksh 10,000 to a much lower figure as a means of curbing the harassment of these public commuter service operators by traffic police?

Could the Cabinet Secretary apprise the Committee on the general deployment policy of the Teachers Service Commission, and in particular, explain to the Members reasons behind the continued discrimination against schools in Eldama Ravine Constituency when it comes to deployment of teachers; further enlighten the Committee on why the Constituency has fewer TSC teachers compared to other parts of Baringo County which have smaller population sizes and some of whose schools have been in operation for less than four years as shown in the following analysis:

(ii) Question No. 111/2015 by the Member for Garissa County (The Hon. Shukran Hussein Gure, M.P.):

Could the Cabinet Secretary explain to Members the reasons behind the indefinite closure of public learning institutions in Garissa County including the Kenya Medical Training College (KMTC) and the North Eastern Provincial Technical College, and provide timelines within which the institutions shall be reopened?

(iii) Question No. 112/2015 by the Member for Kandara Constituency (The Hon. Alice Wahome, M.P.):

Could the Cabinet Secretary apprise the Committee on whether County Governments have authority to convert public primary schools into boarding primary schools, and more so without feasible sustainability programs in place and indeed without authority from the Ministry of Education, Science and Technology; and in particular confirm to Members whether he is aware that the County Government of Murang'a is converting two primary schools per sub-county (constituency) in Murang'a County into public boarding schools including Gakarara and Githunguri Primary Schools in Kandara Constituency; and the policies, if any, that address such conversions; measures the Ministry has in place to either prevent or sustain these conversions?
