At the Sitting of the Senate held on 21st July, 2020, the Hon. Speaker of the Senate, presented a Petition submitted by Mr. Robert Musyoka, acting Clerk, Makueni County Assembly, on behalf of the Sectoral Committee on Environment and Climate Change concerning the adverse effects of rock blasting at Thwake Dam, Makueni County.

The salient issues raised in the said Petition are as follows-

- That, the Petitioners, Sectoral Committee on Environment and Climate Change, have concluded the matter of a request for a Statement regarding the adverse effects of rock blasting at the ongoing construction of Thwake Multipurpose Dam in Kalawa Ward, Makueni County and it has not been able to resolve the problem conclusively as the matter is affecting more than one county having been funded and implemented by the National Government.
- 2. That, the construction of the dam involves amongst other activities, blasting of rocks which has adversely impacted on the lives of the residents of nearby

villages such as houses and shops cracking, thus posing danger to the occupants of such structures. Other adverse effects of rock blasting in the area include noise pollution and respiratory problems to the residents.

- That, the affected areas include but not limited to Ndindi, Syotuvali Market, Kamutinye, Kitoto, Unyeeo, Ngomano and Syongungi in Kathulumbi Location Ward and Kyusyani, Miangeni, Kaseve, Katithi, Miksi and Mathangathi in Mavindini Ward; and
- 4. That, the Committee recommended corrective measures to the contractor but the matter has not been addressed by the relevant contractor and other agencies.

Therefore, the petitioners humbly pray that the Senate intervenes to ensure that the contractor safeguards the residents living in the affected areas from devastating effects of the construction of the dam, not limited to the noise from the rock blasting.

Pursuant to standing order 232(1) and the Second Schedule to the Standing Orders of the Senate, the Petition was committed to the Standing Committee on Land, Environment and Natural Resources.

Pursuant to Articles 37 and 119(1) of the Constitution, section 5(2) of the Petition to Parliament (Procedure) Act and standing order 232 of the Senate Standing Orders, the Committee is mandated to consider the Petition and respond to the Petitioner within the prescribed period.

To enable a judicious disposal of the Petition, the Committee resolved to conduct an inquiry on the issues raised in the Petition. In this regard the Committee invited the Petitioner to a meeting of the Committee for the Petitioner to elaborate further on the issues raised in the Petition and to supply supporting evidence on the same.

The Committee proceeded to invite the Cabinet Secretary, Ministry of Environment and Natural Resources for an online meeting on the matter since the subject falls within the mandate of the Ministry of Environment and Forestry and further requested for written responses from the Ministry of Water, Sanitation and Irrigation.

The Committee also undertook a site visit of the Thwake dam area in Makueni County and met with the community living around the Thwake dam accompanied by the area Senator, Makueni County, Sen. Mutula Kilonzo Junior, MP.

CHAPTER I

INTRODUCTION

- At the sitting of the Senate held on 21st July, 2020, the Hon. Speaker of the Senate, presented a Petition submitted by Mr. Robert Musyoka, acting Clerk, Makueni County Assembly, on behalf of the Sectoral Committee on Environment and Climate Change concerning the adverse effects of rock blasting at Thwake Dam, Makueni County.
- 2. The salient issues raised in the Petition are as follows-
 - 1. That, the Petitioners, Sectoral Committee on Environment and Climate Change, have concluded the matter of a request for a Statement regarding the adverse effects of rock blasting at the ongoing construction of Thwake Multipurpose Dam in Kalawa Ward, Makueni County and it has not been able to resolve the problem conclusively as the matter is affecting more than one county having been funded and implemented by the National Government;
 - 2. That, the construction of the dam involves amongst other activities, blasting of rocks which has adversely impacted on the lives of the residents of nearby villages such as houses and shops cracking, thus posing danger to the occupants of such structures. Other adverse 5 effects of rock blasting in the area include noise pollution and respiratory problems to the residents;
 - That, the affected areas include but are not limited to Ndindi, Syotuvali Market, Kamutinye, Kitoto, Unyeeo, Ngomano and Syongungi in Kathulumbi Location Ward and Kyusyani, Miangeni, Kaseve, Katithi, Miksi and Mathangathi in Mavindini Ward; and
 - 4. That, the Committee recommended corrective measures to the contractor but the matter has not been addressed by the relevant contractor and other agencies.

- The Petitioner, therefore, prays that -3.
 - The Senate intervenes to ensure that the contractor safeguards the residents living in the affected areas from devastating effects of the construction of the dam, not limited to the noise from the rock blasting.
- Pursuant to Standing Order 232(1) of the Standing Orders of the Senate, the Petition 4. was committed to the Land, Environment and Natural Resources Committee.

LEGAL BASIS FOR PETITIONS

- 5. Petitions to the Senate are governed by the Constitution, the Petition to Parliament (Procedure) Act, No. 22 of 2012 and the Senate Standing Orders.
- 6. Article 37 of the Constitution provides that every person has the right, peaceably and unarmed, to assemble, to demonstrate, to picket, and to present petitions to public authorities while Article 119(1) of the Constitution provides that "every person has a right to petition Parliament to consider any matter within its authority, including to enact, amend or repeal any legislation."
- 7. Section 5(2) of the Petition to Parliament (Procedure) Act, provides that a petition that is tabled in Parliament under this Act shall be considered in accordance with the Standing Orders of the relevant House. In this regard, Standing Order 232 of the Senate Standing Orders provides as follows-
 - 232. Committal of Petitions
 - (1) Every Petition presented or reported pursuant to this Part, shall stand committed to the relevant Standing Committee.
 - (2) Whenever a Petition is committed to a Standing Committee, the Committee shall, in not more than sixty (60) calendar days from the time of reading the prayer, respond to the petitioner by way of a report addressed to the petitioner or petitioners and laid on the Table of the Senate and no debate on or in relation to the report shall be allowed, but the Speaker may, allow comments or observations in relation to the Petition for not more than thirty Minutes.
- 8. Standing Order 233 requires the Clerk to, within fifteen (15) days of tabling of the report on a petition under Standing Order 232 (Committal of Petitions), submit a copy of the report to the petitioner or petitioners.

CHAPTER 2

CONSIDERATION OF THE PETITION

Approach taken by the Committee

- 1. In considering the Petition, the Committee observed that it would be important to verify the facts alleged by the Petition. The Committee therefore resolved to conduct an inquiry on the issues raised in the Petition.
- 2. In this regard, the Committee received the Petition from the Petitioners through the House and further invited the Cabinet Secretary, Ministry of Environment and Forestry, together with his team from the National Environment Management Authority, NEMA, who virtually appeared before the Committee on 14th October 2020 and on 2nd December 2021 where he committed to further send written submissions. The Committee also later wrote to the Ministry of Water and Sanitation requesting for written submissions on the matter.

Petitioners Submissions

The Petitioner outlined the Petition as follows;

Public Petition

- 1. **THAT**, pursuant to article 119 (1) of the Constitution of Kenya, 2010, "Every person has a right to petition Parliament to consider any matter within its authority, including to enact, amend or repeal any legislation".
- 2. THAT, the County Assembly Committee on Environment and Climate Change (hereinafter the Committee) has concluded the matter of a request for a Statement regarding the adverse effects of rock blasting at the ongoing construction of Thwake Multipurpose Dam in Kalawa Ward in Makueni County.
- 3. **THAT**, the Committee has not been able to conclusively resolve the problem, since the project is funded and implemented by National Government affecting more than one County, hence the resolution to petition the Senate.
- 4. **THAT**, the construction of the dam involves a number of activities including rock blasting to obtain stones and rocks for construction use.

- 5. **THAT**, the construction activities at the dam, more so the rock blasting, have brought about a plethora of challenges and adverse impacts on the lives of the residents of the nearby villages.
- 6. **THAT**, the noise arising from the rock blasting activities have caused house and shops to crack hence weakening the structures and posing danger to the occupants of such structures.
- 7. **THAT,** flying rocks from blasting site end up hitting roofs of the nearby homesteads a case in point is the house of Ms. Mary Mwikali Kyali who her homestead is located barely 200 metres from the site.
- THAT, the affected areas include but not limited to; Ndingi, Syotuvali Market, Kamutonye, Kitoto, Unyeeo, Ngomano, and Syongungi in Kathulumbi Location. Kalawa ward and Kyusyani, Miangeni, Kaseve, Katithi, Miksi and Mathangathi in Mavindini ward.
- 9. **THAT**, the Committee and the Department of Water, Sanitation, Environment and Climate Change of County Government of Makueni carried out site visits to the project and to the areas affected on separate occasions on a fact-finding mission.
- 10. THAT, the contractor provided contradicting information from what was gathered during the said site visits by the two independent parties. For instance, the contractor indicated that rock blasting was never done at night and yet in actual sense it was done and the contractor did not have a license for night rock blasting.
- 11. **THAT**, the Committee, the Department of Water, Sanitation, Environment and Climate Change of County Government of Makueni, the project Coordinator, Thwake Multipurpose Dam Project, Community Liaison, (representatives of SMEC Kenya (Pty) Ltd. the project supervisors) and representative of the people from the two wards, held a consultative meeting at the project site on 1st November, 2019 to deliberate on the matter in which corrective measures to the effects of rock blasting were resolved and given timelines mostly to be undertaken by the contractor and others by the SMEC Community Liaison officer. The latest timeline was set to be 8th November, 2019 which has long passed and no efforts have been shown to effect the resolutions.

Response by the Cabinet Secretary, Ministry of Environment and Forestry

The Ministry vide a letter Ref. No. SEN/DCS/LENR/2/2020/(70) dated 17th November, 2020 was invited to make submissions on the Petition and appeared before the Committee on 2nd December, 2020 and presented as follows;

1.0 Background

Thwake Multipurpose Dam is a National Government Project undertaken by Tanathi Water Service Board (TAWSB) being constructing at confluence of Athi and Thwake rivers in Mavindini Division of Makueni District, Kalawa divison in Mbooni East District and covering sections of southern part of Yatta division in Kitui West District. It is an embankment dam with an approximate maximum height of 84M covering an area of approximate 2,000ha, with a catchment spanning about 10,276km² spreading into among other locations Mavindini, Kanthuni, Kitise, Kithuki, Kathonzweni and Mbuvo. Part of the inundated area will be in Kanyangi locations in Yatta division (Kitui West District). The dam will store the flood flow from the Athi and the seasonal Thwake rivers and provide water supply for multipurpose use.

The environmental complaints and other issues were raised by the communities around the project area in 2019.

- 1. The Ministry through the National Environment Management Authority (NEMA) is aware of the issues raised. NEMA has coordinated other relevant stakeholders to address the issues and is continually doing so since the project is still ongoing.
- THAT the issues raised by the petitioner were brought to the knowledge of the County Environment Committee (CEC) and deliberated accordingly.
- 3. **THAT** in a County Environment Committee meeting held on 3rd September, 2019 deliberated on the issues surrounding Thwake Dam, among them, complaints on blasting of rocks (**Minutes attached**, **Annex I MIN 2: 3/9/2019**) and established a technical committee to visit the site and investigate on the issues raised.
- 4. **THAT** the Technical Committee visited the site on 5th September, 2019 and prepared a report on that course (**Technical Committee Report Attached Annex II**).
- 5. **THAT** the technical committee which visited the site on 5th September, 2019 found that the contractor has acquired all the relevant documentation and also addressed issues of sanitation and safety.

- 6. **THAT** the committee **did not** also establish the cracks in buildings as claimed to have been caused by the blast and vibrations.
- 7. **THAT** another Environment Committee chaired by the County Commissioner was held on 18th September, 2019 and issues affecting workers and the community around the project area were discussed and addressed in the meeting (**Minutes Attached**, **Annex III**).
- 8. THAT on 1st November, 2019 a County Environment Committee meeting was held at Thwake Dam and the Hon. Members of the County Assembly Committee on Environment and Climate Change were invited and participated in the meeting (Minutes Attached, Annex IV).
- 9. **THAT** on 13th March, 2019 NEMA conducted a site inspection on the project site and issued an improvement notice to the proponent to undertake Environmental Audit which will provide more clarity on compliance level to the licensing condition. (Copy attached Annex V).
- 10. THAT the recommendations made by the Technical Committee on its report (Annex II) and the joint meetings held on 1/11/2019 (Annex IV) were not fully implemented due to COVID-19 Public Health Guidelines and Government directive on measures to control the spread of the pandemic and there were no other physical meetings held from December 2019 until 10 November, 2020 when the first CEC meeting for 2020/2021 was held.
- 11. **THAT**, the County Environment Committee, in a meeting held on 10th November, 2020 resolved to make a joint site inspection to monitor the compliance level on the issues jointly agreed with the proponent during the Technical Committee site visit on 5th September, 2019 (Annex II).
- 12. **THAT**, the Ministry through NEMA will continue to closely monitor the implementation of the Environmental Management Plan and compliance to Environmental Impact Assessment license conditions.
- 13. The Ministry will involve relevant lead agencies to ensure the ongoing project is implemented while ensuring sustainable environmental management.

Response by the Cabinet Secretary, Ministry of Water, Sanitation and Irrigation
The Committee met the Cabinet Secretary, Ministry of Water, Sanitation and received the

following submission:

Hon. Chair, Thwake Multipurpose Dam is a National Government Project undertaken by Ministry of Water Sanitation and Irrigation (MWSI) being constructed at confluence of Athi and Thwake rivers in Mavindini Division of Makueni District, Kalawa Division in Mbooni East Sub-County. It is an embankment dam with an approximate maximum height of 80.5M covering an area of around 9,217 acres, with catchment spanning about 10,276 km², spreading into among other locations; Mavindini, Kanthuni, Kitise, Kithuki, Kathonzweni and Mbuvo. Part of the inundated area will be in Kanyangi locations in Yatta Division, Machakos County. The dam will store the flood flow from the Athi and the Thwake rivers and provide water supply for multipurpose use.

The Project is funded by GoK and development partners; and is supervised by an international firm of consulting engineers. The Contractor employed in the works is also an international contractor from China with wide experience in construction of such works. The construction process involves quarrying of rocks through drilling, blasting and transporting the same to the construction points.

Hon. Chair, to respond to the issues raised by the petitioner, I wish to inform the Committee that the Ministry has been aware of the environmental concerns of the community around Thwake Dam construction site since the commencement of construction in March, 2017, and has continuously ensured the implementation of remedial actions in compliance with environmental regulations and guidelines. This particular petition first came before the County Government of Makueni in the year 2019, where the issues raised by the petitioner were brought to the knowledge of the County Environment Committee (CEC) and deliberated accordingly.

At a meeting of the County Environment Committee held on 3rd September, 2019, issues surrounding Thwake Dam, among them, complaints on blasting of rocks were discussed (Minutes attached, Annex I, MIN 2: 3/9/2019) and a Technical Committee formed to visit the Dam site and undertake further investigations. The Technical Committee visited the site on 5th September, 2019 and prepared a report on their findings (*Technical Committee Report Attached Annex II*). Key observations of the report were that the contractor had acquired all environmental licenses and permits necessary for dam construction, cracks in buildings had not been caused by the blasts and vibrations. In addition, they found that issues of sanitation and safety have been adequately addressed.

Hon. Chair, the County Commissioner held an Environment Committee meeting on 18th September, 2019 to discuss issues affecting workers and the community around the project area (*Minutes Attached*, *Annex III*). A follow up meeting, which was attended by the County Assembly Committee on Environment and Climate Change was held at the Dam site on 1st November, 2019 (*Minutes Attached*, *Annex IV*). During the meetings, environmental issues were raised, key among which were lack of access to water, dusty roads, noise pollution, vibrations, blasting without adequate warning (sirens) and falling rock debris after blasting.

The Environment Committee recommended that the project undertake the necessary measures to address the above community concerns and that frequent site visits be conducted to ensure the contractors implement them. Shortage of water in the vicinity of the Dam site was to be addressed by constructing six (6) boreholes, two (2) at Mavindini, two (2) at Mbooni and two (2) at Kalawa Wards.

Towards this end, the Government through the CSR component of the project is implementing all the six (6) boreholes. Dust levels have been controlled by repairing road sections near schools and markets from the site to Kwa-Kamote Junction; approximately 3 km; in addition to watering haulage roads on site. The measured sound levels within 250 to 300 metres of the blast point had been found to be 108.1 dB(A) against a limit of 114 dB(A) in accordance with NEMA guidelines for mines and quarries.

Hon. Chair, Blasting is restricted to daytime hours only in accordance with the blasting license issued by the Government that limits blasting hours between 6am-6pm, while the measured vibration levels obtained from a seismograph installed on site are below the NEMA limit of 0.5 cm/sec. This is safe and is tolerated by nearby humans and animals and cannot damage structures. A baseline survey conducted on 16th December 2020, at UNYEEO area prior to commencing blasting in the quarry near the area, established that many structures have cracks, which could not be directly linked to vibrations and were attributed to improper construction methods leading the defects.

Hon. Chair, to minimize cases of falling debris on houses or even injuring members of the public, blasting sites have been clearly marked with visible tape and warning signs erected to warn people of the danger. Blasting timetable is shared with the community in good time before blasting and commencement of blasting is announced via sirens loud enough to warn every one of the impending blast. Residents very close to the quarries have been relocated to safer areas.

Hon. Chair, NEMA, while on its routine inspection mission, conducted a site inspection on the project on 13th March, 2020 and issued an improvement notice to the proponent to undertake Environmental Audit which will provide more clarity on compliance level to the licensing conditions.

The County Environment Committee, in a meeting held on 10th November, 2020 resolved to make a joint site inspection to monitor the compliance level on the issues jointly agreed with the proponent during the Technical Committee site visit on 5th September, 2019 (Annex II).

The Environmental Audit and the joint site inspection visit would have made very useful tools to verify the level of compliance on the environmental and safety measures, however, the activities are yet to take place due to challenges posed by implementation of COVID-19 Public Health Guidelines and Government directive on measures to control

the spread of the Pandemic.

In conclusion, Hon. Chair, the Government is very keen about the safety of its citizens during implementation of such projects and any deviation from this cardinal obligation is not tolerated and the Ministry of Water, Sanitation and Irrigation will not hesitate to sanction contractors who flout the rules. Further, in order to strengthen the implementation of the environmental and safety measures at Thwake Dam construction site, the project consultants under the guidance of this Ministry have prepared and ensured strict compliance with the Environment Health and Safety protocol on site. At the same time the Ministry, County Environment Committee, NEMA and other stakeholders will continue to closely monitor the implementation of the Environmental Management Plan and compliance to Environmental Impact Assessment license conditions.

Finally, the Ministry has established a Community Liaison position in the project that engages the community to ensure harmonious relations are maintained between the community and the project for smooth implementation.

Site Visit by the Senate Committee on Land, Environment and Natural Resources

The Committee undertook a Site Visit of Thwake Dam on Friday, 28th May, 2021. The Committee was accompanied by Senator Mutula Kilonzo Junior, MP, the Senator for Makueni County. The County Commissioner was also present at the Committees meetings with the residents neighboring Thwake Dam.

On visiting the Site, the Committee was able to visit the places where the contractor admitted to doing the blasts.

Submissions by Residents neighboring Thwake Dam, Makueni County


The Committee was informed as follows;

- Boundaries Demarcation of the boundaries was not clearly done. The residents
 informed the Committee that they needed to be shown the exact beacon boundaries
 and size of the land.
- 2. Rock Blasting The Committee was informed that blasting was being done during the night and has caused damages and cracks to houses, physiological effects to the elderly and ailing residents residing next to the dam and school going children. Residents also raised the matter of dust from the blast affecting them and that considering it was being done at night, it was not visible during the day but the effects of the air pollution was greatly felt. The effects were also experienced in cattle with a lot of still births of calves.

Stones from the blasts hit houses that are far approximately 200M from the site with such an experience recounted by an elderly ailing lady who was at the Site meeting.

- 3. The Committee was also informed that as a result of the blasting, Ammonia gas is released to the air and to the streams nearby causing excessive pollution.
- 4. Corporate Social Responsibility (CSR) The Community residing around the Dam was promised many CSR activities but they have since not received any. Some of these activities include; equipping of schools, a football field, bore holes, maintenance of roads being used by the Contractor and access to water. The only place with water in the area has a very deep gradient and the elderly and animals are unable to fetch water.
- 5. Human Wildlife Conflict The area that the dam is situated in was a wildlife corridor and no buffer zone was created for wildlife and the residents fear that the effects will be felt by the locals with an increase in attacks by wildlife.
- Sanitation The Site workers dont dispose of masks safely despite the wake of the COVID-19 pandemic that is being experienced. School going children pick them and wear them posing a risk to them and the Community.
- 7. **Compensation to injured Workers** Some of the community members who got hurt in the line of duty and were dismissed unfairly and haven't been compensated to date.

CHAPTER 5

COMMITTEE OBSERVATIONS

In accordance with the Prayers of the Petitioner the Committee observes that:

- 1. The Contractor on site confirmed that there is blasting going on at night and will continue for at least two more months.
- 2. The blasting is causing noise pollution and respiratory problems to the residents.
- 3. That National Environmental Management Authority indicated that the contractor on site had acquired all environmental licenses and permits necessary for dam construction. Further, NEMA informed the Committee that cracks in buildings had not been caused by the blasts and vibrations.
- 4. The Cabinet Secretary, Ministry of Water and Sanitation confirmed that blasting is restricted to daytime hours only in accordance with the blasting license issued by the Government that limits blasting hours between 6am-6pm while the measured vibration levels obtained from a seismograph installed on site are below the NEMA limit of 0.5 cm/sec.
- 5. The Committee noted that due to this, the Government through the CSR component of the project is implementing all the six (6) boreholes.
- 6. The Committee while at the site visit collecting views from the public observed that roads leading to the Dam have been severely damaged by the heavy trucks ferrying construction material to and from the Dam Construction site.

CHAPTER 6

COMMITTEE RECOMMENDATIONS

In accordance with the Prayers of the Petitioner the Committee that:

Should it be found that buildings were affected during the construction process, the Contractor be compelled upon to compensate all persons affected.
- 3. That as per the Environmental Management and Co-ordination Act section 108, a restoration order to be issued once National Environment Management Authority (NEMA) ascertains the contractor on site to have caused any environmental damage during the construction process and a copy be sent to Senate within 30 days of tabling the Report in the Senate.

- 4. The contractor on site ensures that they adhere to the Work Injuries and Benefits Act when dealing with all employees injured while on duty. Further, the Committee directs the Ministry of Water, Sanitation & Irrigation to find out whether anyone was hurt during the line of duty and that they are adequately compensated by the Company doing the Construction of the Dam.
- 5. The Committee urges the Ministry of Water, Sanitation and Irrigation to do follow ups and ensure that all the CSR activities promised for the Community is fulfilled.
- 6. NEMA require the Contractor to file Audit Reports on the blasts including and not limited to the level of noise and effects thereof.
- 7. NEMA causes an officer at Makueni County to be present during the blasts at the cost of the Contractor under the Polluter Pays Principle.
- 8. An urgent evaluation be undertaken, to confirm whether the Houses/Residences along the periphery are affected by flying rocks, and urgent acquisition and relocation be done to forestall fatalities or injuries.
- 9. The Ministry of Water, Sanitation and Irrigation should ensure regular maintenance of the roads being used by the Contractor and watering of the earth roads is done continuously to reduce dust pollution. Further, at the end of the project, the Ministry should ensure that all roads that were used in the process are repaired and improved.

Presentation by the Cabinet Secretary, Ministry of Water, Sanitation & Irrigation;

Hon. Chair, Thwake Multipurpose Dam is a National Government Project undertaken by Ministry of Water Sanitation and Irrigation (MWSI) being constructed at confluence of Athi and Thwake rivers in Mavindini Division of Makueni District, Kalawa Division in Mbooni East Sub -County. It is an embankment dam with an approximate maximum height of 80.5 m covering an area of around 9,217 acres, with catchment spanning about 10,276 km², spreading into among other locations; Mavindini, Kanthuni, Kitise, Kithuki, Kathonzweni and Mbuvo. Part of the inundated area will be in Kanyangi locations in Yatta Division, Machakos County. The dam will store the flood flow from the Athi and the Thwake rivers and provide water supply for multipurpose use.

The Project is funded by GoK and development partners; and is supervised by an international firm of consulting engineers. The Contractor employed in the works is also an international contractor from China with wide experience in construction of such works. The construction process involves quarrying of rocks through drilling, blasting and transporting the same to the construction points.

Hon. Chair, to respond to the issues raised by the petitioner, I wish to inform the Committee that the Ministry has been aware of the environmental concerns of the community around Thwake Dam construction site since the commencement of construction in March, 2017, and has continuously ensured the implementation of remedial actions in compliance with environmental regulations and guidelines. This particular petition first came before the County Government of Makueni in the year 2019, where the issues raised by the petitioner were brought to the knowledge of the County Environment Committee (CEC) and deliberated accordingly.

At a meeting of the County Environment Committee held on 3rd September, 2019, issues surrounding Thwake Dam, among them, complaints on blasting of rocks were discussed (*Minutes attached*, *Annex I*, *MIN 2: 3/9/2019*) and a Technical

Committee formed to visit the Dam site and undertake further investigations. The Technical Committee visited the site on 5th September, 2019 and prepared a report on their findings (*Technical Committee Report Attached Annex II*). Key observations of the report were that the contractor had acquired all environmental licenses and permits necessary for dam construction, cracks in buildings had not been caused by the blasts and vibrations. In addition, they found that issues of sanitation and safety have been adequately addressed.

Hon. Chair, the County Commissioner held an Environment Committee meeting on 18th September, 2019 to discuss issues affecting workers and the community around the project area (*Minutes Attached, Annex III*). A follow up meeting, which was attended by the County Assembly Committee on Environment and Climate Change was held at the Dam site on 1st November, 2019 (*Minutes Attached, Annex IV*). During the meetings, environmental issues were raised, key among which were lack of access to water, dusty roads, noise pollution, vibrations, blasting without adequate warning (sirens) and falling rock debris after blasting.

The Environment Committee recommended that the project undertake the necessary measures to address the above community concerns and that frequent site visits be conducted to ensure the contractors implement them. Shortage of water in the vicinity of the Dam site was to be addressed by constructing six (6) boreholes, two (2) at Mavindini, two (2) at Mbooni and two (2) at Kalawa.

Towards this end, the Government through the CSR component of the project is implementing all the six (6) boreholes. Dust levels have been controlled by repairing road sections near schools and markets from the site to Kwa-Kamote Junction; approximately 3 km; in addition to watering haulage roads on site. The measured sound levels within 250 to 300 metres of the blast point has been found to be 108.1 dB(A) against a limit of 114 dB(A) in accordance with NEMA guidelines for mines and quarries.

Hon. Chair; Blasting is restricted to daytime hours only in accordance with the blasting license issued by the Government that limits blasting hours between 6 am-6pm, while the measured vibration levels obtained from a seismograph installed on site are below the NEMA limit of 0.5 cm/sec. This is safe and is tolerated by nearby humans and animals and cannot damage structures. A baseline survey conducted on 16th December 2020, at UNYEEO area prior to commencing blasting in the quarry near the area, established that many structures have cracks, which could not be directly linked to vibrations and were attributed to improper construction methods leading the defects.

Hon. Chair, to minimize cases of falling debris on houses or even injuring members of the public, blasting sites have been clearly marked with visible tape and warning signs erected to warn people of the danger. Blasting timetable is shared with the community in good time before blasting and commencement of blasting is announced via sirens loud enough to warn everyone of the impending blast. Residents very close to the quarries have been relocated to safer areas.

Hon. Chair, NEMA while on its routine inspection mission, conducted a site inspection on the project on 13th March, 2020 and issued an improvement notice to the proponent to undertake Environmental Audit which will provide more clarity on compliance level to the licensing conditions.

The County Environment Committee, in a meeting held on 10th November, 2020 resolved to make a joint site inspection to monitor the compliance level on the issues jointly agreed with the proponent during the Technical Committee site visit on 5th September, 2019 (Annex II).

The Environmental Audit and the joint site inspection visit would have made very useful tools to verify the level of compliance on the environmental and safety measures, however, the activities are yet to take place due to challenges posed by implementation of COVID-19 Public Health Guidelines and Government directive on measures to control the spread of the Pandemic.

In conclusion, Hon. Chair, the Government is very keen about the safety of its citizens during implementation of such projects and any deviation from this cardinal obligation is not tolerated and the Ministry of Water, Sanitation and Irrigation will not hesitate to sanction contractors who flout the rules. Further, in order to strengthen the implementation of the environmental and safety measures at Thwake Dam construction site, the project consultants under the guidance of this Ministry have prepared and ensured strict compliance with the Environment Health and Safety protocol on site. At the same time the Ministry, County Environment Committee, NEMA and other stakeholders will continue to closely monitor the implementation of the Environmental Management Plan and compliance to Environmental Impact Assessment license conditions.

Finally, the Ministry has established a Community Liaison position in the project that engages the community to ensure harmonious relations are maintained between the Community and the project for smooth implementation.

The Committee proceeded to make the following resolutions

- The Committee noted that the Presentation by the Cabinet Secretary, Ministry of Water, Sanitation and Irrigation was an exact replica of what was presented by the Cabinet Secretary, Ministry of Environment and Forestry that was earlier presented to the Committee;
- 2. Conduct a site visit once the COVID-19 containment measures are relaxed; and
- 3. Request for the Noise Licensing and the ESIA Report so as to cross check whether they are in compliance.

MINUTE SEN/SCLENR/122/2021: ANY OTHER BUSINESS

• Sen. Johnes Mwaruma, informed the meeting that in 2018, he had requested for a statement on all projects being undertaken by the Ministry of Water, Sanitation and Irrigation. The Ministry was to get back with a more updated list with clearly projects per County but has since not returned any feedback. Further the CS, at the time assured the Senator that a Kshs. 300,000,000 project was in the Pipeline on Mzima 1, Taita Taveta County and he has since not received an update on the matter.

• The Committee asked the Ministry to share the information that has been raised by Sen. Johnes Mwaruma and a copy of the response shared with his office.

MINISTERIAL RESPONSE BY THE CABINET SECRETARY TO A PETITION BY HON. MEMBERS OF THE MAKUENI COUNTY ASSEMBLY SECTORAL COMMITTEE ON ENVIRONMENT AND CLIMATE CHANGE REGARDING ADVERSE EFFECTS OF ROCK BLASTING AT ONGOING CONSTRUCTION OF THWAKE DAM IN KALAWA AND MAVINDUNI WARDS IN MAKUENI COUNTY.

The Senate Standing Committee on Land, Environment and Natural Resources through letter Ref. No. SEN/DCS/LENR/2/2020/(70) dated 17th November, 2020 by the Clerk of the Senate invited the Cabinet Secretary, Ministry of Environment and Forestry to a meeting to respond to a Public Petition as follows:-

Public Petition

- THAT, pursuant to article 119 (1) of the Constitution of Kenya,
 2010, "Every person has a right to petition Parliament to consider any matter within its authority, including to enact, amend or repeal any legistlation".
- 2. THAT, the County Assembly Committee on Environment and Climate Change (hereinafter the Committee) has concluded the matter of a request for a statement regarding the adverse effects of rock blasting at the ongoing construction of Thwake Multipurpose Dam in Kalawa Ward in Makueni County.

- 3. THAT, the Committee has not been able to conclusively resolve the problem, since the project is funded and implemented by National Government affecting more than one County, hence the resolution to petition the Senate.
- THAT, the construction of the dam involves a number of activities including rock blasting to obtain stones and rocks for construction use.
- 5. THAT, the construction activities at the dam, more so the rock blasting, have brought about a plethora of challenges and adverse impacts on the lives of the residents of the nearby villages.
- THAT, the noise arising from the rock blasting activities have caused house and shops to crack hence weakening the structures and posing danger to the occupants of such structures.
- 7. THAT, flying rocks from blasting site end up hitting roofs of the nearby homesteads a case in point is the house of Mary Mwikali Kyali who her homestead is located barely 200 metres from the site.
- 8. THAT, the affected areas include but not limited to; Ndingi, Syotuvali Market, Kamutonye, Kitoto, Unyeeo, Ngomano, and Syongungi in Kathulumbi Location. Kalawa ward and Kyusyani, Miangeni, Kaseve, Katithi, Miksi and Mathangathi in Mavindini ward.
- 9. THAT, the Committee and the Department of Water, Sanitation, Environment and Climate Change of County Government of Makueni carried out site visits to the project



- and to the areas affected on separate occasions on a fact finding mission.
- 10. THAT, the contractor provided contradicting information from what was gathered during the said site visits by the two independent parties. For instance, the contractor indicated that rock blasting was never done at night and yet in actual sense it was done and the contractor did not have a license for night rock blasting.
- 11. **THAT**, the Committee, the Department of Water, Sanitation, Environment and Climate Change of County Government of Makueni, the project Coordinator, Thwake Multipurpose Dam Project, Community Liaison, (representatives of SMEC Kenya Ltd. the project supervisors) and representative of the people from the two wards, held a consultative meeting at the project site on 1st November, 2019 to deliberate on the matter in which corrective measures to the effects of rock blasting were resolved and given timelines mostly to be undertaken by the contractor and others by the SMEC Community Liaison officer. The latest timeline was set to be 8th November, 2019 which has long passed and no efforts have been shown to effect the resolutions.

1.0 Background

Thwake Multipurpose Dam is a National Government Project undertaken by Tanathi Water Service Board (TAWSB) being constructed at confluence of Athi and Thwake rivers in Mavindini Division of Makueni District, Kalawa divison in Mbooni East Sub-



County, and covering sections of southern part of Yatta division in Lower Yatta Sub-County. It is an embankment dam with an approximate maximum height of 84 m covering an area of approximate 2,000 ha, with a catchment spanning about 10,276km² spreading into among other locations Mavindini, Kanthuni, Kitise, Kithuki, Kathonzweni and Mbuvo. Part of the inundated area will be in Kanyangi locations in Yatta division (Lower Yatta Sub-County). The dam will store the flood flow from the Athi and the seasonal Thwake rivers and provide water supply for multipurpose use.

The environmental complaints and other issues were raised by the communities around the project area in 2019.

Response to the Issues raised by the petitioner

Hon. Chair, I take note of the issues raised by the County Assembly (hereafter the petitioner) and I wish to respond as follows:-

- The Ministry through the National Environment Management Authority (NEMA) is aware of the issues raised. NEMA has coordinated other relevant stakeholders to address the issues and is continually doing so since the project is still ongoing.
- THAT the issues raised by the petitioner were brought to the knowledge of the County Environment Committee (CEC) and deliberated accordingly.
- 3. **THAT** in a County Environment Committee meeting held on 3rd September, 2019 deliberated on the issues surrounding Thwake Dam, among them, complaints on blasting of rocks

(Minutes attached, Annex I MIN 2: 3/9/2019) and established a technical committee to visit the site and investigate on the issues raised

- 4. THAT the Technical Committee visited the site on 5th September, 2019 and prepared a report on that course (Technical Committee Report Attached Annex II).
- 5. THAT the technical committee which visited the site on 5th September found that the contractor has acquired all the relevant documentation and also addressed issues of sanitation and safety.
- THAT the committee did not also establish the cracks in buildings as claimed to have been caused by the blast and vibrations.
- 7. THAT another Environment Committee chaired by the County Commissioner was held on 18th September, 2019 and issues affecting workers and the community around the project area were discussed and addressed in the meeting (Minutes Attached, Annex III).
- 8. **THAT** on 1st November, 2019 a County Environment Committee meeting was held at Thwake Dam and the Hon. Members of the County Assembly Committee on Environment and Climate Change were invited and participated in the meeting (Minutes Attached, Annex IV).
- 9. THAT on 13th March, NEMA conducted a site inspection on the project site and issued an improvement notice to the proponent to undertake Environmental Audit which will provide more clarity on compliance level to the licensing condition. (Copy attached Annex V).



- 10. **THAT** the recommendations made by the Technical Committee on its report (Annex II) and the joint meetings held on 1/11/2019 (Annex IV) were not fully implemented due to COVID-19 Public Health Guidelines and Government directive on measures to control the spread of the pandemic and there were no other physical meetings held from December 2019 until 10 November, 2020 when the first CEC meeting for 2020/2021 was held.
- 11. **THAT**, the County Environment Committee, in a meeting held on 10th November, 2020 resolved to make a joint site inspection to monitor the compliance level on the issues jointly agreed with the proponent during the Technical Committee site visit on 5th September, 2019 (Annex II).
- 12. THAT the Ministry through NEMA will continue to closely monitor the implementation of the Environmental Management Plan and compliance to Environmental Impact Assessment license conditions.
 - 13. The Ministry will involve relevant lead agencies to ensure the ongoing project is implemented while ensuring sustainable environmental management.

Background & Objectives:

Following a County Environment Committee meeting held on 3rd September 2019, a technical committee was formed to carry out inspection on the Environmental Compliance of Thwake Multipurpose Dam and report back the findings by 11th September 2019 to the main committee.

Technical Committee Members are as follows;

The Terms of Reference for the assignment are as follows;

- · To check all Environmental Documents and licenses
- · To establish compliance to relevant legal instruments
- · To evaluate safety measures that have been put in place
- · To evaluate sanitation and Health measures that have been put in place
- To check Environmental impacts and mitigation measures
- Check on the measures put in place to ensure a healthy and safe Environment for workers and people living around the site.

Site visit

The team visited the site Thursday 4th September 2019 and come up with the following findings;

1. Documentation

- The contractor has conducted an Environmental Impact Assessment for blasting activities; NEMA/PR/5/2/19956(PSR/11429) and consequently issued with a license (No; NEMA/EIA/PSL/6858).
- The contractor obtained has obtained Authority to conduct blasting permit from Ministry of Petroleum and Mining.
- · An Effluent Discharge License is available.
- An initial Environmental Audit for the project was prepared and submitted to NEMA (Copies attached)

2. Compliance with Legal framework

a) Environment Management and monitoring Plan

- The proponent does not monitor the level of noxious fumes
- The contractor does not monitor the levels of vibrations
- From the records availed the contractor started monitoring the levels of noise from 24th July 2019 to date. (After the strike)
- Pre blasting conditions survey of structures was conducted for 6 households in Mavindini Ward. A post-assessment will be done after the blasting period to the surrounding household structures to ascertain the destruction by blasting vibrations and if need be compensation will be done. Report attached.
- · Workers around the site have Personal Protective gear
- All affected parties and communities were not consulted during the public participation

b) Blasting License conditions

- The proponent has not adhered to Air quality regulations by not monitoring the level of noxious fumes.
- The contractor is mitigating the dust impacts by watering the site and up to 800m from the barrier.

c) Noise and excessive vibration pollution regulations (2009)

Some household are less than 2 Kilometers from Quarries and designated areas for blasting


3. Environmental Impacts

a) Blasting and Vibrations

- Blasting is conducted at the quarries, spillway, approach and outlet channels, guide hole, dam's toe plate etc.
- The blasting lasts approximately 2 seconds.
- · All blasters at the site are licenced by the Ministry of Mining and Petroleum




- Since January, 2019 they have blasted approximately 500 times covering over 2000 holes.
- The blaster keeps records indicating the amount of explosives used, no of holes and date. The records does not include actual time,
- The blasting noise ranges from 84.6- 112.5 decibels within a distance ranging from 150M and 216M according to blasting records from HSE department dated 24th July 2019 to 4th September 2019.

b) Dust

c) Defects on housing structures




4. Community Awareness

 Two community sensitization forums on impacts of blasting were undertaken for residents of Mavindini ward on 5th December 2018 and 13th December 2019. (Copies of attendance lists attached below)
 The awareness was inadequate.

5. Safety

- No accidents so far have been recorded regarding blasting operations at the site
- The contractor conducts a revolving siren at three different areas (at the gate barrier, the exact place the blasting is been done and bridge 1). From the visit on 11th September by the CEC committee, the siren was not audible from a distance of approximately 800M.
- The blasters at the site, restrict movement of people, machines, animals and vehicles at all entry roads for the period the blasting is taking place.
- All working personnel at the site are restricted to stay away at least 200 metres from the blasting points which is the safe radius.
- The contractor has displayed safety rules at the various places at the site.

6. Sanitation

- The site has approximately 7 blocks of toilets with different compartments and 8 mobile toilets (where it is inconvenient to construct)
- They have provided portable drinking water points at strategic locations.
- The site has resting shades strategically located.
- · The site has dustbins in different locations.
- The site has designated septic tanks in different location for liquid waste management to safeguard that no effluent has been discharged to the river.

Recommendations

• The contractor to map out the vibration levels; the data presented should include; number of people located in the exposed area, number of structures, health facilities, education facilities exposed, vibration level and extent and mitigation measures starting from 9th September 2019.

- The contractor to carry Pre blasting conditions survey of structures within the radius established during mapping and any other area that impacts may be identified and periodic monitoring of structures.
- The contractor to carry out frequent community awareness for all the three wards (Mavindini, Kalawa and Kanyangi) for blasting and any other Environmental issue that may arise starting from 9th September 2019. Share the schedule with Environment Directorate.



- The chair of the meeting then asked the community to talk their grievances The chairman also enquired on issues of compensation for homesteads that were very close to the blasting area.

The community members gave their comments as follows:

- Cracking of their structures due to vibrations.
- Some people very close to the site were not compensated and relocated
- Small children and elderly people running on prescription now doubling their dosage due to effects believed to be associated to the project
- A case of twin children getting amazed and shocked when blasting happens.
- No drinking water was provided still as was promised to the community.
- Siren volume too low to be heard before blasting happens.

MCA Mavindini

The honorable member:

- Thanked and appreciated the contractors for putting Murram in some roads nearby schools.
- Praised the contractor for improving the sanitation conditions for the workers
- Mentioned four nearby schools on the verge of being closed up (mixed pri. Katithi pri. Katithi sec & mumbeni) due to huge cracks developing in their classrooms.

He stressed that there are no political motives behind these complaints but insisted that if the issues are not resolved, The chair mentioned that there were improvements in some issues and there are still some things that need to be done. the politicians will be forced to take all measures to defend their people. The chair then requested the contractor to respond to these allegations by asking the following questions (Q - question by the chair: A – answer by the contractor & SMEC);

Q 1. Whether there is a siren, and if there is any, what coverage does it make?

A. The contractor responded by saying that there is a siren and the coverage is approximately 1.6 kilometers, however, the community members objected to the claim. The contractor then agreed to verify the communities concerns and promised to install sirens with larger volumes from tomorrow. A team was selected to establish if the improvements were implemented or not.

Q 2. Whether blasting is being conducted at night?

A. Tunnel blasting was carried out some times at night which is crucial for the project but there is no permit granted yet for all night blasting activities. The contractor agreed to acquire the permit the soonest possible beginning from Monday.

There were no reported cracks or damages observed in these structures and therefore could not establish the claims of faraway structures cracking from project activities. However, the contractor was advised to do vibration mapping in all areas that are deemed to be affected by the vibration and also sensitize the communities on the objective of the assessment.

MINISTERIAL RESPONSE BY THE CABINET SECRETARY TO A PETITION BY HON. MEMBERS OF THE MAKUENI COUNTY ASSEMBLY SECTORAL COMMITTEE ON ENVIRONMENT AND CLIMATE CHANGE REGARDING ADVERSE EFFECTS OF ROCK BLASTING AT ONGOING CONSTRUCTION OF THWAKE DAM IN KALAWA AND MAVINDINI WARDS IN MAKUENI COUNTY.

The Senate Standing Committee on Land, Environment and Natural Resources through letter Ref. No. SEN/DCS/LENR/2/2021/(16) dated 23rd March, 2021 invited the Cabinet Secretary, Ministry of Water, Sanitation and Irrigation to a meeting to respond to a Public Petition regarding environmental impacts at the construction site of Thwake Dam in Makueni County. The Public Petition is: -

- 1. THAT, pursuant to article 119 (1) of the Constitution of Kenya, 2010, "
 Every person has a right to petition Parliament to consider any matter within its authority, including to enact, amend or repeal any legislation".
- 2. THAT, the County Assembly Committee on Environment and Climate Change (hereinafter the Committee) has concluded the matter of a request for a statement regarding the adverse effects of rock blasting at the

- ongoing construction of Thwake Multipurpose Dam in Kalawa Ward in Makueni County.
- 3. THAT, the Committee has not been able to conclusively resolve the problem, since the project is funded and implemented by National Government affecting more than one County, hence the resolution to petition the Senate.
- 4. THAT, the construction of the dam involves a number of activities including rock blasting to obtain stones and rocks for construction use.
- 5. THAT, the construction activities at the dam, more so the rock blasting, have brought about a plethora of challenges and adverse impacts on the lives of the residents of the nearby villages.
- 6. THAT, the noise arising from the rock blasting activities have caused house and shops to crack hence weakening the structures and posing danger to the occupants of such structures.
- 7. THAT, flying rocks from blasting site end up hitting roofs of the nearby homesteads a case in point is the house of Mary Mwikali Kyali who her homestead is located barely 200 metres from the site.
- 8. THAT, the affected areas include but not limited to; Ndingi, Syotuvali Market, Kamutonye, Kito to, Unyeeo, Ngomano, and Syong un g i in Kathulumbi Location. Kalawa ward and Kyusyani, Miangeni, Kaseve, Katithi, Miksi and Mathangathi in Mavindini ward.
- 9. THAT, the Committee and the Department of Water, Sanitation, Environment and Climate Change of County Government of Makueni

carried out site visits to the project and to the areas affected on separate occasions on a fact-finding mission.

- 10.THAT, the contractor provided contradicting information from what was gathered during the said site visits by the two independent parties. For instance, the contractor indicated that rock blasting was never done at night and yet in actual sense it was done and the contractor did not have a license for night rock blasting.
- 11.THAT, the Committee, the Department of Water, Sanitation, Environment and Climate Change of County Government of Makueni, the project Coordinator, Thwake Multipurpose Dam Project, Community Liaison, (representatives of SMEC Kenya Ltd., the project supervisors) and representative of the people from the two wards, held a consultative meeting at the project site on 1st November, 2019 to deliberate on the matter n which corrective measures to the effects of rock blasting were resolved and given timelines mostly to be undertaken by the contractor and others by the SMEC Community Liaison officer. The latest timeline was set to be 8th November, 2019 which has long passed and no efforts have been shown to effect the resolutions.

Hon. Chair, Thwake Multipurpose Dam is a National Government Project undertaken by Ministry of Water Sanitation and Irrigation (MWSI) being constructed at confluence of Athi and Thwake rivers in Mavindini Division of Makueni District, Kalawa Division in Mbooni East Sub -County. It is an embankment dam with an approximate maximum height of 80.5 m covering an area of around 9,217 acres, with catchment spanning about 10,276 km², spreading into among other locations; Mavindini, Kanthuni, Kitise, Kithuki, Kathonzweni and Mbuvo. Part of the inundated area will be in Kanyangi locations in Yatta

Division, Machakos County. The dam will store the flood flow from the Athi and the Thwake rivers and provide water supply for multipurpose use.

The Project is funded by GoK and development partners; and is supervised by an international firm of consulting engineers. The Contractor employed in the works is also an international contractor from China with wide experience in construction of such works. The construction process involves quarrying of rocks through drilling, blasting and transporting the same to the construction points.

Hon. Chair, to respond to the issues raised by the petitioner, I wish to inform the Committee that the Ministry has been aware of the environmental concerns of the community around Thwake Dam construction site since the commencement of construction in March, 2017, and has continuously ensured the implementation of remedial actions in compliance with environmental regulations and guidelines. This particular petition first came before the County Government of Makueni in the year 2019, where the issues raised by the petitioner were brought to the knowledge of the County Environment Committee (CEC) and deliberated accordingly.

At a meeting of the County Environment Committee held on 3rd September, 2019, issues surrounding Thwake Dam, among them, complaints on blasting of rocks were discussed (*Minutes attached, Annex I, MIN 2: 3/9/2019*) and a Technical Committee formed to visit the Dam site and undertake further investigations. The Technical Committee visited the site on 5th September, 2019 and prepared a report on their findings (*Technical Committee Report Attached Annex II*). Key observations of the report were that the contractor had acquired all environmental licenses and permits necessary for dam construction, cracks in buildings had not been caused by the blasts and vibrations. In addition, they found that issues of sanitation and safety have been adequately addressed.

Hon. Chair, the County Commissioner held an Environment Committee meeting on 18th September, 2019 to discuss issues affecting workers and the community around the project area (*Minutes Attached, Annex III*). A follow up meeting, which was attended by the County Assembly Committee on Environment and Climate Change was held at the Dam site on 1st November, 2019 (*Minutes Attached, Annex IV*). During the meetings, environmental issues were raised, key among which were lack of access to water, dusty roads, noise pollution, vibrations, blasting without adequate warning (sirens) and falling rock debris after blasting.

The Environment Committee recommended that the project undertake the necessary measures to address the above community concerns and that frequent site visits be conducted to ensure the contractors implement them. Shortage of water in the vicinity of the Dam site was to be addressed by constructing six (6) boreholes, two (2) at Mavindini, two (2) at Mbooni and two (2) at Kalawa.

Towards this end, the Government through the CSR component of the project is implementing all the six (6) boreholes. Dust levels have been controlled by repairing road sections near schools and markets from the site to Kwa-Kamote Junction; approximately 3 km; in addition to watering haulage roads on site. The measured sound levels within 250 to 300 metres of the blast point has been found to be 108.1 dB(A) against a limit of 114 dB(A) in accordance with NEMA guidelines for mines and quarries.

Hon. Chair; Blasting is restricted to daytime hours only in accordance with the blasting license issued by the Government that limits blasting hours between 6 am-6pm, while the measured vibration levels obtained from a seismograph installed on site are below the NEMA limit of 0.5 cm/sec. This is safe and is tolerated by nearby humans and animals and cannot damage structures. A baseline survey conducted on 16th December 2020, at UNYEEO area prior to commencing

blasting in the quarry near the area, established that many structures have cracks, which could not be directly linked to vibrations and were attributed to improper construction methods leading the defects.

Hon. Chair, to minimize cases of falling debris on houses or even injuring members of the public, blasting sites have been clearly marked with visible tape and warning signs erected to warn people of the danger. Blasting timetable is shared with the community in good time before blasting and commencement of blasting is announced via sirens loud enough to warn everyone of the impending blast. Residents very close to the quarries have been relocated to safer areas.

Hon. Chair, NEMA while on its routine inspection mission, conducted a site inspection on the project on 13th March, 2020 and issued an improvement notice to the proponent to undertake Environmental Audit which will provide more clarity on compliance level to the licensing conditions.

The County Environment Committee, in a meeting held on 10th November, 2020 resolved to make a joint site inspection to monitor the compliance level on the issues jointly agreed with the proponent during the Technical Committee site visit on 5th September, 2019 (Annex II).

The Environmental Audit and the joint site inspection visit would have made very useful tools to verify the level of compliance on the environmental and safety measures, however, the activities are yet to take place due to challenges posed by implementation of COVID-19 Public Health Guidelines and Government directive on measures to control the spread of the Pandemic.

In conclusion, Hon. Chair, the Government is very keen about the safety of its citizens during implementation of such projects and any deviation from this cardinal obligation is not tolerated and the Ministry of Water, Sanitation and

Irrigation will not hesitate to sanction contractors who flout the rules. Further, in order to strengthen the implementation of the environmental and safety measures at Thwake Dam construction site, the project consultants under the guidance of this Ministry have prepared and ensured strict compliance with the Environment Health and Safety protocol on site. At the same time the Ministry, County Environment Committee, NEMA and other stakeholders will continue to closely monitor the implementation of the Environmental Management Plan and compliance to Environmental Impact Assessment license conditions.

Finally, the Ministry has established a Community Liaison position in the project that engages the community to ensure harmonious relations are maintained between the Community and the project for smooth implementation.
