RE: PETITION TO THE SENATE CONCERNING FALURE BY THE MANAGING DIRECTOR OF KENYA BREWERIES LIMITED, COMPANY SECRETARY, KAPLAN & 1/2 STRATTON ADVOCATES AND HARRISON KINYANJUL ADVOCATES TO PAY COMPENSATION TO LAWRENCE NDUTTU & 125 OTHERS AWARDED LAWRENCE NDUTTU & 6000 OTHERS VS KENYA BREWERIES & ANOTHER HEECLAST OF 2023

We, the undersigned.

Citizens of the Republic of Kenya, former employees of Kenya Breweries Limit Nairobi County.

RECEIVED

Draw the attention of the Senate to the following: -

- THAT, we were dismissed from employment in violation of the memorandum of agreement we signed with the company.
- THAT, we filed a petition in court in 2003, referred to as Lawrence Nduttu & 125 Others Vs. Kenya Breweries Limited & Another (HCCC, 279 of 2003)
- THAT, we submit this petition on behalf of 125 individuals represented by the law firm Harrisson Kinyanjui & Co. Advocates in the aforementioned case.
- 4. THAT, Lawrence Nduttu, along with 6,000 others, filed a representative suit on behalf of former employees of Kenya Breweries Ltd whose terms and conditions of employment were governed by a memorandum of agreement dated 5th December, 1997, and 29th July, 1999. Their contracts were impacted by the company's re-engineering process that began in 1994.
- THAT, the claimants, Lawrence Nduttu and 6,000 others, were represented by three law firms:
   J. Harrison Kinyanjui & Company Advocates, Namada & Company Advocates, and O.P. Ngoge & Company Advocates.
- THAT, on 24th January, 2018, Hon Justice Sergon delivered a judgment in favour of Lawrence Nduttu and 6000 other people. The judgement stated as follows:
  - The decision to cause the plaintiffs to take early retirement was unlawful and in breach of the constitution and the plaintiff's agreement of employment.
  - b. The defendant pays each of the plaintiffs damages for loss of employment amounting to one (1) month's salary as at the time of termination of employment.

& Company Advocates forwarded a signed consent to Kaplan & Stratton Advocates without the petitioners' authority or knowledge.

- 13. THAT, K.B.L, Kaplan & Stratton and Harrison Kinyanjui Advocates have failed to pay interest up to 31th January 2022 of 4,350,771.35 as awarded by the Court but instead paid up to November and damages for loss of employment a sum equivalent to one (1) month's salary as at the time of termination of employment as awarded by the Court
- 14. THAT, we have made efforts to have the matter addressed by the Advocates Complaints Commission but the response was unsatisfactory.
- 15. THAT, none of the issues raised in this petition is pending in any court of law, constitutional, or any other legal body.

## WHEREFORE, your humble petitioners pray that the Senate-

- Investigates the matter with a view to recommending that the outstanding dues for the Petitioners
  are settled; and
- Investigates the matter, address and make recommendation on actions of commission or omission on the part of the advocates for the Petitioners.
