WHEREAS, the Kenya National Council for Population and Development Bill (National Assembly Bill No. 72 of 2023) was published vide Kenya Gazette Supplement No. 227 of 24<sup>th</sup> November 2023 as a Bill seeking to provide for the establishment, roles and functions of the Kenya National Council for Population and Development, and for the establishment of the Board of the Council and other connected purposes;

AND WHEREAS, the National Assembly considered the said Bill and passed it with amendments on Thursday, 19th June 2025, in the form attached hereto;

NOW THEREFORE, in accordance with the provisions of Article 110(4) of the Constitution and Standing Order 142 of the National Assembly Standing Orders, I hereby refer the Bill to the Senate for consideration."

WHEREAS, the Culture Bill (National Assembly Bill No. 12 of 2024) was published vide Kenya Gazette Supplement No.49 of 5<sup>th</sup> March 2024 as a Bill seeking to give effect to Article 11(3)(a) of the Constitution, to provide for the protection and promotion of culture and the cultural heritage of communities;

AND WHEREAS, the National Assembly considered the said Bill and passed it with amendments on Thursday, 12th June 2025, in the form attached hereto;

NOW THEREFORE, in accordance with the provisions of Article 110(4) of the Constitution and Standing Orders 41(1) and 142 of the National Assembly Standing Orders, I hereby refer the Bill to the Senate for consideration."

Honourable Senators,

Pursuant to Standing Order No. 163 which requires that a Bill which originates in the National Assembly be proceeded with by the Senate in the same manner as a Bill introduced in the Senate by way of First Reading in accordance with Standing Order No.144; I direct that the Culture Bill (National Assembly Bill No. 12 of 2024) be Read a First-time on Tuesday, 15th July, 2025.

## iii) Resolution of the County Assembly of Kiambu on conferment of city status to Thika Municipality

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 48 (3), I received a Message from the Clerk of the County Assembly of Kiambu.

The Message, dated 24<sup>th</sup> June, 2025, transmits a resolution of the County Assembly of Kiambu to the effect that –

The County Assembly of Kiambu, taking into consideration the recommendations of the County Assembly Sectoral Committee on County

Planning and Urbanization in its Report on the proposed conferment of City Status to Thika Municipality in Kiambu County, laid on the table of the County Assembly on Thursday, 19<sup>th</sup> June, 2025, and pursuant to the provisions of Section 8(4) of the Urban Areas and Cities Act, 2011, resolved to confer the status of a city to Thika Municipality in Kiambu County.

Honourable Senators,

The following documents were annexed to the letter transmitting the resolution of the County Assembly:

- i) The Order Paper for the County Assembly of Kiambu special sitting of Thursday, 19<sup>th</sup> June, 2025 at 9.00 am;
- ii) The Hansard Report for the County Assembly special sitting; and
- iii) The Report of the County Assembly of Kiambu Sectoral Committee on County Planning and Urbanization on conferment of City Status to Thika Municipality.

Further, vide a letter reference *CAK/1/19/10 Vol. 2(15)* dated 3<sup>rd</sup> July, 2025, the Clerk of the County Assembly also forwarded to the Clerk of the Senate, the Report of the *Ad-Hoc* Committee constituted by the Governor of Kiambu County to consider the Application by the board of the Thika Municipality for Conferment of City Status to the municipality.

Honourable Senators,

Section 8 (6) of the Urban Areas and Cities Act (Cap. 275) provides that -

- "(1) The board of a municipality may, upon a resolution, apply to the county executive committee for consideration for the conferment of city status.
- (2) Where the executive committee approves the application, the county governor shall constitute an ad hoc committee to consider the recommendation and advise as appropriate.
- (3) The ad hoc committee shall comprise of relevant professionals in good standing nominated by the following institutions taking account of regional, ethnic and gender diversity and representation of persons with disability—
  - (a) the Institution of Surveyors of Kenya;
  - (b) the Kenya Institute of Planners;
  - (c) the Architectural Association of Kenya;
  - (d) the Law Society of Kenya;
  - (e) an association of urban areas and cities;
  - (f) the Institute of Certified Public Accountants of Kenya; and
  - (g) the business community.
- (4) Where the ad hoc committee under subsection (2) determines that the municipality under review meets the requisite criteria for classification as a city, the county governor shall transmit the recommendation to the county assembly for approval.

- (5) Where the county assembly approves the recommendation for conferment of city status to a municipality under this section, the clerk of the county assembly shall transmit the resolution to the Senate for consideration.
- (6) Where the Senate approves the recommendation, the clerk of the Senate shall forward the resolution to the President for conferment of city status on the municipality."

Honourable Senators,

In order to facilitate the Senate in its consideration of the conferment of city status to Thika Municipality as contemplated in Section 8 (5) of the Urban Areas and Cities Act (Cap. 275), I forthwith refer the Message to the Standing Committee on Devolution and Intergovernmental Relations for consideration, pursuant to Standing Order 48 (7)(c). I also direct that the Committee expedites its consideration of this matter and tables its report for consideration by the Senate.

### 7. QUESTIONS AND STATEMENTS

### a) Statements pursuant to Standing Order 52(1)

i) Nominated Senator (Sen. Hamida Kibwana, MP) made a Statement concerning allegations of misconduct involving Mr. Peter Ayiro, a senior teacher and long-serving Christian Union patron at Alliance Girls High School.

In the Statement, the Senator highlighted disturbing claims from over two dozen former students and teachers who accused Mr. Ayiro of grooming, emotional manipulation, and inappropriate conduct spanning more than two decades. These incidents were said to have occurred within the school enabled by his spiritual authority, unchecked influence and a culture of institutional silence.

The Senator expressed deep concern over the systemic issues exposed by the case, noting that girls' boarding schools, meant to be safe spaces for education and character development, had instead become environments where abuse could persist unnoticed or unchallenged.

The Senator concluded by emphasizing the responsibility of leaders to ensure that accountability mechanisms were effectively enforced and called upon the Senate to lead the charge in demanding transparency, justice and the establishment of a national safeguarding framework that puts the welfare of students above all else.

ii) Nominated Senator (Sen. (Prof.) Margaret Kamar, EGH, MP) made a Statement on the recently concluded Continental Consultation on the Draft Model Law on Labour Migration in Africa, held from 16<sup>th</sup> to 18<sup>th</sup> June, 2025 in Nairobi.

In the Statement, the Senator highlighted that the forum had brought together lawmakers, government officials, international partners, and civil society to review a harmonised legal framework designed to help African Union (AU) Member States manage labour migration in a coordinated and rights-based manner.

The Senator explained that the Model Law, developed over two years, aimed to guide Member States in aligning national legislation, safeguarding migrant workers' rights, promoting fair recruitment, supporting gender-responsive policies, and adhering to international labour standards. She informed the Senate that Kenya was represented by Senator Danson Mungatana, who in his submission, emphasized the importance of legal protections and the economic potential of migration.

In conclusion, Sen. (Prof.) Kamar called on the Standing Committee on Labour and Social Welfare to prioritize the Labour Migration and Management (No. 2) Bill (Senate Bills No. 42 of 2024), which aligns with the

Model Law. She urged the Committee to consider incorporation of key recommendations from the consultation to enhance Kenya's labour migration governance and better protect migrant workers.
