5. <u>NOTICE OF MOTION - APPROVAL OF SITTINGS OF THE SENATE TO BE</u> <u>HELD IN BUSIA COUNTY</u>

(Sen. Wafula Wakoli, MP on behalf of the Senate Majority Leader)

THAT, AWARE that the Senate of Kenya is established under Article 93 of the Constitution and its main role, as set out at Article 96 is to represent, serve and protect the interests of the counties and their governments;

FURTHER AWARE of the critical role that the Senate plays in the interlinkage between the National and County levels of government, and the need to enhance the interaction between the Senate and county governments, as a means of bringing the Senate closer to the counties and the general public;

ACKNOWLEDGING the successes made during the sittings of the Senate outside Nairobi held in Uasin Gishu, Kitui and Turkana Counties in September, 2018, 2019 and 2023, respectively;

FURTHER ACKNOWLEDGING the recommendation of the Senate Business Committee that a sitting of the Senate be held away from the traditional premises in Parliament Buildings, Nairobi, during the term of the 13th Parliament; and the subsequent resolution of the Senate made on 8th March, 2023, to hold plenary and committee sittings in the counties for a one-week period within the month of September in every Session of the 4th Senate, except during an election year with the objective to: -

- 1) promote the role and work of the Senate and enhance public awareness regarding the Business of the Senate and Parliament in general;
- 2) highlight existing and new opportunities for engagement in the legislative process;
- 3) develop and strengthen partnerships at the county level of government; and
- 4) provide an opportunity to members and staff of county assemblies to learn and share best practices with Senators and parliamentary officers;

NOW, THEREFORE, pursuant to Article 126 (1) of the Constitution, the Senate resolves to hold its Plenary and Committee sittings in Busia County, from 6^{th} to 10^{th} October 2025.

6. NOTICE OF MOTION - REPORT OF THE 67TH COMMONWEALTH PARLIAMENTARY ASSOCIATION (CPA) CONFERENCE HELD IN SYDNEY, AUSTRALIA ON 3RD TO 8TH NOVEMBER, 2024

(Sen. Jackson Mandago, MP)

THAT, the Senate notes the Report of the 67th Commonwealth Parliamentary Association (CPA) Conference held in Sydney, Australia on 3rd to 8th November, 2024, laid on the Table of the Senate on Tuesday, 22nd July, 2025.

7. QUESTIONS AND STATEMENTS

a) Statements pursuant to Standing Order 52 (1)

i) The Senator for Mombasa County (Sen. Mohammed Faki, MP) made a Statement regarding the celebration of World Snake Day. He emphasized

the vital yet often misunderstood role snakes play in maintaining ecological balance. The Senator highlighted this year's theme, *"Respect, Do Not Fear: Protecting Nature's Silent Guardians,"* as a call to challenge misconceptions and promote peaceful coexistence. The Senator noted that fear, myths, and habitat destruction frequently lead to the unnecessary killing of snakes, despite their benefits in pest control and biodiversity preservation.

The Senator urged greater public education and awareness, particularly within local communities. He also raised concerns about limited awareness of the Government's snake-bite compensation scheme and the widespread shortage of anti-snake venom in health facilities. The Senator called on all Kenyans to respect and protect snakes as essential allies in conservation.

ii) Nominated Senator (Sen. Esther Okenyuri, MP) made a Statement concerning the demise and enduring legacy of the Late Hon. Catherine Nyamato, MP, who died on 16th July 2025. Hon. Nyamato, a former Member of Parliament from Nyamira County, was the first woman MP from the Gusii community and served from 1997 to 2002 under the Kenya National Union Party (KANU).

The Senator described the late Nyamato as a fearless, principled, and humble leader who commanded respect across political lines. The Senator also highlighted her role as Chairperson of Maendeleo ya Wanawake Organisation, where she championed women's rights, fought against harmful cultural practices such as FGM, and advocated for gender equality and women's leadership. In addition, she founded the Nyamato Foundation to support transformative community programmes. Senator Okenyuri expressed heartfelt condolences to her family, the people of Nyamira County, and the nation, and honoured her enduring legacy.

iii) The Senator for Nandi County (Sen. Samson Cherarkey, MP) made a Statement regarding the Kaptagat Integrated Conservation Programme, praising it as a visionary environmental initiative led by Dr. Chris Kiptoo, Principal Secretary of the National Treasury.

The Senator noted that the programme aligns with Kenya's climate goals of planting 15 billion trees by 2032 and increasing forest cover to 30 percent. He highlighted the 9th edition of the initiative, held on 12th July 2025 in Elgeyo Marakwet County, which was attended by President William Ruto and featured tree planting, cycling, and community-led activities. The Senator reported that the President announced plans to fence off Kaptagat Forest and distribute avocado and coffee seedlings to improve local livelihoods, while emphasizing community participation in forest management. He commended Dr. Kiptoo's longstanding leadership and the programme's national and international recognition for effectively linking environmental conservation with economic empowerment. Senator Cherarkey concluded by urging all leaders and citizens to emulate these efforts in safeguarding Kenya's natural heritage for future generations.
