## 7. QUESTIONS AND STATEMENTS

#### a) Statement pursuant to Standing Order 52 (1)

The Senator for Garissa County (Sen. Abdul Haji, MP) made a Statement regarding the outstanding performances by Faith Kipyegon and Beatrice Chebet at the Eugene Diamond League 2025, Prefontaine Classic held on 5<sup>th</sup> July 2025 in Eugene, Oregon, USA.

Thereupon, the Senator pointed out that, during the Eugene Diamond League, held on 5<sup>th</sup> July, 2025, in Eugene, Oregon, USA, Faith Kipyegon delivered a phenomenal performance in the Women's 1500 metres, clocking an astonishing time of 3 minutes, 48.68 seconds. This feat broke her previous world record of 3:49.04, set at the Paris Diamond League in July 2023, by 0.36 seconds.

The Senator also stated that on the same evening, Beatrice Chebet demonstrated exceptional brilliance and tactical mastery by winning the Women's 5000 metres and making history by becoming the first woman ever to run the 5000 metres in under 14 minutes, setting a new world record of 13:58.06. This achievement surpassed the previous record, held by Ethiopia's Gudaf Tsegay since the year 2022, by more than two seconds.

The Senator congratulated Faith Kipyegon and Beatrice Chebet for their incredible victories.
