WEDNESDAY, JULY 23, 2025 (AFTERNOON SITTING)

- 1. The Senate assembled at thirty Minutes past Two O'clock.
- 2. The proceedings were opened with Prayer said by the Speaker.

3. **QUORUM OF THE SENATE**

The Speaker, having counted the Honourable Senators present at the commencement of the Sitting and confirming that there was no Quorum, directed that the Bell be rung for ten minutes, pursuant to Standing Order 40;

And there being a Quorum before the expiry of the ten minutes;

The Speaker invited the Clerk to call the Orders of the day.

4. COMMUNICATIONS FROM THE CHAIR ON THE CONSIDERATION OF THE PRESIDENTIAL RESERVATIONS TO THE CONFLICT OF INTEREST BILL (NATIONAL ASSEMBLY BILL NO. 12 OF 2023

The Speaker conveyed the following Communication from the Chair:

"Honourable Senators,

Before we proceed to the next order, I have a communication to make on disposal of His Excellency the President's Memoranda on the Conflict of Interest Bill (National Assembly Bills No. 12 of 2023).

As you are aware, the Conflict of Interest Bill (National Assembly Bills No. 12 of 2023) was published vide Kenya Gazette Supplement No. 41 of 2023 as a Bill seeking to provide for the management and regulation of conflict of interest in the discharge of official duties. The National Assembly passed the Bill on 6th December, 2023 and referred it to the Senate for consideration. The Bill was read a First Time in the Senate on 14th February, 2024 and subsequently passed with amendments on 16th May, 2024 and referred back to the National Assembly.

The National Assembly did not concur with the Senate amendments to the Bill and voted to reject the said amendments on 24th July, 2024. The Bill was subsequently referred to a Mediation Committee in accordance with Article 113 of the Constitution and the Standing Orders of the Houses of Parliament. The report of the Mediation Committee was tabled in the National Assembly and the Senate on 5th December, 2024. The National Assembly approved the mediated version of the Bill on 5th December, 2024 while the Senate approved the mediated version of the Bill on 8th April, 2025. Following the approval of the mediated version of the Bill by the Houses of Parliament, the Bill was presented to His Excellency the President for assent.

Honourable Senators,

On 30th April, 2025, His Excellency the President referred the Conflict of Interest Bill (National Assembly Bills No. 12 of 2023) back to Parliament for reconsideration in accordance with the provisions of Article 115 of the Constitution. On 6th May, 2025, I conveyed a Message to the Senate from the President on the Memorandum and committed the matter to the Standing Committee on Justice, Legal Affairs and Human Rights for consideration.

Similar procedures, in accordance with the relevant Standing Orders, were being followed in the National Assembly. Consequently, the National Assembly considered the President's reservations and passed the Bill fully accommodating the President's reservations on Tuesday, $3^{\rm rd}$ June, 2025. By way of Message, I communicated this decision of the National Assembly to the assembled Senate on $5^{\rm th}$ June, 2025.

On the part of the Senate, the Standing Committee on Justice, Legal Affairs and Human Rights tabled its report on the President's reservations on 12th June, 2025. At the sittings of the Senate held on Wednesday, 9th and on Thursday, 10th July, 2025, the Senate through the Committee of the Whole considered the President's reservations. In accordance with established procedure in a Committee of the Whole, the Chairperson of the Committee deferred the putting of the Questions to a later date. Upon resumption of interrupted debate on the President's reservations, the Questions will be put as indicated in today's Order Paper at Order No. 10.

Honourable Senators,

This is not the first time that the Senate is considering the President's reservations on a Bill. On 16th December, 2015, the Senate considered the President's reservations to the Public Audit Bill, (National Assembly Bill No. 38 of 2014) and the Public Procurement and Asset Disposal Bill (National Assembly Bill No. 40 of 2014). However, it is imperative that I guide the Senate on the procedure for disposal of the President's reservations at the time of voting.

In a communication issued on 1st October, 2015, the then Speaker, Sen. Ekwee Ethuro, observed that Article 115 of the Constitution requires that each House

of Parliament specifically pronounces itself on the President's reservations by either accepting or rejecting the reservations. He stated that, "there is no room for deeming of either an acceptance or a rejection. A specific resolution must be made by the Senate." Consequently, in considering the Motion on the President's reservations on the Conflict of Interest Bill (National Assembly Bills No. 12 of 2023), the Senate may-

- i. Pursuant to Article 115(2) of the Constitution, amend the Bill in light of the President's reservations or amend the Bill in a manner that fully accommodates the President's reservations. This would require the vote of a majority of the Delegations in the Senate, which is twenty-four delegations; or
- ii. Pursuant to Article 115(4) of the Constitution, pass the Bill a second time, without amendment, or with amendments that do not fully accommodate the President's reservations. This would require the vote of two-thirds of the delegations in the Senate, which is thirty-two delegations.

From the foregoing, the only action that would take the agenda forward is either an acceptance or a rejection of the President's reservations by the requisite numbers. For the avoidance of doubt, the Committee of the Whole will vote on each reservation. It would appear that any other action that does not result in an outright acceptance or rejection of the President's reservations would put the Bill in a position of uncertainty to which former Speaker Ethuro referred to as "Constitutional Purgatory".

I refer Honourable Senators to Standing Order 170 (5) which gives a window to the Speaker to direct a further vote to be taken on the Question within five (5) sitting days "whenever a question to approve or reject the President's reservations fails to obtain the required majority and the vote results in a majority of the "Ayes" but the "Noes" have not numbered at least one third of all the Senators". However, Standing Order 170 (6) states that "If the Speaker does not direct a further vote under paragraph (5) or if on such further vote the fixed majority is not obtained, (to either reject or approve), the Speaker shall declare that the Motion is negatived."

The Senate is accordingly guided."

6. NOTICE OF MOTION - PROVISION OF IFMIS REPORTS FOR COUNTY GOVERNMENTS TO THE SENATE

(Sen. Andrew Omtatah Okoiti, MP)

THAT, AWARE that, Article 96 of the Constitution provides that the Senate represents the counties, and serves to protect their interests, determines the allocation of national revenue among counties, as provided in Article 217, and exercises oversight over national revenue allocated to the County Governments;

FURTHER AWARE THAT, in the case of The Senate, the Council of Governors and 6 others Petition No. 24 and 27 of 2029 (consolidated) 2022 KESC No. 57(KLR), the Supreme Court affirmed that the Senate's oversight authority extents to both nationally allocated and locally generated revenue;

CONCERNED THAT, that Senators are constrained by lack of access to real time to data from the IFMIS system for the respective counties they represent, thus affecting effective oversight of County Governments;

FURTHER CONCERNED THAT, in some instances data and information presented to the Senate by the Auditor-General and the Controller of Budget are received and considered late as a result of the backlog resulting into too much information not getting properly reviewed by Senators;

NOTING THAT, as a result of unchecked financial information and systems, County Governments have continued to accumulate pending bills resulting from unplanned expenditures, unaccounted for and inflated cost of projects;

NOW THEREFORE, the Senate resolves, that the Cabinet Secretary in charge of the National Treasury shall on a monthly basis forward to the Clerk of the Senate all IFMIS transactions and reports for each County Government for onward transmission to the respective Senator for information on accountability and transparency, in order to strengthen their constitutional oversight and promote good governance in the management of public finances.

7. QUESTIONS AND STATEMENTS

a) Statement pursuant to Standing Order 52 (1)

Nominated Senator (Sen. Veronica Maina, MP) made a Statement regarding the life, service and enduring legacy of the late Hon. (Dr.) Phoebe Muga Asiyo, MP.

The Senator started by paying tribute to the late Hon. Dr. Phoebe Muga Asiyo, who passed away on 16th July 2025. She described Dr. Asiyo as a trailblazer in Kenya's academic, diplomatic, and political spheres, and a leading advocate for women's empowerment, gender equality, and social justice.

The Senator noted that Dr. Asiyo began her career in education and community service before joining the Maendeleo Ya Wanawake Organisation

(MYWO), where she rose to become Chairperson. She highlighted Dr. Asiyo's historic appointment in 1963 as the first African woman Senior Superintendent of Women's Prisons in Kenya and her later election as Member of Parliament for Karachuonyo Constituency in 1980 and again in 1992.

She recalled Dr. Asiyo's introduction of a groundbreaking Affirmative Action Motion in 1997 and her efforts to promote constitutional reforms to increase women's representation in leadership. The Senator also mentioned her advocacy for girls' education and her work with international organizations such as UNIFEM.

In addition, the Senator stated that Dr. Asiyo played a critical role in the constitutional review process as a commissioner and participated in regional peace initiatives. She praised her continued mentorship of women leaders and her recognition as the first woman to be named a Luo elder.

In conclusion, she reiterated that Dr. Asiyo would be remembered as the original voice behind the two-thirds gender rule in the Constitution, and that her legacy would endure through the many women she mentored. On behalf of the Kenya Women Senators Association (KEWOSA), the Senator conveyed heartfelt condolences to her family and all women leaders.
