- 1. The Senate assembled at thirty Minutes past Two O'clock.
- 2. The proceedings were opened with Prayer said by the Temporary Speaker (Sen. Wakili Hillary Sigei, MP).

3. QUORUM OF THE SENATE

The Temporary Speaker (Sen. Wakili Hillary Sigei, MP), having counted the Honourable Senators present at the commencement of the Sitting and confirming that there was no Quorum, directed that the Bell be rung for ten minutes, pursuant to Standing Order 40;

And there being a Quorum before the expiry of the ten minutes;

The Temporary Speaker (Sen. Wakili Hillary Sigei, MP) invited the Clerk to call the Orders of the day.

4. COMMUNICATION FROM THE CHAIR - VISITING DELEGATION FROM THE BUNGE MASHINANI SCHOOL OF GOVERNANCE

The Temporary Speaker (Sen. Wakili Hillary Sigei, MP) conveyed the following Communication from the Chair:

"Honourable Senators,

i. Passage by the National Assembly, of the County Public Finance Laws (Amendment) Bill (Senate Bills No. 39 of 2023)

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 46 (3), I received a Message from the Speaker of the National Assembly regarding the passage by the National Assembly, of the County Public Finance Laws (Amendment) Bill (Senate Bills No. 39 of 2023).

The Message, dated Thursday, 31st July, 2025, was received in the Office of the Clerk of the Senate on Friday, 1st August, 2025.

Pursuant to Standing Order 46 (4), I now report the Message -

"PURSUANT to the provisions of Standing Order 41 (1) and 144 of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly –

WHEREAS, the County Public Finance Laws (Amendment) Bill (Senate Bills No. 39 of 2023), was passed by the Senate on Tuesday, 15th April, 2025 and referred to the National Assembly for consideration, pursuant to the provisions of Article 110 (4) of the Constitution;

AND WHEREAS, the National Assembly considered the said Bill and passed it <u>without amendments</u> on Tuesday, 29th July, 2025 in the form passed by the Senate;

NOW THEREFORE, in accordance with the provisions of Article 110 of the Constitution and Standing Orders 41 (1) and 144 of the National Assembly Standing Orders, I hereby convey the said decision of the National Assembly to the Senate."

Honourable Senators,

Article 110 (5) of the Constitution provides that, once a Bill concerning counties has been passed by both Houses in the same form, the Speaker of the House in which the Bill originated shall refer the Bill to the President for assent.

Accordingly, I am in the process of referring the County Public Finance Laws (Amendment) Bill (Senate Bills No. 39 of 2023) to His Excellency the President for assent.

I thank you."

ii. Passage by the National Assembly, of the Equalisation Fund Appropriation Bill (National Assembly Bills No. 21 of 2025)

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 46 (3), I received a Message from the Speaker of the National Assembly regarding the passage by the National Assembly, of the Equalisation Fund Appropriation Bill (National Assembly Bills No. 21 of 2025).

The Message, dated Thursday, 31st July, 2025, was received in the Office of the Clerk of the Senate on Friday, 1st August, 2025.

Pursuant to Standing Order 46 (4), I now report the Message -

"PURSUANT to the provisions of Standing Order 41 (1) and 142 of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly –

WHEREAS, the Equalization Fund Appropriation Bill (National Assembly Bills No. 21 of 2025) was published vide Kenya Gazette Supplement No. 80 of 12th June, 2025 as a Bill for an Act of Parliament to authorize the issue of a sum of money out of the Equalization Fund and its application towards the service of the year ending 30th June, 2026; to appropriate that sum for certain public basic services; and for connected purposes;

AND WHEREAS, the National Assembly considered the Bill and passed it <u>with amendments</u> on Wednesday, 30th July 2025;

AND WHEREAS, the Bill concerns county governments in terms of Article 110 (1)(a) of the Constitution as it contains provisions affecting the powers and functions of county governments as set out in the Fourth Schedule to the Constitution;

NOW THEREFORE, in accordance with provisions of Article 110 of the Constitution and Standing Orders 41 (1) and 142 of the National Assembly Standing Orders, I hereby refer the Equalisation Fund Appropriation Bill (National Assembly Bills No. 21 of 2025) to the Senate for consideration."

Honourable Senators,

As you are aware, on Tuesday, 22nd July, 2025, the Senate passed the Equalisation Fund Appropriation Bill (Senate Bills No. 7 of 2025). The Bill which seeks to authorise the withdrawal of funds from the Equalisation Fund and their application towards the provision of public basic services for the financial year ending 30th June, 2026, and for connected purposes, was subsequently transmitted to the National Assembly on Wednesday, 30th July, 2025.

In view of the similarities in the provisions of the two Bills, I hereby refer the Bill to the Standing Committee on Finance and Budget to advise the House on the appropriate way forward.

The House is accordingly guided.

The Report contains various findings and recommendations on cell, tissue and organ transplant services and one key recommendation is the need for complete regulatory reforms on the organ transplantation program.

Consequently, and upon the tabling of this document in the Senate, I hereby direct that the Report be committed to the Standing Committee on Health for consideration. The Committee will be required to consider the Report and table a report containing its recommendations.
