4. QUORUM AT COMMENCEMENT OF THE HOUSE

(CPA) Kuria Kimani) regarding the state of security in the country including steps being taken by the Ministry to avert death and destruction of property during demonstrations and timelines within which the Government will apprehend the culprits responsible for financing and mobilization of demonstrations.
 - (ii) **Question No. 009 of 2025** by the Member for Embakasi West (Hon. Mark Mwenje) regarding the circumstances that led to the death of *Mr. Brian Luka Maina* of ID No. 33037236, who lost his life during the demonstrations of 25th June 2025 and measures put in place to ensure the family of the victim is compensated.
 - (iii) **Question No. 010 of 2025** by the Member for Githunguri (Hon. Gathoni Wamuchomba) regarding report on the total number of female bodies recovered from the *Kware* dumpsite in Embakasi, including an update on the number of victims positively identified through forensic or DNA analysis. The Question was dropped after the Member walked out during the response to the Question by the Cabinet Secretary contrary to the Honourable Speaker's directive.
 - (iv) **Question No. 012 of 2025** by the Member for Gilgil (Hon. Martha Wangari) regarding steps taken by the Ministry to investigate allegations of child sex trafficking in *Mai Mahiu*, Nakuru County following media exposé released on 4th August 2025.
 - (v) Question No. 064 of 2025 by the Member for Nairobi County (Hon. Esther Passaris) regarding the non-implementation of the use of body-worn cameras for police officers involved in arrests, interrogations and custodial transfer of suspects;
 - (vi) **Question No. 066 of 2025** by the Member for Seme (Hon. (Dr.) James Nyikal) regarding psychological and mental health assessments undertaken by the National Police Service Commission during the recruitment of police officers;

 - (iii) by deleting the words "in the ministry" appearing in paragraph (d) and substituting therefor the words "for the time being";
 - (iv) by inserting the following new paragraph immediately after paragraph (d)—

(da) the Principal Secretary for the time being responsible for agriculture or his or her representative;

- (v) by deleting the words "his representative" appearing in paragraph (e) and substituting therefor the words "a representative"; and
- (vi) in paragraph (g) by inserting the following new sub-paragraph immediately after sub-paragraph (v)—
 - (vi) drought risk management.

- (5) If any difficulty or question arises as to the amount, entitlement to compensation or person entitled to compensation payable under this Act, the
