#### 4. QUORUM AT COMMENCEMENT

There being no Quorum present to commence business, the Hon. Speaker ordered that the Quorum Bell be rung for ten minutes;

And Quorum having been attained within the ten minutes, business commenced.

#### 5. COMMUNICATION FROM THE CHAIR

The Speaker issued the following Communications from the Chair—

#### (a) 2025 Speaker's Roundtable with the Kenya Private Sector Alliance (KEPSA)

"Honourable Members, I warmly welcome you back to the House after your brief recess. As we resume our work, I trust that we will complete all pending priority matters before the close of this final segment of the Fourth Session.

It is worth noting that, under our Standing Orders, several Bills and other items of business will lapse at the end of this session. I therefore direct the Clerk to devise a procedural mechanism that will preserve any critical unfinished business, allowing it to resume seamlessly in the Fifth Session.

As you may be aware, the National Assembly and the Kenya Private Sector Alliance (KEPSA) have, since 2009, jointly convened annual dialogues under the Speaker's Round Table.

These sessions gather leaders from the House, key parliamentary committees, and prominent stakeholders across pivotal economic sectors—agriculture, services (including tourism, finance, and retail), manufacturing, and technology—for open, informal exchanges. The goal is to gain a clearer grasp of the obstacles confronting these industries and to pinpoint essential legislative and administrative actions to bolster their progress.

Over the past fourteen years, these engagements have proved indispensable, yielding policy and legislative reforms that have profoundly shaped our economy. From these collaborative forums have sprung vital legal changes that strengthen the business landscape, accelerate economic growth, and advance national development.

To this end, **Honourable Members**, the 2025 Speaker's Round Table engagement is scheduled to be held from 6<sup>th</sup> to 8<sup>th</sup> November, 2025, at the Pride Inn Hotel,

Mombasa County. The meeting will be held under the theme... "From Policy to Practice: Delivering a predictable and competitive investment climate".

As such, the primary focus of the 2025 Round Table engagement will be on the evaluation of taxation regimes, the enhancement of investment protection, export competitiveness, financial sector stability, and evidence-based legislation.

These discussion areas are aimed at fostering a competitive business environment, strengthening governance, and advancing socio-economic development.

The forum brings together the House Leadership, all Chairpersons and Vice Chairpersons of Committees, and the representatives of the business community under the umbrella of the Kenya Private Sector Alliance (KEPSA).

In this regard, **Honourable Members**, I wish to inform the House of the event and extend an invitation to the House Leadership, all Chairpersons and Vice Chairpersons of Committees, and selected Members of the Departmental Committees on Finance and National Planning, Health, Energy, Communication, Information and Innovation and Trade, Industry and Cooperatives, to the meeting. I thank you!"

### (b) <u>Recognition of a visiting delegation from the National Assembly of the Republic</u> of Namibia

**"Honourable Members,** I wish to introduce to you a delegation from the National Assembly of the Parliament of Namibia, seated in the Speaker's Row. The delegation comprises the following seven (7) Members of the Parliamentary Committee on Urban and Rural Development and Land Reform –

**Honourable Members,** the delegation, accompanied by two staff members, is on a benchmarking visit to the National Assembly of Kenya to learn, share experiences, and exchange best practices with our Departmental Committees, particularly on matters of urban and rural development and land reform. Their visit is aimed at strengthening their committee's oversight and legislative role in these critical sectors.

On behalf of the House and on my own behalf, I warmly welcome them to the Parliament of Kenya and wish them fruitful engagements and a pleasant stay in our country. *Karibuni sana!* I thank you!

# (c) Election of Hon. (Dr.) Beatrice Adagala as the Vice-Chairperson of the (CPA) Africa Region Exco and Senator Tabitha M. Mutinda as a Board Member of the Parliamentary Network on the World Bank and IMF

"Honourable Members, I wish to inform the House that I am in receipt of communication from the Commonwealth Parliamentary Association (CPA) Africa Region Secretariat conveying the election of Hon. (Dr.) Beatrice Adagala, Member for Vihiga County, as the Vice-Chairperson of the Executive Committee of the CPA Africa Region for a period of one year, covering the 2025/2026 term.

This is a significant milestone, not only for Hon. (Dr.) Adagala personally, but also for our Parliament, as it underscores the recognition and confidence placed in our institution within the wider Commonwealth parliamentary community.

Accordingly, this Communication serves to formally apprise the House of Hon. (Dr.) Adagala's elevation to this important and prestigious position.

Honourable Members, in the same breath, I wish to inform the House that Senator Tabitha Mutinda, Nominated Senator, has been elected to the Board of the Parliamentary Network on the World Bank and IMF for the period 2025–2027, representing East Africa. This international body promotes transparency, accountability, and inclusive development. Her election is an honour for Kenya and our region, showing growing confidence in our leadership. It also strengthens our engagement with global financial institutions and discussions on development, governance, and sustainable growth.

Honourable Members, on behalf of the House and on my own behalf, I wish to extend our warmest congratulations to Hon. (Dr.) Adagala and Senator Tabitha Mutinda on their well-deserved election. I further urge all Honourable Members to accord them support and cooperation as they undertake their duties and responsibilities in promoting parliamentary diplomacy and excellence. I thank you."

#### 6. PETITIONS

The Speaker reported the following Petition—

### Regularization of various public forest land claims

**"Honourable Members,** Article 119 of the Constitution accords any person the right to petition Parliament to consider any matters within its authority. Further, Standing Order 225(2) (b) requires the Speaker to report to the House any Petition other than those presented by a member.

Honourable Members, section 34 of the Forest Conservation and Management Act, 2016 (Cap. 385) provides for the revocation of the registration of a public forest through a petition to the National Assembly and outlines the specific steps to be followed in the consideration of such a petition.

Honourable Members, in this regard, I wish to report to the House that my office has received a Petition from the Cabinet Secretary for Environment, Climate Change and Forestry, Dr. Deborah Barasa concerning the regularization of various public forest land claims.

Honourable Members, in the Petition, the Cabinet Secretary notes that the Ministry of Environment, Climate Change and Forestry is mandated, *inter alia*, to formulate climate change and environmental policies, promote low-carbon technologies, restore and protect strategic water towers, control pollution, conserve wetlands, manage forest resources, and promote afforestation, re-afforestation, and agroforestry initiatives.

Honourable Members, the Ministry indicates that it has received several petitions from members of the public claiming settlement within various public forest lands across the country. In response to these claims, an Inter-Ministerial Committee was constituted to investigate and review the matters. Additionally, several petitions seeking the degazettement of public forests have been presented to this House and referred to the Public Petitions Committee.

Honourable Members, the Ministry reports that the findings of the Inter-Ministerial Committee revealed that the areas under claim are currently inhabited by persons engaged in non-forestry activities and who have resided in those areas for prolonged periods.

Honourable Members, the Ministry further informs the House that, following a review of the committee's report, the Kenya Forest Service Board, in writing, did recommend the regularization of these settlements through the variation of the respective forest boundaries, in accordance with section 34 of the Forest Conservation and Management Act (Cap 385).

Honourable Members, the Cabinet Secretary clarifies that, following the recommendations of the Kenya Forest Service Board, the Ministry of Environment, Climate Change and Forestry prepared and submitted a Joint Cabinet Memorandum on the determination of public forest land claims. The Memorandum was duly considered and approved by the Cabinet, thereby authorizing the variation of the affected forest boundaries to regularize the said settlements, and forwarded it for consideration and approval by the National Assembly.

Honourable Members, consequently, this Petition is presented to the House pursuant to Articles 37, 62, and 119 of the Constitution, as well as Section 34 of the Forest Conservation and Management Act (Cap. 385), which empowers any person to petition Parliament to recommend the variation or revocation of the registration of a public forest.

Honourable Members, the Cabinet Secretary, avers that the Ministry intends to execute the de-gazettement in phases, prioritizing the following forest areas—

- (a) South Nandi Forest (Chepkumia Block); Declared via Proclamation No. 76 of 1936 and Legal Notice No. 174 of 1964 having a total area of approximately 17,960.50 Hectares. The Petitioner avers that farmers from the hilly terrain of Chepkumia exchanged their land with forest land. The proposed area for degazettement measures approximately 989.17 Hectares and is now fully settled.
- (b) Turbo Forest (Manzini Block); Declared via *Legal Notice No. 145 of 14th June 1968* having a total area of approximately 7,404 Hectares. The Petitioner avers that this was intended for settlement of landless squatters in 1995 within the *Manzini Forest Block, Uasin Gishu County*. The proposed area for degazettement is approximately 1,241.50 Hectares and is now fully settled.
- (c) Mt. Elgon Forest (Chepyuk Settlement Scheme); Declared via *Proclamation No.* 44 of 1932 and Legal Notice No. 174 of 1964 having a total area of approximately 91,997.16 Hectares. The Petitioner avers that the Chepyuk Settlement Scheme was established in 1974 to resettle the Elgony Dorobo community previously residing within the moorlands of the Mt. Elgon Forest Reserve. Phase I of approximately 3,568 Hectares was excised via Legal Notice No. 51 of 1974, while in 2016, the Cabinet approved de-gazettement of 4,647 Hectares at Phases II and III, which are now fully settled.
- (d) Shiru/Shaviringa (Kakamega Forest); Declared via *Proclamation No. 14 of 1933 and Legal Notice No. 174 of 1964* having a total area of approximately 23,777.30 Hectares. The Petitioner avers that the *Shiru/Shaviringa Settlement Scheme* was established in 1988 as compensation for land acquired for public facilities including Vihiga District Headquarters, Mbale Hospital and Okoli Secondary School. It is proposed for de-gazettement of 94.99 and 36 Hectares for *Shiru* and *Shaviringa* Areas respectively, and both are fully settled.

Honourable Members, the Ministry concludes by praying that the National Assembly -

- (a) Urgently approves the variation of the boundaries of the following public forests to regularize the existing settlements:
  - (i) South Nandi at Chepkumia Area, approximately 989.17 Hectares;
  - (ii) Turbo at Manzini Area, approximately 1,241.50 Hectares;
  - (iii) Mt. Elgon at Chepyuk Area, approximately 4,647 Hectares; and,
  - (iv) Kakamega Forest at Shiru and Shaviringa Areas, approximately 94.99 and 36 Hectares, respectively.
- (b) Considers the Petitions and issues appropriate resolutions in accordance with Article 119 of the Constitution and Section 34 of the Forest Conservation and Management Act (Cap. 385).

Honourable Members, having confirmed that the issues raised in this Petition fall squarely within the jurisdiction of this House, and that they are not sub judice before any court or other constitutional body, I hereby commit the Petition—seeking the degazettement of specified public forest lands in Turbo Forest (Manzini Area), Mount Elgon Forest (Chepkyuk Area), and Kakamega Forest (Shiru/Shaviringa Areas)—to the Departmental Committee on Environment, Forestry and Mining for consideration and a report to the House, in accordance with the Petitions to Parliament (Procedure) Act (Cap. 7E).

Since the Petition concerning the **South Nandi Forest at** *Chepkumia* **Area** is *already* under consideration by the Public Petitions Committee, I direct the Committee to prioritize and conclude the deliberations on the matter.

I now, therefore, direct both the Departmental Committee on Environment, Forestry and Mining, and the Public Petitions Committee to expeditiously consider the Petitions and report their findings to the House for consideration in accordance with section 34 of the Forest Conservation and Management Act, 2016 (Cap. 385) and Standing Orders 227(2). I thank you."
