1. The Senate assembled at thirty minutes past Nine O'clock.
2. The proceedings were opened with Prayer said by the Speaker.

3. **QUORUM OF THE SENATE**

The Speaker, having counted the Honourable Senators present at the commencement of the Sitting and confirming that there was no Quorum, directed that the Bell be rung for ten minutes, pursuant to Standing Order 40;

And there being no Quorum at the expiry of the ten minutes, the Speaker directed that the Bell be rung for a further ten minutes;

And there being a Quorum before the expiry of the further ten minutes;

The Speaker invited the Clerk to call the Orders of the Day.

4. **QUESTIONS AND STATEMENTS**

QUESTIONS

- i) Question No. 075 by the Senator for Kisumu County (Sen. (Prof.) Tom Ojienda, SC, MP) to the Cabinet Secretary for Agriculture and Livestock Development on the status of pyrethrum farming in Homa Bay County and the wider Lake Region Economic Block was answered by the Cabinet Secretary.
- ii) Question No. 105 by the Senator for Makueni County (Sen. Daniel Maanzo, MP) to the Cabinet Secretary for Energy and Petroleum on the status of rural electrification projects initiated by the National Government in Makueni County in the 2022/2023, 2023/2024 and 2024/2025 financial years was answered by the Cabinet Secretary.
- iii) Question No. 123 by the Senator for Tharaka Nithi County (Sen. Mwenda Gataya, MP) to the Cabinet Secretary for Energy and Petroleum on the frequent power outages affecting Tharaka University in Tharaka-Nithi County and its environs was answered by the Cabinet Secretary.

- iv) Question No. 043 by the Senator for Nairobi City County (Sen. Edwin Sifuna, MP) to the Cabinet Secretary for Lands, Public Works, Housing and Urban Development on the status of ownership of certain parcels of land in Nairobi City County was answered by the Cabinet Secretary.
- v) Question No. 099 by the Senator for Nairobi City County (Sen. Edwin Sifuna, MP) to the Cabinet Secretary for Lands, Public Works, Housing and Urban Development on the encroachment upon the land in South “C” in Nairobi belonging to the College of Insurance was answered by the Cabinet Secretary.
- vi) Question No. 118 by the Senator for Murang’a County (Sen. Joe Nyutu, MP) to the Cabinet Secretary for Lands, Public Works, Housing and Urban Development on the status of ownership of *Kimorori* Grounds in Kenol, Maragua Constituency in Murang’a County was answered by the Cabinet Secretary.
