INVITATION TO SUBMIT MEMORANDA

WHEREAS, Article 118(1)(b) of the Constitution requires Parliament to facilitate public participation and involvement in the legislative and other business of Parliament and its Committees;

AND WHEREAS, pursuant to section 25(2) and section 33(1) of the Public Finance Management Act, 2012, the Cabinet Secretary for the National Treasury and Economic Planning submitted the **2026 Budget Policy Statement** and the **Medium-Term Debt Management Strategy for FY 2026/27 – FY 2028/29** to the National Assembly on **Wednesday, 11th February 2026** which were referred to the relevant Committees for consideration and reporting to the House;

IT IS NOTIFIED that—

(1) The **2026 Budget Policy Statement** articulates the broad strategic priorities and policy goals that will guide the national government and county governments in preparing their budgets for the 2026/27 Financial Year and over the medium-term; and
(2) The **Medium-Term Debt Management Strategy for FY 2026/27 – FY 2028/29** provides the borrowing strategy for the 2026/27 Financial Year and the medium term and underscores the public debt management objectives that will minimize the costs and risks of the public debt portfolio.

NOW THEREFORE, in compliance with Article 118(1) (b) of the Constitution, the Clerk of the National Assembly hereby invites the public and stakeholders to submit memoranda on the **2026 Budget Policy Statement** and the **Medium-Term Debt Management Strategy for FY 2026/27 – FY 2028/29** to the respective Committee listed below—
