1. The House assembled at Thirty Minutes past Two O'clock.
2. The Proceedings were opened with Prayer.
3. **Presiding** – the Sixth Chairperson of Committees.

4. **QUORUM AT COMMENCEMENT OF THE HOUSE**

There being no quorum present at the commencement of the House, the Sixth Chairperson ordered the Quorum Bell to be rung for ten minutes;

Quorum having not been attained at the expiry of ten minutes; the Sixth Chairperson ordered the Quorum Bell to be rung for a further ten minutes;

And Quorum having been attained within the additional ten minutes, business commenced.

5. **COMMUNICATION FROM THE CHAIR**

The Honourable Speaker issued the following Communications –

I. **Recognition of a Visiting Delegation from the House of Commons, Parliament of the United Kingdom**

Honourable Members, I wish to introduce to you a delegation from the House of Commons, Parliament of the United Kingdom. The delegation comprises the following two (2) Members who serve in the United Kingdom All-Party Parliamentary Group (APPG) on Disability, who are seated in the Speaker's row –

- (i) **The Hon. Marsha de Cordova, M.P. – Chairperson and Leader of the Delegation; and**
- (ii) **The Hon. Shokat Adam, M.P.**

Honourable Members, the delegation, which is accompanied by one member of staff, is in the country to exchange best practices and share experiences with the Departmental Committee on Social Protection on the development of inclusive policies across all areas of life.

Honourable Members, on my own behalf and that of the National Assembly, I welcome them to Parliament and wish them fruitful engagements during their stay in the country.

II. Purported Changes to House Leadership

“Honourable Members, I wish to convey to the House that my office is in receipt of a letter dated 9th March, 2026 **purportedly from the Azimio La Umoja-One Kenya Coalition Party.** On the face of it, the letter is purportedly signed by the **Hon. Kalonzo Musyoka, SC, EGH as the “Leader of the Party”** and seeks to appoint the Member for Suba South, the Hon. Caroli Omondi to the position of *“Leader of Coalition Party Parliamentary Group”*.

A cursory view of the document casts serious doubt as to its authenticity. **First,** it does not bear the original signature of its purported author and is littered with several grammatical and typographical errors, **including the duplication of one of the names of its purported author.** Specifically, the document is signed by *“H. E. Kalonzo Kalonzo Musyoka”*.

Secondly, and most importantly, the letter lacks any forwarding address to which any exchange of correspondence, including seeking of a clarification or making a response, may be directed.

In this regard, as your Speaker, **I highly doubt that the letter originated from an office of the stature of our retired Vice-President** which is an office established in law and fully funded and capacitated under the auspices of the Retirement Benefits (Deputy President and Designated State Officers) Act, Cap. 197B.

Honourable Members,

There being no address to which a clarification may be sought or a reply directed, and noting that information of purported changes to the leadership of the Minority has been circulated in the public domain, I wish to clarify for the benefit of the House and the public record **THAT—**

- (1) The position of “Leader of Coalition Party Parliamentary Group” does not exist in the Constitution, Statute Law or our Standing Orders. This therefore means that the letter has purportedly appointed the Member for Suba South to a position which is not recognized in law.
- (2) The Speaker and the House are unable to process any claim or request contained in the letter as the same is made outside the provisions of the Constitution and the Standing Orders.

The House is accordingly guided. I thank you!”

III. The Demise of the Member for Ol Kalou Constituency, The Late Hon. David Njuguna Kiaraho, MP and Former Senator for Kirinyaga County, The Late Hon. Daniel Karaba

“Honourable Members, As I welcome you back from the short recess, you may recall that on Sunday, 29th March 2026, I notified you and the general public of the untimely demise of the Member for Ol Kalou Constituency, the late **Hon. David Njuguna Kiaraho, MP,** who passed away earlier that morning while receiving treatment at the Nairobi Hospital. The demise of the Hon. Kiaraho brought loss of a dedicated legislator, a distinguished

professional, and a committed servant of the people of Nyandarua County and the nation at large.

The late Hon. Kiaraho was born on 2nd October 1963 in Ol Kalou, Nyandarua County. He began his education at Munyeki Primary School before proceeding to the Alliance High School for his 'O' Level studies. In 1982, he joined Nairobi School for his 'A' Levels, where he continued to excel academically. In 1985, he was admitted to the University of Nairobi for a Bachelor's Degree in Architecture, after which he established a distinguished career in the field. The late Member served as Principal Architect at Archgrid Systems, in which role he built a strong professional foundation in infrastructure development and the built environment, contributing to numerous projects that shaped both public and private sector spaces.

Honourable Members, the late Hon. David Kiaraho joined elective politics in 2013 when he was elected as the Member for Ol Kalou Constituency. He was subsequently re-elected during the 2017 and 2022 General Elections. Throughout his three-term tenure, he served with dedication as a member of the Departmental Committee on Transport & Infrastructure and the Procedure & House Rules Committee.

As a member of the Departmental Committee on Transport & Infrastructure, he played a pivotal role in the processing of legislation aimed at safeguarding road reserves, as well as in the development of frameworks to facilitate the establishment of pedestrian walkways and infrastructure for non-motorised transport.

Honourable Members, over his years of service in Parliament, the late Hon. Kiaraho has maintained a close connection with the people of Ol Kalou, serving them with dedication and passion. He was a steadfast advocate for the advancement of education, demonstrated

by, among other things, the provision of school buses to various institutions and ensuring proper oversight and timely disbursement of bursaries to deserving students in Ol Kalou constituency.

The Hon. Kiaraho demonstrated a strong commitment to community welfare through active engagement in key development initiatives, including the promotion of universal healthcare, enhancement of agricultural productivity, support for affordable housing, upgrading of roads, expansion of electricity and water connectivity, and spearheading infrastructural developments at the J.M. Kariuki Referral Hospital and Nyandarua University College.

In his demise, the institution of Parliament, the people of Ol Kalou, and indeed the whole nation has lost a devoted legislator, a servant of the people, and a committed advocate for justice.

Honourable Members, in order to accord a befitting send-off to our departed colleague and in line with the PSC Bereavement Policy, I have appointed an *Ad Hoc* Parliamentary Funeral Planning Committee to coordinate the funeral arrangements. The Committee will comprise the following Members of Parliament—

In addition, a family representative will be co-opted onto the committee.

Honourable Members, to celebrate the life and legacy of the late Hon. Kiaraho, a **Requiem** Service will be held on Wednesday, 8th April 2026 at Ol Kalou Stadium, Nyandarua County. The funeral service will thereafter take place at PCEA St. Andrew's Church, Nairobi, followed by interment at his family farm in Tigoni, Kiambu County, on Friday, 10th April 2026.

Honourable Members, I also wish to report the demise of **the late former senator for Kirinyaga County, Sen. Daniel Karaba**, who passed away on 23rd March 2026. The Hon Karaba was born on 22nd June 1948 in Kirinyaga County. He had a distinguished career in the teaching profession, serving as a principal in several institutions, and as the Chairperson of the Kenya Secondary Schools Heads Association (KSSHA), from 1984 to 1998.

In 2002, the late Sen. Karaba ventured into elective politics and got elected into the 9th Parliament as the Member for the then Kerugoya/Kutus Constituency, currently Kirinyaga Central Constituency. He served as the Chairperson of the Departmental Committee on

Education, Research, and Technology, and spearheaded the development of education policies, including the Early Childhood Development Education (ECDE) Policy.

In 2013, the late Hon. Karaba successfully vied for and was elected as the first Senator for Kirinyaga County in the 11th Parliament, a position in which he served until 2017, during which time he served as the Chairperson of the Senate Standing Committee on Education. The late Sen. Karaba retired from active politics in 2022 but remained a respected elder and source of counsel to many within his community and beyond. The late Sen. Karaba will be laid to rest tomorrow, Wednesday, 1st April 2026, at his home in Kirinyaga County.

Honourable Members, on another sad note, I wish to inform the House that I have received news of the passing on of **Mama Dorothy Baya Mweri**, the beloved mother of the Deputy Leader of the Majority and Member for Kilifi North, the Hon. Owen Baya, CBS, MP, on the evening of 30th March 2026. Her departure is a profound loss not only to her family but also to all who were touched by her grace, wisdom, and unwavering commitment to community.

In this moment of sorrow, we stand in solidarity with the Deputy Leader and their family, offering our support and prayers as they navigate this difficult time. May her memory be a lasting blessing, and may the family find strength, comfort, and peace in the legacy of love and dignity she leaves behind.

Hon. Members, on behalf of the House, the Parliamentary Service Commission, and indeed on my own behalf, I convey our heartfelt condolences to the families, relatives, and friends of our colleagues and Mama Dorothy Baya.

In honour of our departed colleagues and beloved mother of our colleague, the **Hon. David Njuguna Kiaraho, MP, Sen. Daniel Karaba**, and Mama Dorothy Baya, I request that we all stand and observe a moment of silence. **May their souls rest in eternal peace. I thank you!"**

6. NAMING OF A MEMBER

Rising in her place on a point of order pursuant to the provisions of Standing Order 108, the Member for Laikipia North (Hon. Sarah Korere) invited the Speaker to name the Member for Kitutu Chache South (Hon. Antony Kibagendi) for grossly disorderly conduct;

And the Speaker acceding to the request;

Motion made and Question proposed –

“**THAT**, Hon. Antony Kibagendi be suspended from the service of the House,”

Thereupon question put and agreed to;

Accordingly, the Hon. Member was escorted out of the House by the Serjeant-at-Arms.

7. RE-ORGANISATION OF BUSINESS

Pursuant to Standing Order 40(3), the Honourable Speaker reordered the sequence of proceedings as follows—

Consideration of **Order No. 3** (*Messages*); **Order No. 8** (*Consideration of Sessional Paper No. 3 Of 2025 on Partial Divestiture in Safaricom Plc by the Government of Kenya*); and consideration of **Order No. 7** (*Questions and Statements*) to be undertaken before reverting to Communications from the Chair.

8. MESSAGES

The Sixth Chairperson reported the following Message to the House –

The Consideration of Four (4) Bills

“**Honourable Members**, Pursuant to the provisions of Standing Order 41(4), I wish to report to the House that I have received four (4) Messages from the Senate regarding its consideration of three (3) Senate Bills and one (1) National Assembly Bill.

Honourable Members, the Messages convey that on 3rd March 2026, the Senate considered and passed three (3) Senate Bills, **with amendments**.

The First Message is on the **County Governments Election Laws (Amendment) Bill (Senate Bill No. 2 of 2024)**, which seeks to amend the Elections Act, Cap. 7 and the County Governments Act, Cap. 265, to provide for nomination of Members of a County Assembly to represent marginalised groups.

The Second Message is on the **Tobacco Control (Amendment) Bill (Senate Bill No. 35 of 2024)**, which seeks to amend the Tobacco Control Act, Cap. 245A to regulate electronic nicotine delivery systems, including electronic cigarettes and related products.

The Third Message is on the **Labour Migration and Management (No. 2) Bill (Senate Bill No. 42 of 2024)**, which seeks to provide for the regulation of private employment agencies and the recruitment of workers within and outside Kenya, including safeguarding the rights and welfare of job seekers and migrant workers.

Honourable Members, having passed the said Bills, the Senate now seeks the concurrence of the National Assembly, pursuant to the provisions of Article 110(4) of the Constitution.

Honourable Members, you will note that the Standing Orders require the Speaker to cause a Bill received from the Senate to be read a First time upon conveyance of its Message to the House. In view of this, I direct the Clerk to schedule the three (3) Senate Bills.

Thereafter, the Bills will stand committed to the following Committees for consideration—

1. The County Governments Election Laws (Amendment) Bill (Senate Bill No. 2 of 2024) to the **Departmental Committee on Justice and Legal Affairs;**
2. The Tobacco Control (Amendment) Bill (Senate Bill No. 35 of 2024) to the **Departmental Committee on Health;** and
3. The Labour Migration and Management (No. 2) Bill (Senate Bill No. 42 of 2024) to the **Departmental Committee on Labour.**

Honourable Members, the Message with respect to the Tobacco Control (Amendment) Bill (Senate Bill No. 35 of 2024) further conveys the nomination of Honourable Members of this House to co-sponsor the Bill in the National Assembly.

The Message conveys that the sponsor of the Bill, Sen. Catherine Mumma, MP, has designated the Hon. Millie Odhiambo-Mabona, CBS, MP, Member for Suba North Constituency and the Hon. Samuel Atandi, CBS, MP, Member for Alego Usonga Constituency as the co-sponsors of the Bill in the National Assembly. In this regard, the two Members will marshal the consideration of the said Bill in the National Assembly.

Honourable Members, the **Fourth Message** conveys that on 3rd March 2026, the Senate considered and passed the Public Finance Management (Amendment) (No. 4) Bill (National Assembly Bill No. 45 of 2024), **with amendments.** The Message further conveys that in passing the said Bill, the Senate incorporated the provisions of the Public Finance Management (Amendment) (No. 2) Bill (National Assembly Bill No. 26 of 2024), and the Public Finance Management (Amendment) (No. 3) Bill (National Assembly Bill No. 44 of 2024).

Honourable Members, you may recall that this House passed the Public Finance Management (Amendment) (No. 3) Bill, 2024, and the Public Finance Management (Amendment) (No. 4) Bill, 2024 on 28th November, 2024 and the Public Finance Management (Amendment) (No. 2) Bill, 2024 on 14th March 2025, respectively.

Thereafter, I referred the three (3) Bills to the Senate for consideration pursuant to the provisions of Article 110(4) of the Constitution. The Senate has now referred the said Bills back for reconsideration pursuant to Article 112(1)(b) of the Constitution. The National Assembly is therefore required to consider the Senate amendments to the Public Finance Management (Amendment) (No. 4) Bill (National Assembly Bill No. 45 of 2024), as consolidated with two other related Bills.

Honourable Members, the decision by the Senate to consolidate the three Bills was informed by an observation that the Bills deal with related matters. In this regard, the

Leadership of both Houses agreed to consolidate the three (3) Bills for purposes of legislative efficiency.

Honourable Members, I therefore refer the Schedule of Senate amendments to the Public Finance Management (Amendment) (No. 4) Bill (National Assembly Bill No. 45 of 2024) to the **Departmental Committee on Finance and National Planning** for consideration.

Honourable Members, to facilitate the consideration of the Senate amendments to the said Bill, the Clerk is directed to circulate the *Schedule of Amendments* to all Members and the relevant Committees as required by the Standing Orders.

The Committees to which the four (4) Bills have been referred are encouraged to prioritise their consideration and submit reports as soon as is practicable to enable the House to proceed with the next steps.

9. MOTION - CONSIDERATION OF SESSIONAL PAPER NO. 3 OF 2025 ON PARTIAL DIVESTITURE IN SAFARICOM PLC BY THE GOVERNMENT OF KENYA

Motion made and Question proposed –

THAT, this House **adopts** the Joint Report of the Departmental Committee on Finance and National Planning and the Public Debt and Privatization Committee on the consideration of Sessional Paper No. 3 of 2025 on Partial Divestiture in Safaricom PLC by the Government of Kenya, *laid on the Table of the House on Tuesday, 10th March 2026* and—

(a) **resolves that**, pursuant to the provisions of section 87(A) of the Public Finance Management Act, Cap. 412A, the House **approves** the Sessional Paper No. 3 of 2025 on Partial Divestiture of Safaricom PLC by the Government of Kenya; and

(b) **further resolves** as follows –

Effective date

(i) **That**, the effective date for the approval shall be 1st April 2026 or such later date when all regulatory approvals that form condition precedent in paragraph 4.1 of the Share Purchase Agreement shall have been obtained;

Completion upon obtaining all regulatory approvals

(ii) **That**, the Cabinet Secretary for the National Treasury shall upon obtaining all regulatory approvals in line with condition precedent in paragraph 4.1 of the Share Purchase Agreement undertake and complete the transaction through the *Block Trade Platform of the Nairobi Securities Exchange*;

Upfront payment to be made in lieu of future dividends

(iii) **That**, the Government of Kenya shall receive Kenya shillings Forty billion and two hundred million (Ksh. 40.2B) as upfront payment in *lieu* of future dividends on the residual twenty (20) percent shareholding as per the Dividend Purchase Agreement;

Proceeds to be paid into the National Infrastructure Fund

(iv) **That**, notwithstanding anything contained in the Share Purchase Agreement and the Dividend Purchase Agreement, the proceeds of the divestiture shall be paid into the National Infrastructure Fund;

No redundancy of existing staff

(v) **That**, to safeguard against loss of jobs for existing staff, there shall be no acquisition-related redundancies in Safaricom PLC; and

Preservation of the existing business model with Safaricom PLC dealers, agents and other business partners

- (vi) **That**, the Cabinet Treasury for the National Treasury shall ensure that, within ten (10) years of the divestiture, there shall be no material change to the current shared prosperity business model in Safaricom PLC that will prejudice the existing Safaricom PLC dealers, agents and other business partners.
